

Dear Colleague:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to San Francisco, California, scheduled for August 10, 2017, sponsored by Main Street Advocacy and Pacific Gas and Electric Company.
