Reason for Invitation:

Congressman Davis has been instrumental in our efforts in gaining a Memorandum of Understanding (MOU) between Biojam Industrial Research & Development Global, Inc. and the Government of Jamaica (GOJ) and led our initial trade delegation to Jamaica during March 9th. through 12th. 2015. He led a Codel to witness the public signing ceremony July 6th, 2017 for our small Minority Business Enterprise (MBE) to develop an inclusive innovation effort for underserved communities in the Western Hemisphere. The United Nations (UN) World Intellectual Property Organization has kept track of our activities and invited our delegation of MBEs, University representatives, Illinois State Representatives and local non-profits along with the Chicago Minority Business Development Agency Trade Center to their headquarters in Geneva, Switzerland to be part of a fact finding mission to unearth how inclusive innovation can be a tool to use for stemming crime and poverty accompanied by Congressman Davis and includes meetings with former UN Secretary General Kofi Annan (with the Annan Foundation), World Health Organization and others. Our objective is to discuss inclusive innovation and unearth workable mechanisms that are being created to help mitigate crime and poverty in underserved communities throughout the Western Hemisphere.

Background:

During July 5th through 7th of 2017, Congressman K. Davis was invited by Biojam Industrial Research & Development Global Incorporated; a Chicago based small minority business comprised of Board Members representing SIX minority small businesses and non-profits, primarily because of his experience and knowledge of successful revitalization and community building in areas within his district to witness the first signing between a US Minority Business Enterprise (MBE) and a foreign nation to develop an inclusive innovation mechanism for the Caribbean Basin to mitigate lack of diversity in innovation, and crime stemming from non-inclusivity of underserved community members in Science, Technology, Energy & Mathematics initiatives. The conditions in his area of representation, the Seventh (7th) Congressional District of Illinois, are much like those in Jamaica where there exists high crime rates, unemployment and poverty within underserved neighborhoods while being surrounded by untapped economic opportunity. His base town of Chicago boasts:

- Total minority-owned firms: 95,685
- Annual sales of minority-owned firms: \$21.4 billion
- Total African American-owned firms: 35,569
- Annual sales of African American-owned firms: \$3.4 billion

Additionally, Chicago Metro Area / Illinois is home to fourteen (14) of the largest US Fortune 500

Companies, five (5) of which are:

- Archer Daniels Midland (ADM); Decatur, IL., \$69.2 billion
- Abbott Laboratories, Chicago IL., Chicago, IL., \$30.0 billion
- Boeing; Chicago, IL., \$68.3 billion
- Ford Motor Company, Chicago, IL., \$151.0 billion (Assembly Plant in Chicago)
- Sears Roebuck & Co. Hoffman Estates, IL., \$44.0 billion.

Over the last three years we have been engaged with the Department of Commerce and its Minority Business Development Agency (MBDA) both at the federal and local level. MBDA is an entrepreneurially focused and innovative organization committed to wealth creation in minority communities and the only federal agency dedicated to establishing and growing minority owned businesses in America. The Chicago MBDA Center has assisted over 1200 MBEs in obtaining \$2.5 billion in contracts, \$800 million in financing and helped to create over 5,000 jobs. During 2013, the center assisted MBEs with over \$360 Million in procurement and capital for MBEs which helped generate and retain over 5,000 jobs.

The UN World Intellectual Property Organization recognized this effort and proposed this delegation work with them on solutions for Global Inclusive Innovation led by US entrepreneurs, Non-Profits, Universities and Minority Business Enterprises (MBEs) with the aid of their representatives.

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Switzerland, scheduled for April 2 to 6, 2018, sponsored by Biojam Industrial Research & Development Global, Inc.


You must complete a Member/Officer Post-Travel Disclosure Form and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. You must also report all travel expenses totaling more than \$390 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House Members may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$390] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments filed with the Committee, and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.
