Dear Colleague:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your and your spouse's proposed trip to Denmark,¹ scheduled for August 3 to 9, 2019, sponsored by the Ripon Society and the Franklin Center for Global Policy Exchange. We note that this trip includes two days at your personal expense.

You must complete a Member/Officer Post-Travel Disclosure Form and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. You must also report all travel expenses totaling more than \$390 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House Members may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$390] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

¹ Please be aware that the Committee's review of the proposed trip does not extend to either the security situation in the destination country or security related to foreign travel in general. We recommend you contact the Sergeant at Arms (SAA) for a safety and security briefing prior to your departure. SAA may be reached at (202) 226-2044 or ohsstaff@mail.house.gov. House travelers should also register for the U.S. State Department's Smart Traveler Enrollment Program at <https://step.state.gov>.

TransAtlantic Capital to Capital Exchange Copenhagen, Denmark – August 5-9, 2019 **Reasons for Copenhagen**

Denmark and the United States have had uninterrupted diplomatic relations since first establishing ties in 1801. Since its liberation in 1945, Denmark has been one of the United States' closest allies economically and militarily, with the U.S. being Denmark's largest non-European trade partner. Along with the U.S., Denmark is a founding-member of the United Nations and the North Atlantic Treaty Organization, and they have most recently been a reliable supporter of U.S. foreign policy in Iraq and Afghanistan.

International Security: As close NATO allies, the U.S. and Denmark consult on European and regional political matters as well as security threats, cooperating extensively to promote peace and stability well beyond Europe's borders. President Trump met with Prime Minister Lars Løkke Rasmussen in March 2017, to further strengthen U.S.-Danish relations and encourage Denmark to reach the NATO 2% GDP commitment to defense spending.

Terrorism: Denmark is an active coalition partner in the War on Terror, and was one of the first countries to join the counter-ISIS coalition, offering F-16 fighter jets, military trainers, special operations forces, and humanitarian assistance. The U.S. Air Force presence at Thule Air Base in northwest Greenland, a part of Denmark, provides significant strategic value for the U.S. and NATO allies and plays a critical role in our early-warning radar system.

Shared International Membership: Denmark belongs to the United Nations, NATO, Euro-Atlantic Partnership Council, Organization for Security and Cooperation in Europe, and OECD. The United States and Denmark are both heavily invested in international cooperation to address pressing issues around the world, and it is essential that close working ties be maintained.

Economic Relationship: Denmark is a social welfare state, with a modern, services-based economy. It is highly dependent on foreign trade and a strong supporter of liberal trade policy. Denmark's strategic location at the entrance of the Baltic Sea has made Copenhagen a critical location for U.S. agencies and businesses dealing in the Nordic and Baltic region. The U.S. is Denmark's largest non-European trading partner, with trade of goods and services between the two countries totaling over \$17 billion annually.

Healthcare: Healthcare in Denmark is largely financed through local taxation, with integrated funding and provision of health care at the regional level. The national tax for healthcare is set at around 8% of the total taxable income. In a time where our own healthcare system is faltering to serve the public's needs, it is imperative that legislators study the successes and failings of other national systems to find a solution that fits the United States' needs.

Refugee/Subsidiary Stance: Over the course of the 20th century, Denmark became home to refugees and immigrants from the Soviet bloc, the Balkans, the Middle East, and beyond. However, the recent rise in refugee applications due to the Syrian Civil War is putting a strain on Denmark's social welfare state, leading to more restrictive immigration policies. Seeing the refugee crisis first-hand in Europe will be especially useful for U.S. lawmakers as they craft policies to address the problem within our own borders.
