

Rep. Jacobs participates in (and Kuhn attends) “Governing a Divided Country—By Leaving Washington” session in Salon A, Hilton Austin Downtown.

Bipartisan relationships of trust are key to collaboration and a functioning legislative process. Yet, opportunities for building these bonds have all but evaporated in Washington. Many lawmakers are actually good people responding to bad incentives in a highly polarized environment. We must create authentic opportunities for them to connect despite the rawness and divisions. Getting members of Congress from opposite parties outside the beltway to visit each other's districts and literally see where each other is coming from is essential to restoring consensus-based problem solving.

Rep. Meijer will join Rep. Jacobs (D-CA-53) as they discuss why it is critical to a functional legislative process to have and build bipartisan conversations and relationships through the concept of, essentially, domestic CODELs (similar to a recommendation made by the House Select Committee on the Modernization of Congress). Moderated by Bipartisan Policy Center Founder & President Jason Grumet.

- 5:15-5:30 p.m. Meet & greet with audience.
- 5:30-5:45 p.m. Walk to “EU @ SXSW”, Native on 4th Street.
- 5:45-6:30 p.m. The European Union is brimming with culture, creativity, diversity, climate, trade, technology, and innovation. Rep. Jacobs serves on the House Foreign Affairs Committee, where her position on the International Development, International Organizations and Global Corporate Social Compact Subcommittee (and her chief of staff’s role) relates to this visit. At “EU @ SXSW,” Rep. Jacobs and Ms. Kuhn spoke with Maria Belovas, Head of Press & Public Diplomacy for the EU Delegation to the U.S., about the ongoing conflict in Ukraine and how it has affected the European Union; the location was decorated in blue and yellow, with the theme of #StandWithUkraine.
- 6:30-6:45 p.m. Rep. Jacobs, Ms. Kuhn, and BPC staff take ride share to BPC reception with Reps. Peter Meijer and Nancy Mace
- 6:45-8:00 p.m. Rep. Jacobs and Ms. Kuhn attend a BPC reception focusing on the promise and shortcomings of bipartisanship. Reps. Jacobs, Meijer, and Mace give remarks and speak with attendees about bipartisanship and highlight the bills and projects they have partnered on during the 117th Congress.
- Reps. Jacobs and Meijer have worked together on the issue of War Powers and also co-led a letter to the Biden Administration urging implementation of the Global Fragility Act.
- Reps. Jacobs and Mace have introduced two pieces of legislation together – the *Ending Veteran Homelessness Act* and the *HUD-VASH Improvement Act* – both focusing on supporting veterans across the country and in each of their respective districts.
- 8:00-8:45 p.m. Rep. Jacobs and Ms. Kuhn meet with former Austin City Councilman Greg Casar to discuss commonalities between the major U.S. cities of Austin and San Diego. Issues discussed include rising costs of living, the growth and revitalization of the city centers, and the impact of federal COVID relief dollars.
- 8:45-9:00 p.m. Rep. Jacobs, Ms. Kuhn, and Mr. Casar meet with Trey Spaw, co-owner and operator of the Empire Control Room, to discussed what the return of SXSW means to the local Austin economy and to local small business owners, and the hardships small businesses have endured during the COVID-19 pandemic.
- The Shuttered Venue Operators Grant (SVOG) – a program run through the U.S. Small Business Administration – was established by the Economic Aid to Hard-Hit Small Businesses, Nonprofits, and Venues Act, and amended by the American Rescue Plan Act, which Rep. Jacobs helped pass in March 2021. In the lead-up to the passage of the

American Rescue Plan, Rep. Jacobs and her team heard from many local venues in San Diego that had not been able to receive Paycheck Protection Program funding and needed another source of support.

49 venues in Rep. Jacobs' district (CA-53) ended up receiving funding through the SVOG program (and more in San Diego as a whole). 108 venues in Austin received funding through the SVOG program, including SXSW, which received a \$8,000,000 grant.

Rep. Jacobs and Ms. Kuhn engage in a working breakfast with BPC staff to further discuss the promises and limitations of bipartisanship, and the reasons for polarization in Congress.

Rep. Jacobs discussed her roles on the House Foreign Affairs Committee and House Armed Services Committee, which are both historically bipartisan. She also discussed the areas she has worked with Republican Members of Congress to advance bipartisan legislation, including the *Ending Veteran Homelessness Act* and the *HUD-VASH Improvement Act* she co-led with Rep. Nancy Mace and the *Military Child Care Expansion Act*, which she co-led with Reps. Jackie Speier (D-CA-15), Rep. Stephanie Bice (R-OK-5), and Sen. Tammy Duckworth (D-IL)

Rep. Jacobs and Kuhn visit Creative Industries Expo, Austin Convention Center.

The Creative Industries Expo highlights the integrations and overlaps between SXSW's converging industries, hosting a diverse range of forward-thinking exhibitors ranging from promising startups to established industry leaders. This stop relates to Rep. Jacobs' interest in the expansion of technology in creative industries, which are seeing explosive growth in San Diego, where she represents. Especially important to Rep. Jacobs will be the opportunity to learn about trends in Communication Arts, Architecture & Interior Design, Publishing & Printing, and Visual & Performing Arts – which are quickly advancing in her congressional district.

12:00-12:30 p.m.

Rep. Jacobs and Kuhn attend SXSW panel "What We're Getting Wrong About Homelessness"

The panel addressed homelessness "not an individual crisis, [but] a policy choice." The discussion, Hannah Lebovits and Lisa Marshall of Fighting Homeless – a public policy researcher and long-time homelessness advocate – discuss the legal, regulatory, and administrative systems that force thousands of people into homelessness each year. They discussed specific policies that make housing security impossible for countless

individuals and give audience members concrete tools to advocate for change.

This panel was relevant to Rep. Jacobs' work as one of the five Members of Congress representing San Diego County, which has the fourth highest homelessness population in the United States.

Congresswoman Sara Jacobs (CA-53) represents a Southern California district which includes the San Diego metro area, home to a significant military presence, higher education, aerospace, high-tech, and tourism

She serves on the House Foreign Affairs Committee, where her position on the International Development, International Organizations and Global Corporate Social Compact Subcommittee offers discussions and issues related to trade, economic alliances, and universal access to uninterrupted and affordable energy. International affairs will be a topic that Rep. Jacobs will engage in at SXSW.

She also serves on the House Select Committee on Economic Disparity and Fairness in Growth, which considers the yawning prosperity gap between wealthy Americans and everyone else. Great wealth disparities slow our economy, poison our politics, and are manifested in how people participate (or don't) in democratic elections. Some of the conference sessions Rep. Jacobs will attend, deal with this connection between economics and access to the ballot.

Rep. Jacobs will have the opportunity to meet with businesses in the Austin area that have a global reach and will be able to compare and contrast the challenges facing these firms with the issues that the businesses in CA-53 grapple with.

Amy Kuhn – Ms. Kuhn serves as chief of staff to Rep. Jacobs. As such, she has ultimate responsibility for the member's overall legislative strategy and agenda, and ensuring the member remains well-informed and updated on issues of importance to her and her district.

State legislatures across the country are passing new laws that make it harder to vote and easier for bad actors to overturn future election results they disagree with, while efforts to deceive voters about the security and integrity of our democracy undermine the foundations of our country. This panel discussion, led by two figures serving on the front lines defending democracy — Michigan Secretary of State Jocelyn Benson and Arizona Secretary of State Katie Hobbs — will summarize these and other growing threats and what all Americans can do to ensure democracy prevails. The panel will be moderated by Scott Nathan, voter protection lawyer and advisor to the Voter Protection Corps.

Rep. Jacob's interest and belief in election integrity and election reform, relates to the subject of this session.

Bipartisan relationships of trust are key to collaboration and a functioning legislative process. Yet, opportunities for building these bonds have all but evaporated in Washington. Many lawmakers are actually good people responding to bad incentives in a highly polarized environment. We must create authentic opportunities for them to connect despite the rawness and divisions. Getting members of Congress from opposite parties outside the beltway to visit each other's districts and literally see where each other is coming from is essential to restoring consensus-based problem solving.

Rep. Meijer will join Rep. Jacobs (D-CA-53) as they discuss why it is critical to a functional legislative process to have and build bipartisan conversations and relationships through the concept of, essentially, domestic CODELs (similar to a recommendation made by the House Select Committee on the Modernization of Congress). Item 12: *Bipartisan Policy Center*: The Bipartisan Policy Center is a non-profit organization that combines the best ideas from both parties to promote health, security, and opportunity for all Americans. BPC drives principled and politically viable policy solutions through the power of rigorous analysis and painstaking negotiation.

As a Washington, D.C.-based think tank that actively promotes bipartisanship, BPC works to address the key challenges facing the nation. Our policy solutions are the product of informed deliberations by former elected and appointed officials, business and labor leaders, and academics and advocates who represent both ends of the political spectrum. We are currently focused on such issues as health, energy, national security, the economy, financial regulatory reform, housing, immigration, infrastructure, and governance.

While a healthy, civil debate among those with differing viewpoints is an essential component of our democracy, the current partisan tone in government is impeding progress. BPC is focused on how to overcome political divides and help make our government work better.

Regardless of deep policy disagreements, Congress must operate with mutual respect, decency, and civility which are foundational to forging collaborative solutions. While there are disparities and regional differences, as elected officials, members of Congress all have a responsibility to address challenges confronting their constituents and the nation, as well as strengthen the institution itself.

The American Congressional Exchange (ACE) Program, which is a focus of the SXSW panel, is a systematic approach to building better relationships and bipartisanship in Congress. ACE is focused on members of the U.S. House of Representatives and is built upon three precepts:

- To develop trust, Members of Congress must listen to one another to understand what it is that motivates them and concerns them.
- Once they listen to each other, they often learn they actually have more in common than meets the eye – and if they can see each other in that vein, impactful legislation can be achieved.
- A shared experience based on close interaction can be what brings Members of Congress together to take action on behalf of the American people.

The central goal of ACE is to build connections and trust, which will create conditions for intentional negotiation and compromise on issues of importance to the participants' constituencies as well as the nation. The trips increase mutual understandings, and further collaboration on policy matters and legislation. Additionally, as a result, Congress will operate more effectively. BPC representative will accompany traveler on the trip to provide logistics and coordinate functioning of events.

The Austin, TX region is the location of the South By Southwest Festival (SXSW) and affords Congresswoman Jacobs a variety of learning opportunities relevant to her home district and her committee assignments.
