Question 12: Founded in 2014, Latinos in Heritage Conservation (LHC) is a non-profit and the leading organization for the preservation of Latina/o places, stories, and cultural heritage in the United States. The goal of our biennial conference, Congreso 2022 is to elevate and educate our audience on significant and lesser-known Latinx heritage sites, historic preservation work, and organizations throughout the Intermountain Region.

We invite the Congressman as a representative and individual from the Intermountain Region, as a historic preservationist, and Chair of the House Natural Resources Committee. For his visit, he will address the audience on Friday, April 30, 2022, on his life experience living in Arizona and his work in heritage conservation, through his life, and as the House Natural Resources Committee Chair. Additionally, Senior Executive Assistant, Carlos Martinez will accompany the Representative to assist with scheduled events, keynote presentation, and remarks.

About Congreso 2022: Region, Rights, and Resources in the Intermountain Region

In partnership with Historic Denver Inc, LHC will host Congreso 2022 in Denver, Colorado, April 28-30, 2022, at the History Colorado Center. Guided by the belief that historic preservation should be accessible, more inclusive, and reflective of her people, Congreso 2022 will center the Intermountain Region, explore multiple perspectives, and ignite the next wave of Latinx heritage practitioners.

This event will bring together stakeholders working to save heritage sites throughout the Intermountain Region. They will participate as panel speakers, engage in networking events, and actively learn about historic preservation and best practices to build their toolbox. Consonant with our meeting location, the geographical focus of LHC's fourth national biennial conference is the **Intermountain Region**, an area characterized by a range of geographies and ecological zones and diverse cultures, histories, and traditions. The name of our gathering recalls El Congreso de Pueblos de Habla Española, the coalition of civil rights and labor rights organizations that Luisa Moreno first convened in Los Angeles in 1938. In the same spirit, we remember the Crusade for Justice founded by Rodolfo "Corky" Gonzales and other activists in 1966 and the National Chicano Youth Liberation Conferences hosted in Denver. Today, as we remain mindful of the **fundamental rights** we must continue to defend, we also seek to honor and protect the varied and complex **historical, cultural, and natural resources** we share, in this region and beyond - our stories, art, music, foodways, neighborhoods, waterways, clean air, public lands, and enduring landscapes.

Our constituency is a diverse network of intergenerational advocates who work to conserve Latinx sites and living cultures in the fabric of American society. This landmark gathering brings together over 200 national thought leaders, preservationists, scholars, students, historic site staff, and community advocates to discuss the value and future of Latinx heritage conservation in the United States. Previous events took place in Tucson in 2015, Houston in 2016, and Providence in 2018. Building on these successes, Congreso 2022 offers three days of content explicitly focused on Latinx preservation heritage
