Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your and your spouse's proposed trip to Egypt, scheduled for November 9 to 13, 2022, sponsored by the Climate Solutions Foundation.

Egypt has invested water desalination projects along its coast to accommodate a growing tourist population and decreasing available water supply. Sharm El-Sheikh boasts over 60 hotels and resorts along its coast. To serve the water needs of this area, the government invested in multiple desalination plants in partnership with private entities. BOO Seawater Desalination Plant is positioned at the entrance of the Aqaba Gulf. The plant is a seawater reverse osmosis desalination plant with a total capacity of 18,000 m³/day. International Utilities Company, the private company responsible for building and maintaining the plant, will provide us with an overview of their plan, progress made since 2002, and what to expect in the future.

The Conference of Parties, COP, is the decision-making body responsible for monitoring and reviewing the implementation of the United Nations Framework Convention on Climate Change, whose objective is to "stabilize greenhouse gas concentrations in the atmosphere at a level that would prevent dangerous anthropogenic interference with the climate system". 

David Dumke, Executive Director of Global Perspectives & International Initiatives at the University of Central Florida, will join us to provide additional background information on what to expect while in Egypt and global perspectives on climate change.

Overview of meetings in the Blue Zone, the official meeting center of COP27: You will be meeting with dignitaries from foreign governments, NGO executives, and corporate executives during this time. Please note that governments are aware that you are not part of an official United States Government delegation. Sarah Wiszniak, Program Director of CSF, will be guiding the group through the Blue Zone. She will meet you at the convention center before going through security.

Meeting with Lord Goldsmith, Minister of State for Asia, Energy, Climate and Environment of the United Kingdom

About Lord Goldsmith: Lord Goldsmith of Richmond Park, "Zac" is the scion of billionaire industrialist James Goldsmith and married to Alice Rothschild of the Rothschild banking dynasty. He is a member of the conservative party and served in the House of Commons from 2007 to 2019 when he lost his election. He is a close ally of Boris Johnson who then appointed him to the House of Lords. Until then-Prime Minister Truss fired him, he served as Minister of State with special responsibilities regarding the environment. In the current administration of Prime Minister Sunak, he has been given responsibilities for territories and the Commonwealth.

Today, Lord Goldsmith's agenda reflects his years of work on the environment and his recent responsibilities for territories, and he is likely to raise the need for developed nations to aid less developed nations experiencing the consequences of climate change; particularly those dealing with rising seas.

About the UK's climate agenda: In 2019, the UK pledged to reduce greenhouse gas emissions to netzero by 2050. In addition, then-Prime Minister Boris Johnson committed that the UK's electricity sector will achieve net-zero by 2035. The 2050 commitment is considered "on-track" with Paris Agreement goals to limit global warming to 1.5 degrees Celsius. On the other hand, it is unclear how the UK will meet its goals, particularly the early 2035 goal for the power sector.

The new administration of Prime Minister Sunak has not yet made its climate policies clear. Climate was a major priority for Prime Minister Boris Johnson (and previous conservative prime ministers back to Margaret Thatcher) who viewed the issue as key to expanding the party's base and winning elections. The UK exerted considerable influence on climate in advance of and surrounding last year's COP26 in Glasgow, but its future commitment is uncertain given the recent changes in government.

Hurst also cofounded of the Electronic Industry Citizenship Coalition (EICC, now the Responsible Business Alliance). In her early career, Hurst worked in the offices of Mayor Willie Brown of San Francisco and for the late Senator Daniel Patrick Moynihan (D-NY).

The Green Climate Fund (GCF) was established in 2010 as an independent entity to create a climate finance market in the developing world. The view is that projects in the developing world had little to no access to green investors which would result in climate-friendly projects being set aside for traditional projects. The Green Climate Fund is supposed to provide incremental funding for those projects, but also to create channels for private investment to displace projects that emit more greenhouse gasses. Large projects are in agriculture and reforestation.

The GCF was envisioned as a \$100 billion/year undertaking to be funded by developed countries. To date, a little over \$10 billion has been raised. The United States has committed \$3 billion and provided \$1.5 billion. House Republicans have been critical of using tax dollars for this work. Major groups including Conservation International, World Wildlife and banks including Deutsche Bank ad HSBC partner with the GCF. Yannick Glemarec, the executive director of the GCF with whom you will meet has announced his retirement in March of 2023.

About Yannick Glemarec: Yannick Glemarec is the Executive Director of the Green Climate Fund. Yannick has 30 years of international experience in climate change, development and finance, and their interrelationships, including serving as UN Assistant Secretary-General for Policy and Programme in UN Women, Executive Coordinator of the UN Multi-Partner Trust Fund Office, and UNDP Deputy Executive Coordinator for the Global Environment Facility Administration.

CSF has assembled a group of corporate Chief Sustainability Officers (CSOs) for a discussion on how corporate climate goals are transforming with recently developed CSO roles and what policies CSOs wish the government had in place.

11:00 AM to 12:30 PM

Off-Site Visit to Sharm El-Sheikh Power Station

Members of Congress, Hon. Curbelo, and Alex Flint will tour the Sharm El-Sheikh Power Station. General Electric works with the Egyptian Government to operate the power plant. The delegation will meet with Egyptian officials and General Electric. You will be the first public group to view General Electric's pilot program with the Government of Egypt that will bring hydrogen-blended fuel to the continent of Africa for the first time.

There will be a group of 20 representatives from all companies involved in the operations of the plant joining you on this tour. Roger Martella, GE's Chief Sustainability Officer, and Joseph Anis, GE's President & CEO, Europe, Middle East & Africa, GE Gas Power, will be leading this tour. Abeer Masood and Mohamed el Sharkawy have been extremely helpful in putting this program together.

Due to the limited quantities of hydrogen available on the power plant site, the turbine will not be running on a hydrogen fuel blend until the week following our visit. The group will walk away from the tour with knowledge of technical modifications that need to be made to allow for power generation through hydrogen-blended fuel and the policy benefits attending these efforts. The delegation will be able to see all the preparations made for the first turbine to run on a hydrogen blend on the African continent.

General Electric has operated in Egypt since the 1970s and has played a pivotal role in the expansion of Egypt's green electricity capabilities. We will hear from their Egyptian leadership team on how they their relationship with Egypt has evolved over time, and what new technology they're introducing to assist in enhancing Egypt's climate change strategy.

12:30 PM to 4:00 PM Lunch and Visit to Surrounding Area of Ras Mohamed National Park by Boat

We will be given a tour and talk about Ras Mohamed Nature Reserve in Ras Mohamed National Park (RMNP) that highlights how Egypt has ensured the coral reef remains intact despite it being one of the most famous diving sites in the world. Over the past 15 years, the United Nations has pushed for increased funding for site conservation. In 2018, the RMNP received the International Union for Conservation of Nature (IUCN) Green List certification for its fair and effective management efforts that have ensured the protection and survival of natural ecosystems, especially coral reefs, mangroves, and sea grasses.

Our group will be led by Ahmed Gabr, Guinness World Record Holder for the deepest SCUBA dive. Ahmed is an ex-Egyptian Army officer and the only certified US Combat Diver in the Middle East. He began his diving career at 18 and is now an instructor. Ahmed has a deep understanding of Ras Mohamed National Park and how climate change has impacted the area.
