Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to United Kingdom,¹ scheduled for January 12 to 17, 2023, sponsored by Association of Marshall Scholars.

Committee travel regulations require that you submit your complete pre-trip approval request to the Committee at least 30 days before the commencement of the trip or it will not be granted. Despite your failure to do so in this instance, we are approving your current request. However, any future requests should adhere to the 30-day requirement.

You must complete a Member/Officer Post-Travel Disclosure Form and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. You must also report all travel expenses totaling more than the reporting threshold from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. That reporting threshold is currently \$415 but is set to adjust in 2023. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

¹ Please be aware that the Committee's review of the proposed trip does not extend to either the security situation in the destination country or security related to foreign travel in general. Because the trip may involve meetings with foreign government representatives, we note that House Members may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$415, but set to adjust in 2023] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

The delegation engages in dialogue on issues of critical concern to both nations. The US-UK Legislative Exchange provides an opportunity to underscore and share the expertise within the Marshall community and aims to support a valuable exchange between legislators from both nations.

Between her first election and her second in 2015, Ms. Baldwin MP's parliamentary experience largely focused on work and pensions, acting as Parliamentary Private Secretary to the Minister for Employment in the Department of Work and Pensions and serving on the Work and Pensions Select Committee. In 2015, she became Economic Secretary to the

Treasury and in 2019, she joined the Treasury Select Committee. She was elected Chair of the Treasury Select Committee in November 2022.

Ms. Baldwin MP is wholeheartedly dedicated to representing the UK's foreign policy. She has represented the UK on the NATO Parliamentary Assembly two separate times, was the Prime Minister's Trade Envoy to Russia, and served as Minister for Africa. She has also served as the Conservative Party's Assistant Government Whip, from which position she was promoted to Lord Commissioner to HM Treasury.



Rt Hon Liam Byrne MP (LAB)

Liam is the Labour MP for Birmingham Hodge Hill, a member of Her Majesty's Privy Council, elected Chair of the Global Parliamentary Network on the World Bank and IMF and an Associate of Nuffield College, Oxford. He sits on the House of Commons Foreign Affairs Committee and chairs the All Party Parliamentary Group on Inclusive Growth.

He was promoted to become a minister within six months and to Cabinet after four years, serving as the youngest member of Gordon

Brown's top team helping coordinate No 10 Downing Street as Chancellor of the Duchy of Lancaster during the Great Financial Crisis before negotiating Labour's fiscal consolidation plan as Chief Secretary to Her Majesty's Treasury.

In addition, Liam has worked extensively on foreign affairs. He is a former member of the Council of Europe and is one of Westminster's leading authorities on China. His book Turning to Face the East was published in 2013, he co-founded the UK-China Young Leader's Roundtable, and helps anchor the UK-China Leadership for the Future Forum. He has travelled and taught extensively through the Middle East and the Gulf and his book, Black Flag Down: Counter-Extremism, Defeating ISIS and Winning the Battle of Ideas was published in 2017.



Rt Hon Mr Nigel Evans MP (CON)

Nigel Martin Evans MP (born 10 November 1957) is a British politician serving as the Member of Parliament (MP) for the Ribble Valley constituency in Lancashire since 1992. A member of the Conservative Party, he was Joint Executive Secretary of the 1922 Committee from 2017 to 2019. He served as First Deputy Chairman of Ways and Means, one of the Speaker's three deputies, from 2010 to 2013. He was elected as Second Deputy Chairman of Ways and Means in 2020.



The Baroness Falkner of Margravine (CROSS)

Baroness Falkner was appointed to the House of Lords in 2004, joining the Liberal Democrats' parliamentary team of 74 in the Lords. In 2005 she became the first Muslim to be promoted to the front bench in UK parliamentary history, becoming a spokesperson on Communities and Local Government. Falkner's other parliamentary activities have included serving on committees scrutinizing Human Rights, European Union Foreign Affairs, International Development and Defense and Legal Services. Falkner also speaks on international terrorism and was a member of the Prime Minister's Taskforce on Muslim Extremism in 2005.

Baroness Falkner served as Chief Executive of Students Partnership Worldwide, an international charity focusing on the needs of young people in Africa and Asia. Falkner's previous roles included working for the Commonwealth Secretariat, where she was responsible for good governance, democracy and political development in Commonwealth countries, and as Director of Policy and International Affairs for the Liberal Democrats. Born in Pakistan, Falkner has lived and worked in several regions of the world including the Middle East, Europe, Africa and Asia.



Rt Hon Dr Liam Fox MP (CON)

Dr Liam Fox was Secretary of State for International Trade and President of the Board of Trade from July 2016 to July 2019. He was elected as the Conservative MP for North Somerset in 1992.

Liam held several ministerial roles in John Major's Conservative government. He served as Constitutional Affairs Spokesman (1998–1999), Shadow Health Secretary (1999–2003), Conservative Party chairman (2003–05), Shadow Foreign Secretary (2005) and Shadow Defence Secretary (2005–10). In 2010, he was appointed

Secretary of State for Defence, a position from which he resigned on 14 October 2011.

Liam worked as a GP before his election to Parliament and is a former Civilian Army Medical Officer and Divisional Surgeon with St John Ambulance.



Darren Jones MP (LAB)

Mr. Darren Jones MP is Member of Parliament for Bristol North West, and Chair of the cross-party Business, Energy and Industrial Strategy Committee. He also sits on the National Security Strategy, Draft Online Safety Bill, and Liaison Committees.

Mr. Jones MP was born and raised in Bristol and now lives there, in his constituency, with his family. He trained as a solicitor, working in Plymouth, Bristol, and London. He specialised in technology law, and also spent many years working for the National Health Service.



Alicia Kearns MP (CON)

Alicia Kearns is a British Conservative Party politician. She has been the Member of Parliament (MP) for Rutland and Melton since the 2019 general election.

In October 2022, Kearns was elected Chair of the Foreign Affairs Select Committee.



Rt Hon the Baroness Neville-Jones DCMG (CON)

Baroness Neville-Jones DCMG served as the UK Special government representative to Business for Cyber Security " an appointment by Prime Minister David Cameron that she has held from the time she stepped down in May 2011 from being Minister of State for Security and Counter Terrorism at the British Home Office with a permanent position on the newly created National Security Council. Prior to serving as a Minister in the Coalition government, with a seat on the House of Lords, she was David Cameron's national security adviser while in opposition and the author of much of the Conservative party's national security policy. She is patron of "Cyber Security Challenge" in the UK.

Pauline Neville-Jones was a career member of HM Diplomatic Service from 1963 to 1996, during which time she served in British Missions in Rhodesia, Singapore, Washington, DC in Bonn and in the European Commission. From 1991 to 1994 she was Head of the Defence and Overseas Secretariat in the Cabinet Office and Deputy Secretary to the Cabinet. During 1993 and 1994 she was Chairman of the Joint Intelligence Committee. From 1994, until her retirement, she was Political Director in the Foreign and Commonwealth Office, in which capacity she led the British delegation to the Dayton negotiations on the Bosnia peace settlement. As chairman of QinetiQ Group Plc, Pauline took the defence and security company to flotation as a FTSE 250 company in 2006. She is a former Governor of the BBC.



Chi Onwurah MP (LAB)

Ms. Chi Onwurah has been elected four times as the Member of Parliament for Newcastle upon Tyne Central, and is the current Shadow Minister for both Business, Energy and Industrial Strategy (since 2016) and Digital, Culture, Media and Sport (from 2015–2016 and since 2020). From 2010–2013 and 2015–2016, she was also Shadow Minister for Business, Innovation and Skills.

Ms. Onwurah MP was born in Newcastle, but her family briefly emigrated to her father's native Nigeria, only to be brought back by the onset of the Biafran Civil War. She has a long family history in

Newcastle, with a maternal grandfather who was a sheet metal worker in the shipyards of the Tyne during the Great Depression. Newcastle's industrial past led her to a successful career as an engineer in a range of countries, including the United States. For years, Ms. Onwurah MP was on the National Executive of the Anti Apartheid Movement and its successor, ACTSA.



Rt Hon Mark Pritchard MP (CON)

Mark Pritchard was first elected as Member of Parliament for The Wrekin in 2005. He is currently serving his fifth term as an MP - enjoying the largest parliamentary majority in the 100 year history of The Wrekin seat. He is also the longest serving MP for The Wrekin in its history - under any boundary configuration.

Before entering Parliament in 2005, Mark ran a successful marketing business - advising a range of blue-chip clients and international businesses. He continues to run his own business, which he says "keeps me rooted in the real world - not just in the Westminster bubble. Mark has served on eight select committees

during his time in Parliament, including most recently the Intelligence and Security Committee.



Rt Hon Julian Smith MP (CON)

Julian has been the Conservative MP for Skipton and Ripon since 2010. Prior to entering Parliament he built and ran an executive search firm in London and Singapore.

Julian was appointed Secretary of State for Northern Ireland following Boris Johnson's election as Prime Minister in July 2019.

From 2017-2019 Julian was Government Chief Whip. Usually a low profile role, the combination of a hung parliament and Brexit placed it in sharp focus. Julian led efforts to hold the Conservative party together during the most divisive period in the party's history. Prior to becoming Government Chief Whip, Julian held various

roles in the Whips office including Deputy Chief Whip and Vice Chamberlain – the Minister who regularly updates the Sovereign on parliamentary affairs.



Rt Hon John Spellar MP (LAB)

John Spellar has been Warley's Member of Parliament since 1997. Before then, he was MP for Warley West from 1992–1997 and for Birmingham, Northfield from 1982–1983. In government, Mr. Spellar MP has been Minister of State for Defense (1999–2001), the Armed Forces (1999–2001), and Transport (2001–2003), as well as Deputy Chief Whip (2008–2010). In opposition, he was Shadow Minister of Foreign and Commonwealth Affairs from 2010 to 2015. Since 2015, he has sat on the Defense Committee and Sub-Committee.

Prior to his storied career in Parliament, Mr. Spellar MP was a trade union official, serving as the Political Officer of the Electrical, Electronic, Telecommunications and Plumbing Union. He was also a Councillor for Bromley Borough from 1970 to 1974. He is presently the Honorary Treasurer for the British American Parliamentary Group.



Rt Hon the Lord Vaizey of Didcot (CON)

Lord Vaizey was elevated to the peerage in 2020 after 15 years as the Member of Parliament for Wantage. He served as the UK's Culture and Digital Minister from 2010 to 2016, the longest anyone has held that role, and in that position rolled out rural broadband to over 4 million homes, oversaw the introduction of 4G, and pushed for the inclusion of coding in the national curriculum. He also published the first White Paper on Culture in 50 years and helped persuade Lucas Films to make the new *Star Wars* in the UK.

Lord Vaizey is an executive-in-residence at LionTree, a mergers and acquisitions firm specialising in the technology, media, and telecom sector. He also advises Common Sense Media, a non-profit (co-founded by a 1972 Marshall Scholar) that campaigns for kids' internet safety, and a variety of other organizations, and is a trustee of the National Youth Theatre and the Documentary Society.

He writes regularly on culture for Country and Townhouse Magazine.



The Lord Wood of Anfield (LAB)

The Lord Wood of Anfield has sat under that title since 2011, and serves on a range of committees concerning the UK's relationship with Europe, including the European Affairs Committee, the European Union Committee, and the EU Goods Sub-Committee. From 2011–2015, Lord Wood was a Shadow Minister without Portfolio and adviser to Ed Miliband. Prior to Parliament, he worked as Senior Special Adviser to Prime Minister Gordon Brown, leading on foreign policy, Northern Irish Affairs, and culture,

media, and sports policy. From 2001-2007, he was also a member of the Treasury's Council of Economic Advisers.

Lord Wood is a Fellow of Magdalen College (Oxford), where he taught politics from 1995-2011, and is currently a Visiting Fellow at the University of Oxford's Blavatnik School of Government. His research and teaching focused on political economy in western Europe. He writes regularly on issues of contemporary public policy.

Since 2010, he has been the Shadow Leader of the House of Commons, the Shadow Secretary of State for Communities and Local Government and the Shadow Foreign Secretary. He was elected Chair of the Exiting the European Union

Select Committee in October 2016 and served in this capacity and then subsequently as Chair of the Select Committee on the Future Relationship with the European Union until January 2021. He is currently co-convenor of the UK Trade and Business Commission.



Sarah Champion MP (LAB)

Sarah Champion is a British Member of Parliament and member of the Labour Party. She is Chair of the International Development Select Committee.



Philip Collins, UK Political Journalist and Columnist, *New Statesman*

Philip Collins is a political journalist and columnist and leader writer for the *New Statesman*. He is also the chair of the board of trustees at the independent think tank Demos and a visiting fellow in the public policy

unit at the University of Oxford. He was the Chief Speech Writer for the Prime Minister, Tony Blair, the Director of the Social Market Foundation think tank and an Equity Strategist at two investment banks.



Stephen Doughty MP (LAB)

Stephen Doughty is the Labour (Co-op) MP for Cardiff South and Penarth, and has been an MP continuously since 15 November 2012. He currently undertakes the role of Shadow Minister (Foreign and Commonwealth Affairs and International Development).



The Lord Jay of Ewelme GCMG (CROSS)

Michael Jay, Baron Jay of Ewelme is a British politician and former diplomat. He sits as a Crossbench member of the House of Lords, and previously served as Ambassador to France and Permanent Under Secretary at the Foreign and Commonwealth Office.



Dr. Gabriele Finaldi, Director, National Gallery

Gabriele Finaldi has been Director of the National Gallery since August 2015. Dr Finaldi was previously Deputy Director for Collections and Research at the Museo Nacional del Prado, Madrid, a position he took up in 2002.

Prior to his role at the Prado, he was a curator at the National Gallery between 1992 and 2002 where he was responsible for the later Italian paintings in the collection (Caravaggio to Canaletto) and the Spanish collection (Bermejo to Goya).

He has curated exhibitions in Britain, Spain, Italy, and Belgium and he has written catalogues and scholarly articles on Velázquez and Zurbarán, on Italian Baroque painting, on religious iconography, and on Picasso.



Sir Jeremy Fleming KCMG CB, Director, GCHQ

Sir Jeremy Fleming is the Director of GCHQ, the UK's Intelligence, Cyber and Security Agency. He was appointed in 2017 and is the 16th person to hold the role. After an early career in the financial sector, Jeremy joined MI5 in 1993. He gained extensive operational, investigative and leadership experience across the full range of national security work. He helped shape MI5's response to the London terrorist attacks in 2005, led the revision and publication of the Government's counter-terrorism strategy, CONTEST, and was promoted to Assistant Director General to lead MI5's preparations for the London 2012 Olympics. He then spent four years as Deputy Director General with responsibility for all investigations and operations.

In GCHQ, Jeremy has overseen the creation of the National Cyber Security Centre with a mission to make the UK the safest place to live and do business online. It has become a world leader in bringing together Government, industry and international partners to address cyber threats and inform the public.



Air Vice-Marshal Paul Godfrey OBE (RAF)

Air Vice-Marshal Paul Godfrey is a senior Royal Air Force officer, who serves as the first commander of the UK Space Command. Godfrey was commissioned into the Royal Air Force on 9 May 1991. After serving as a Harrier Jump Jet pilot, he became station commander at RAF Lossiemouth in November 2015. In February 2021 it was announced that he would

become the first Commander, United Kingdom Space Command. In taking up the post he will be promoted to the rank of Air Vice-Marshal.



Andrew Griffith MP (CON)

Andrew Griffith is a former senior media executive who has been the Member of Parliament (MP) for Arundel and South Downs since 2019. A member of the Conservative Party, he has been serving as Economic Secretary to the Treasury since October 2022. He was appointed Parliamentary Under-Secretary of State for Exports in July 2022 and served until September 2022. Griffith previously was Director of the Number 10 Policy Unit from February 2022 to July 2022.



Rt Hon Greg Hands MP (CON)

The Rt Hon Greg Hands is the Conservative MP for Chelsea and Fulham, and has been an MP continuously since 5 May 2005. He currently holds the Government post of Minister of State (Department for International Trade).



Rt Hon Chris Heaton-Harris MP (CON)

Penny Mordaunt has been Leader of the House of Commons and Lord President of the Council since September 2022. A member of the Conservative Party, she has been Member of Parliament (MP) for Portsmouth North since May 2010. She served as a junior minister under Boris Johnson, having previously served in Theresa May's Cabinet as Secretary of State for International Development from 2017 to 2019, and as Secretary of State for Defence from May to July 2019.



Hans Pung (Marshall Scholar 1995), President, Rand Europe

Hans Pung is president of RAND Europe, a not-for-profit public policy research organisation that helps improve policy and decisionmaking through research and analysis. With offices in Cambridge (UK), and Brussels (BE), RAND's staff undertakes empirical studies for public, private, and third sector clients on a diverse range of policy issues including innovation, science, health, social policy, defence, home affairs, and infrastructure.

Pung joined RAND as a policy analyst in 2002 and continues to lead and deliver research projects, particularly around industrial economics and security policy issues. He has held a range of senior leadership positions in RAND Europe, including directing RAND's European defence and security research portfolio as well as heading RAND Europe's efforts to grow and diversify into new research areas.

First Lieutenant Katherine "Katie" Scheibner is a 2020 Marshall Scholar and Cyberspace Effects Operations Officer in the United States Space Force. She is a Distinguished Graduate of the United States Air Force Academy (2020), University of St Andrew (2021), and University of Oxford (2022).



Sir Nigel Sheinwald GCMG, Chair, Chatham House

Sir Nigel served for nearly four decades in the British Diplomatic Service. He was ambassador to the US (2007-12), foreign policy and defence adviser to the UK prime minister (2003-07), and ambassador to the EU (2000-03). During his tenure, he also served as Chief of Staff to

Sir Martin is founder and Executive Chairman of Surrey Satellite Technology Ltd (SSTL). He has pioneered rapid response, low-cost and highly-capable small satellites utilizing modern terrestrial COTS devices to 'change the economics of space' that stimulated the so-called 'Newspace'

initiative. SSTL has designed, built, launched and operated in orbit 61 nano, micro, and mini-satellites—including the International Disaster Monitoring Constellation (DMC) and the first Galileo navigation satellite (GIOVE-A) for ESA and all the subsequent 34 navigation payloads for the operational European Galileo constellation.

In 2014, he was identified by the Sunday Times as one of the UK's top 20 most influential engineers and in Debrett's 2017 list of the 500 most influential people in the UK.



Rt Hon Mr Ben Wallace MP (CON)

The Rt Hon Mr Ben Wallace is the Conservative MP for Wyre and Preston North, and has been an MP continuously since 5 May 2005. He currently holds the Government post of Secretary of State for Defence.

The Archbishop of Canterbury, The Most Revd Justin Welby



The Most Revd Justin Welby was ordained in 1992 after an 11-year career in the oil industry. He spent his first 15 years serving in Coventry diocese, often in places of significant deprivation.

In 2002 he was made a Canon of Coventry Cathedral, where he jointly led its international reconciliation work. During this time he worked extensively in Africa and the Middle East. Archbishop Justin has had a passion for reconciliation and peace-making ever since.

He was Dean of Liverpool from 2007 to 2011 and Bishop of Durham from 2011 to 2012, before being announced as the 105th Archbishop of Canterbury in late 2012.

Xenia Wickett, Wickett Advisory






THE TIES THAT BIND

Every year, the Association of Marshall Scholars partners with Emerson College Polling Center to conduct a poll that highlights major current issues and public perceptions about US-UK ties. This year's report surveys American attitudes toward strategic alliances, international partnerships and overseas learning. The data—which found that 80 percent of Americans believe US-UK leadership is important for global security—comes just as the UK government is experiencing great political change with a new Prime Minister and a new King.



Which of the following countries do you think is the most valuable ally and strategic partner of the United States?







In your opinion, which of the following has the most significant influence on a strong alliance between the United States and the United Kingdom?

A NEW CLASS

Introducing the 2023 Marshall Scholars

The 40 winners of the 2023 Marshall Scholarships were unveiled by the British government in December. The recipients, considered among the most accomplished undergraduate university students and recent graduates in the United States, were chosen following an intense selection process. The 2023 class will begin graduate studies at universities across the United Kingdom next year, coinciding with the 70th anniversary of the scholarship.

This year's class includes accomplished authors, astrophysicists, a human rights advocate, and COVID-19 researchers, among other disciplines. Eighty-five percent of the 2023 class intend to pursue public service careers in the US following their time in the UK, including representatives from the US Military Academy and US Air Force Academy who will take up active-duty service upon completing their studies.

"Whether it is the War in Ukraine or global challenges from the effects of climate change, Marshall Scholars continue to work to help address global issues head on," said Dame Karen Pierce, British ambassador to the United States. "The British government is excited to support these future leaders of American society as they begin the next stage of their lives studying at some of the UK's top academic institutions."







ABOUT THE AMS

British Parliament created the Marshall Scholarship in 1953 in gratitude to the United States for the Marshall Plan. The flagship program continues today as an extraordinary opportunity for between 40-50 highly accomplished young Americans to begin or continue post-graduate education at any university in the United Kingdom.

The Association of Marshall Scholars works to strengthen US-UK ties and also the Marshall Scholarship. Historically, the transatlantic alliance has served as a linchpin for liberal democracy, prosperity, and global peace. A valuable thread of this relationship has been the Marshall Scholarship, an educational program strengthening international exchange and advancement in nearly every field of human endeavor.

Over 2,000 young Americans have been awarded Marshall Scholarships to study at universities throughout the United Kingdom. Since that time, the Scholarship has counted among its distinguished alumni a Nobel Laureate, a NASA Astronaut, Oscar, and Academy Award winners and nominees, fourteen MacArthur Fellows, six Pulitzer Prize winners, founders of global companies such as Dolby Labs and LinkedIn, presidents of Universities and Colleges, and many in the military and public service across the legislative, executive and judicial branches of government.

In recent years, the Association has developed programs to foster educational exchange with its membership and civic leaders in the US and in the UK. Examples of these ongoing programs include The Marshall Forum and the US-UK Legislative Exchange.

A close accord between our two countries is essential to the good of mankind in this turbulent world of today, and that is not possible without an intimate understanding of each other. These scholarships point the way to the continuation and growth of the understanding which found its necessity in the terrible struggle of the war years.

British Parliament created the Marshall Scholarship in 1953 in gratitude to the United States for the Marshall Plan. The flagship program continues today as an extraordinary opportunity for between 40-50 highly accomplished young Americans to begin or continue post-graduate education at any university in the United Kingdom.

The Association of Marshall Scholars works to strengthen US-UK ties and also the Marshall Scholarship. She is admitted to the bar in New York, Connecticut and Florida. She also is admitted to all federal courts including the United States Supreme Court.

Mike Turner (R OH-10) (emeritus co-chair)

Congressman Turner was first elected to Congress in 2002. In Congress, Turner is a senior member of the House Armed Services Committee and has previously served as the lead Republican of the Tactical Air and Land Forces subcommittee and the Strategic Forces subcommittee. The subcommittees oversee Army and Air Force acquisition programs, all Navy and Marine Corps aviation programs, nuclear weapons, missile defense, and space systems.

After serving on the House Permanent Select Committee on Intelligence (HPSCI) since 2015, Turner was appointed as the Lead Republican of HPSCI in January 2022.

In January 2011, Turner was appointed Chairman of the US Delegation to the North Atlantic Treaty Organization (NATO) Parliamentary Assembly, the inter-parliamentary organization of legislators from the countries of the North Atlantic Alliance. In December of 2014, Turner was elected President of the NATO Parliamentary Assembly. He now serves as Vice-Chairman of the Defense and Security Committee of the NATO Parliamentary Assembly.



Harriett Baldwin MP (CON)

Harriet Baldwin has served as Member of Parliament for West Worcestershire since 2010. She came to politics from a successful 20 year career in finance, which she has used to great effect in representing her constituents. Between her first election and her second in 2015, Ms. Baldwin MP's parliamentary experience largely focused on work and pensions, acting as Parliamentary Private Secretary to the Minister for Employment in the Department of Work and Pensions and serving on the Work and Pensions Select Committee. In 2015, she became Economic Secretary to the

Rt Hon Liam Byrne MP (LAB)

Liam is the Labour MP for Birmingham Hodge Hill, a member of Her Majesty's Privy Council, elected Chair of the Global Parliamentary Network on the World Bank and IMF and an Associate of Nuffield College, Oxford. He sits on the House of Commons Foreign Affairs Committee and chairs the All Party Parliamentary Group on Inclusive Growth.

He was promoted to become a minister within six months and to Cabinet after four years, serving as the youngest member of Gordon

Brown's top team helping coordinate No 10 Downing Street as Chancellor of the Duchy of Lancaster during the Great Financial Crisis before negotiating Labour's fiscal consolidation plan as Chief Secretary to Her Majesty's Treasury.

In addition, Liam has worked extensively on foreign affairs. He is a former member of the Council of Europe and is one of Westminster's leading authorities on China. His book Turning to Face the East was published in 2013, he co-founded the UK-China Young Leader's Roundtable, and helps anchor the UK-China Leadership for the Future Forum. He has travelled and taught extensively through the Middle East and the Gulf and his book, Black Flag Down: Counter-Extremism, Defeating ISIS and Winning the Battle of Ideas was published in 2017.



Rt Hon Mr Nigel Evans MP (CON)

Nigel Martin Evans MP (born 10 November 1957) is a British politician serving as the Member of Parliament (MP) for the Ribble Valley constituency in Lancashire since 1992. A member of the Conservative Party, he was Joint Executive Secretary of the 1922 Committee from 2017 to 2019. He served as First Deputy Chairman of Ways and Means, one of the Speaker's three deputies, from 2010 to 2013. He was elected as Second Deputy Chairman of Ways and Means in 2020.



The Baroness Falkner of Margravine (CROSS)

Baroness Falkner was appointed to the House of Lords in 2004, joining the Liberal Democrats' parliamentary team of 74 in the Lords. In 2005 she became the first Muslim to be promoted to the front bench in UK parliamentary history, becoming a spokesperson on Communities and Local Government. Falkner's other parliamentary activities have included serving on committees scrutinizing Human Rights, European Union Foreign Affairs, International Development and Defense and Legal Services. Falkner also speaks on international terrorism and was a member of the Prime Minister's Taskforce on Muslim Extremism in 2005.

Baroness Falkner served as Chief Executive of Students Partnership Worldwide, an international charity focusing on the needs of young people in Africa and Asia. Falkner's previous roles included working for the Commonwealth Secretariat, where she was responsible for good governance, democracy and political development in Commonwealth countries, and as Director of Policy and International Affairs for the Liberal Democrats. Born in Pakistan, Falkner has lived and worked in several regions of the world including the Middle East, Europe, Africa and Asia.



Rt Hon Dr Liam Fox MP (CON)

Dr Liam Fox was Secretary of State for International Trade and President of the Board of Trade from July 2016 to July 2019. He was elected as the Conservative MP for North Somerset in 1992.

Liam held several ministerial roles in John Major's Conservative government. He served as Constitutional Affairs Spokesman (1998–1999), Shadow Health Secretary (1999–2003), Conservative Party chairman (2003–05), Shadow Foreign Secretary (2005) and Shadow Defence Secretary (2005–10). In 2010, he was appointed

Secretary of State for Defence, a position from which he resigned on 14 October 2011.

Liam worked as a GP before his election to Parliament and is a former Civilian Army Medical Officer and Divisional Surgeon with St John Ambulance.



Darren Jones MP (LAB)

Mr. Darren Jones MP is Member of Parliament for Bristol North West, and Chair of the cross-party Business, Energy and Industrial Strategy Committee. He also sits on the National Security Strategy, Draft Online Safety Bill, and Liaison Committees.

Mr. Jones MP was born and raised in Bristol and now lives there, in his constituency, with his family. He trained as a solicitor, working in Plymouth, Bristol, and London. He specialised in technology law, and also spent many years working for the National Health Service.



Alicia Kearns MP (CON)

Alicia Kearns is a British Conservative Party politician. She has been the Member of Parliament (MP) for Rutland and Melton since the 2019 general election.

In October 2022, Kearns was elected Chair of the Foreign Affairs Select Committee.



Rt Hon the Baroness Neville-Jones DCMG (CON)

Baroness Neville-Jones DCMG served as the UK Special government representative to Business for Cyber Security " an appointment by Prime Minister David Cameron that she has held from the time she stepped down in May 2011 from being Minister of State for Security and Counter Terrorism at the British Home Office with a permanent position on the newly created National Security Council. Prior to serving as a Minister in the Coalition government, with a seat on the House of Lords, she was David Cameron's national security adviser while in opposition and the author of much of the Conservative party's national security policy. She is patron of "Cyber Security Challenge" in the UK.

Pauline Neville-Jones was a career member of HM Diplomatic Service from 1963 to 1996, during which time she served in British Missions in Rhodesia, Singapore, Washington, DC in Bonn and in the European Commission. From 1991 to 1994 she was Head of the Defence and Overseas Secretariat in the Cabinet Office and Deputy Secretary to the Cabinet. During 1993 and 1994 she was Chairman of the Joint Intelligence Committee. From 1994, until her retirement, she was Political Director in the Foreign and Commonwealth Office, in which capacity she led the British delegation to the Dayton negotiations on the Bosnia peace settlement. As chairman of QinetiQ Group Plc, Pauline took the defence and security company to flotation as a FTSE 250 company in 2006. She is a former Governor of the BBC.



Chi Onwurah MP (LAB)

Ms. Chi Onwurah has been elected four times as the Member of Parliament for Newcastle upon Tyne Central, and is the current Shadow Minister for both Business, Energy and Industrial Strategy (since 2016) and Digital, Culture, Media and Sport (from 2015–2016 and since 2020). From 2010–2013 and 2015–2016, she was also Shadow Minister for Business, Innovation and Skills.

Ms. Onwurah MP was born in Newcastle, but her family briefly emigrated to her father's native Nigeria, only to be brought back by the onset of the Biafran Civil War. She has a long family history in

Newcastle, with a maternal grandfather who was a sheet metal worker in the shipyards of the Tyne during the Great Depression. Newcastle's industrial past led her to a successful career as an engineer in a range of countries, including the United States. For years, Ms. Onwurah MP was on the National Executive of the Anti Apartheid Movement and its successor, ACTSA.



Rt Hon Mark Pritchard MP (CON)

Mark Pritchard was first elected as Member of Parliament for The Wrekin in 2005. He is currently serving his fifth term as an MP - enjoying the largest parliamentary majority in the 100 year history of The Wrekin seat. He is also the longest serving MP for The Wrekin in its history - under any boundary configuration.

Before entering Parliament in 2005, Mark ran a successful marketing business - advising a range of blue-chip clients and international businesses. He continues to run his own business, which he says "keeps me rooted in the real world - not just in the Westminster bubble. Mark has served on eight select committees

during his time in Parliament, including most recently the Intelligence and Security Committee.



Rt Hon Julian Smith MP (CON)

Julian has been the Conservative MP for Skipton and Ripon since 2010. Prior to entering Parliament he built and ran an executive search firm in London and Singapore.

Julian was appointed Secretary of State for Northern Ireland following Boris Johnson's election as Prime Minister in July 2019.

From 2017-2019 Julian was Government Chief Whip. Usually a low profile role, the combination of a hung parliament and Brexit placed it in sharp focus. Julian led efforts to hold the Conservative party together during the most divisive period in the party's history. Prior to becoming Government Chief Whip, Julian held various

roles in the Whips office including Deputy Chief Whip and Vice Chamberlain – the Minister who regularly updates the Sovereign on parliamentary affairs.



Rt Hon John Spellar MP (LAB)

John Spellar has been Warley's Member of Parliament since 1997. Before then, he was MP for Warley West from 1992–1997 and for Birmingham, Northfield from 1982–1983. In government, Mr. Spellar MP has been Minister of State for Defense (1999–2001), the Armed Forces (1999–2001), and Transport (2001–2003), as well as Deputy Chief Whip (2008–2010). In opposition, he was Shadow Minister of Foreign and Commonwealth Affairs from 2010 to 2015. Since 2015, he has sat on the Defense Committee and Sub-Committee.

Prior to his storied career in Parliament, Mr. Spellar MP was a trade union official, serving as the Political Officer of the Electrical, Electronic, Telecommunications and Plumbing Union. He was also a Councillor for Bromley Borough from 1970 to 1974. He is presently the Honorary Treasurer for the British American Parliamentary Group.



Rt Hon the Lord Vaizey of Didcot (CON)

Lord Vaizey was elevated to the peerage in 2020 after 15 years as the Member of Parliament for Wantage. He served as the UK's Culture and Digital Minister from 2010 to 2016, the longest anyone has held that role, and in that position rolled out rural broadband to over 4 million homes, oversaw the introduction of 4G, and pushed for the inclusion of coding in the national curriculum. He also published the first White Paper on Culture in 50 years and helped persuade Lucas Films to make the new *Star Wars* in the UK.

Lord Vaizey is an executive-in-residence at LionTree, a mergers and acquisitions firm specialising in the technology, media, and telecom sector. He also advises Common Sense Media, a non-profit (co-founded by a 1972 Marshall Scholar) that campaigns for kids' internet safety, and a variety of other organizations, and is a trustee of the National Youth Theatre and the Documentary Society.

He writes regularly on culture for Country and Townhouse Magazine.



The Lord Wood of Anfield (LAB)

The Lord Wood of Anfield has sat under that title since 2011, and serves on a range of committees concerning the UK's relationship with Europe, including the European Affairs Committee, the European Union Committee, and the EU Goods Sub-Committee. From 2011–2015, Lord Wood was a Shadow Minister without Portfolio and adviser to Ed Miliband. Prior to Parliament, he worked as Senior Special Adviser to Prime Minister Gordon Brown, leading on foreign policy, Northern Irish Affairs, and culture,

media, and sports policy. From 2001-2007, he was also a member of the Treasury's Council of Economic Advisers.

Lord Wood is a Fellow of Magdalen College (Oxford), where he taught politics from 1995-2011, and is currently a Visiting Fellow at the University of Oxford's Blavatnik School of Government. His research and teaching focused on political economy in western Europe. He writes regularly on issues of contemporary public policy.

Rt Hon Hilary Benn MP (LAB)

Hilary has been the Labour Member of Parliament for Leeds Central since 1999. Since 2010, he has been the Shadow Leader of the House of Commons, the Shadow Secretary of State for Communities and Local Government and the Shadow Foreign Secretary. He was elected Chair of the Exiting the European Union

Select Committee in October 2016 and served in this capacity and then subsequently as Chair of the Select Committee on the Future Relationship with the European Union until January 2021. He is currently co-convenor of the UK Trade and Business Commission.



Sarah Champion MP (LAB)

Sarah Champion is a British Member of Parliament and member of the Labour Party. She is Chair of the International Development Select Committee.



Philip Collins, UK Political Journalist and Columnist, *New Statesman*

Philip Collins is a political journalist and columnist and leader writer for the *New Statesman*. He is also the chair of the board of trustees at the independent think tank Demos and a visiting fellow in the public policy

unit at the University of Oxford. He was the Chief Speech Writer for the Prime Minister, Tony Blair, the Director of the Social Market Foundation think tank and an Equity Strategist at two investment banks.



Stephen Doughty MP (LAB)

Stephen Doughty is the Labour (Co-op) MP for Cardiff South and Penarth, and has been an MP continuously since 15 November 2012. He currently undertakes the role of Shadow Minister (Foreign and Commonwealth Affairs and International Development).



The Lord Jay of Ewelme GCMG (CROSS)

Michael Jay, Baron Jay of Ewelme is a British politician and former diplomat. He sits as a Crossbench member of the House of Lords, and previously served as Ambassador to France and Permanent Under Secretary at the Foreign and Commonwealth Office.



Dr. Gabriele Finaldi, Director, National Gallery

Gabriele Finaldi has been Director of the National Gallery since August 2015. Dr Finaldi was previously Deputy Director for Collections and Research at the Museo Nacional del Prado, Madrid, a position he took up in 2002.

Prior to his role at the Prado, he was a curator at the National Gallery between 1992 and 2002 where he was responsible for the later Italian paintings in the collection (Caravaggio to Canaletto) and the Spanish collection (Bermejo to Goya).

He has curated exhibitions in Britain, Spain, Italy, and Belgium and he has written catalogues and scholarly articles on Velázquez and Zurbarán, on Italian Baroque painting, on religious iconography, and on Picasso.



Sir Jeremy Fleming KCMG CB, Director, GCHQ

Sir Jeremy Fleming is the Director of GCHQ, the UK's Intelligence, Cyber and Security Agency. He was appointed in 2017 and is the 16th person to hold the role.

After an early career in the financial sector, Jeremy joined MI5 in 1993. He gained extensive operational, investigative and leadership experience across the full range of national security work. He helped shape MI5's response to the London terrorist attacks in 2005, led the revision and publication of the Government's counter-terrorism strategy, CONTEST, and was promoted to Assistant Director General to lead MI5's preparations for the London 2012 Olympics. He then spent four years as Deputy Director General with responsibility for all investigations and operations.

In GCHQ, Jeremy has overseen the creation of the National Cyber Security Centre with a mission to make the UK the safest place to live and do business online. It has become a world leader in bringing together Government, industry and international partners to address cyber threats and inform the public.



Air Vice-Marshal Paul Godfrey OBE (RAF)

Air Vice-Marshal Paul Godfrey is a senior Royal Air Force officer, who serves as the first commander of the UK Space Command. Godfrey was commissioned into the Royal Air Force on 9 May 1991. After serving as a Harrier Jump Jet pilot, he became station commander at RAF Lossiemouth in November 2015. In February 2021 it was announced that he would

become the first Commander, United Kingdom Space Command. In taking up the post he will be promoted to the rank of Air Vice-Marshal.



Andrew Griffith MP (CON)

Andrew Griffith is a former senior media executive who has been the Member of Parliament (MP) for Arundel and South Downs since 2019. A member of the Conservative Party, he has been serving as Economic Secretary to the Treasury since October 2022. He was appointed Parliamentary Under-Secretary of State for Exports in July 2022 and served until September 2022. Griffith previously was Director of the Number 10 Policy Unit from February 2022 to July 2022.



Rt Hon Greg Hands MP (CON)

The Rt Hon Greg Hands is the Conservative MP for Chelsea and Fulham, and has been an MP continuously since 5 May 2005. He currently holds the Government post of Minister of State (Department for International Trade).



Rt Hon Chris Heaton-Harris MP (CON)

The Rt Hon Chris Heaton-Harris is the Conservative MP for Daventry, and has been an MP continuously since 6 May 2010. He currently holds the Government post of Secretary of State for Northern Ireland.



Kayla Lucero-Matteucci (Marshall Scholar 2021)

Kayla is a researcher based jointly at Cambridge's Centre for the Study of Existential Risk and Leverhulme Centre for the Future of Intelligence. Michael Mosbacher is Associate Editor (Comment) of the Daily Telegraph. He edited and co-founded two impactful and innovative London based magazines of ideas, The Critic and Standpoint. In 2019, as Editor and Publisher, he launched The Critic. Bringing together some of the most renowned conservative intellectuals, writers, and authors, he created a magazine that made political, cultural, and artistic ideas engaging and accessible to the intelligent reader.

In 2008, Mosbacher was a co-founder, and latterly Editor of Standpoint magazine, which grew into an influential mainstay of modern conservative thought in Britain and a bridgehead for American voices into the British debate. Rt Hon Penny Mordaunt MP (CON)

Penny Mordaunt has been Leader of the House of Commons and Lord President of the Council since September 2022. A member of the Conservative Party, she has been Member of Parliament (MP) for Portsmouth North since May 2010. She served as a junior minister under Boris Johnson, having previously served in Theresa May's Cabinet as Secretary of State for International Development from 2017 to 2019, and as Secretary of State for Defence from May to July 2019.



Hans Pung (Marshall Scholar 1995), President, Rand Europe

Hans Pung is president of RAND Europe, a not-for-profit public policy research organisation that helps improve policy and decisionmaking through research and analysis. With offices in Cambridge (UK), and Brussels (BE), RAND's staff undertakes empirical studies for public, private, and third sector clients on a diverse range of policy issues including innovation, science, health, social policy, defence, home affairs, and infrastructure.

Pung joined RAND as a policy analyst in 2002 and continues to lead and deliver research projects, particularly around industrial economics and security policy issues. He has held a range of senior leadership positions in RAND Europe, including directing RAND's European defence and security research portfolio as well as heading RAND Europe's efforts to grow and diversify into new research areas.

First Lieutenant Katherine "Katie" Scheibner is a 2020 Marshall Scholar and Cyberspace Effects Operations Officer in the United States Space Force. She is a Distinguished Graduate of the United States Air Force Academy (2020), University of St Andrew (2021), and University of Oxford (2022).



Sir Nigel Sheinwald GCMG, Chair, Chatham House

Sir Nigel served for nearly four decades in the British Diplomatic Service. He was ambassador to the US (2007-12), foreign policy and defence adviser to the UK prime minister (2003-07), and ambassador to the EU (2000-03). He also served as the UK prime minister's special envoy for international data

sharing (2014-15). He is a non-executive director of Invesco, an asset management company, and of Oxford Instruments plc. He is also a senior adviser to Universal Music Group and Tanium, a cyber security company, a Governor of the Ditchley Foundation and member of the advisory board of the Centre for European Reform. David Schwimmer, CEO, London Stock Exchange Group

David Schwimmer is Chief Executive Officer of London Stock Exchange Group and a member of the Board of LSEG plc. Prior to joining the Group in August 2018, he spent twenty years at Goldman Sachs where he held a number of senior roles, most recently as Global Head of Market Structure and Global Head of Metals & Mining. During his tenure, he also served as Chief of Staff to

Lloyd Blankfein, who was then President and COO of Goldman Sachs, and also spent three years in Russia as Co-Head of Russia/CIS. Prior to joining Goldman Sachs, he practiced law at Davis Polk & Wardwell.



Sir Martin Sweeting OBE FRS FREng FIET FRAeS, Executive Chairman of Surrey Satellite Technology Ltd

Sir Martin is founder and Executive Chairman of Surrey Satellite Technology Ltd (SSTL). He has pioneered rapid response, low-cost and highly-capable small satellites utilizing modern terrestrial COTS devices to 'change the economics of space' that stimulated the so-called 'Newspace'

initiative. SSTL has designed, built, launched and operated in orbit 61 nano, micro, and mini-satellites—including the International Disaster Monitoring Constellation (DMC) and the first Galileo navigation satellite (GIOVE-A) for ESA and all the subsequent 34 navigation payloads for the operational European Galileo constellation.

In 2014, he was identified by the Sunday Times as one of the UK's top 20 most influential engineers and in Debrett's 2017 list of the 500 most influential people in the UK.



Rt Hon Mr Ben Wallace MP (CON)

The Rt Hon Mr Ben Wallace is the Conservative MP for Wyre and Preston North, and has been an MP continuously since 5 May 2005. He currently holds the Government post of Secretary of State for Defence.

The Archbishop of Canterbury, The Most Revd Justin Welby



The Most Revd Justin Welby was ordained in 1992 after an 11-year career in the oil industry. He spent his first 15 years serving in Coventry diocese, often in places of significant deprivation.

In 2002 he was made a Canon of Coventry Cathedral, where he jointly led its international reconciliation work. During this time he worked extensively in Africa and the Middle East. Archbishop Justin has had a passion for reconciliation and peace-making ever since.

He was Dean of Liverpool from 2007 to 2011 and Bishop of Durham from 2011 to 2012, before being announced as the 105th Archbishop of Canterbury in late 2012.

Xenia Wickett, Wickett Advisory



He has held a range of executive roles including as a specialist at Barclays Bank in international trade finance and as manager for the Corporate Bank European Currency Programme. In 1997 he moved to Barclays' Head




THE TIES THAT BIND

Every year, the Association of Marshall Scholars partners with Emerson College Polling Center to conduct a poll that highlights major current issues and public perceptions about US-UK ties. This year's report surveys American attitudes toward strategic alliances, international partnerships and overseas learning. The data—which found that 80 percent of Americans believe US-UK leadership is important for global security—comes just as the UK government is experiencing great political change with a new Prime Minister and a new King.


"Americans understand how critically important US-UK leadership is to global security," said Dr. Nell Breyer, executive director of the AMS. "The strong response to the war in Ukraine reflects our shared foundational values and mutual commitment to democratic norms. Which of the following countries do you think is the most valuable ally and strategic partner of the United States?







In your opinion, which of the following has the most significant influence on a strong alliance between the United States and the United Kingdom?

A NEW CLASS

Introducing the 2023 Marshall Scholars

The 40 winners of the 2023 Marshall Scholarships were unveiled by the British government in December. The recipients, considered among the most accomplished undergraduate university students and recent graduates in the United States, were chosen following an intense selection process. The 2023 class will begin graduate studies at universities across the United Kingdom next year, coinciding with the 70th anniversary of the scholarship.

This year's class includes accomplished authors, astrophysicists, a human rights advocate, and COVID-19 researchers, among other disciplines. Eighty-five percent of the 2023 class intend to pursue public service careers in the US following their time in the UK, including representatives from the US Military Academy and US Air Force Academy who will take up active-duty service upon completing their studies.

"Whether it is the War in Ukraine or global challenges from the effects of climate change, Marshall Scholars continue to work to help address global issues head on," said Dame Karen Pierce, British ambassador to the United States. "The British government is excited to support these future leaders of American society as they begin the next stage of their lives studying at some of the UK's top academic institutions."






