Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Israel, Rwanda,¹ scheduled for September 1 to 10, 2023, sponsored by American Israel Education Foundation.

You must complete a Member/Officer Post-Travel Disclosure Form and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. You must also report all travel expenses totaling more than \$480 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House Members may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$480] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

l Please be aware that the Committee's review of the proposed trip does not extend to either the security situation in the destination country or security related to foreign travel in general. Dear Chairman Guest and Ranking Member Wild:

I serve as the Chief Legal Counsel for the American Israel Education Foundation ("AIEF"). As you know, AIEF, a 501(c)(3) organization, sponsors congressional trips to Israel. This year, AIEF is planning to sponsor a trip for select members of the Congressional Black Caucus ("CBC") scheduled for September 1-10, 2023. This trip will include a special leg to Kigali, Rwanda, where the members will witness, first-hand, the impact of the special, strong and fruitful relationship between the State of Israel and the Republic of Rwanda. This leg of the trip is scheduled to take place between September 5-9, 2023.

To accommodate travel to Rwanda, AIEF is seeking to charter a flight, with this Committee's approval, that would allow the CBC members to travel in a cohesive group, without multiple flight arrangements and stopovers that would create security concerns and additional trip expense. Section 305.1 of the Travel Regulations issued by the U.S. House of Representatives Committee on Ethics provides that approval for charter air travel must be sought in writing and approved by the Committee prior to the trip if the trip sponsor demonstrates, among other things: 1) "that the cost of such travel does not exceed the cost of available business-class transportation;" 2) "genuine security circumstances require such travel; (3) "the scheduled travel time, including airport layovers and change of planes, is in excess of 4 hours from takeoff to landing...;" or (4) "the flight begins before midnight and lands after 5 a.m. the following day." Here, several of these factors are met, justifying approval for charter air travel.

The estimated cost for a round-trip ticket on a commercial airline from D.C. to Tel Aviv is approximately \$10,000 per passenger. The estimated cost of a round-trip ticket from D.C. to Tel Aviv to Kigali to D.C. can range anywhere from \$13,000 to \$20,000 per passenger depending on when the ticket is purchased (which is, in turn, dependent on when members confirm their participation in the trip). If a charter flight to Kigali were added, the estimated additional cost per passenger would be \$8,072. This added charter flight would allow the members to travel from D.C. to Tel Aviv, from Tel Aviv to Kigali, from Kigali to Tel Aviv, and then from Tel Aviv back to D.C., for an estimated total cost of \$18,072 per person, which would be within the aforementioned estimated cost range for a round-trip ticket from D.C. to Tel Aviv to Kigali to D.C.

There would indeed be serious security concerns if the members were required to travel via commercial flights for the Kigali leg of the trip, as it would not be possible for the entire delegation to travel together as a unit on any of the flights. To accommodate this group on a commercial airline, the members would need to \(\frac{251 \text{ H Street NW}}{\text{Washington, DC 20001}} \)

be split among four or five different airlines for each leg of the trip, each landing at different times with different stops along the way. There are no direct or Tax ID# 5

indirect commercial flights that would accommodate the entire group at once. The various factions would need to make stops in Istanbul, Turkey and Entebbe, Uganda, which would create additional security risks. A charter flight, on the other hand, would allow the entire group to remain together and to travel back and forth from Tel Aviv to Kigali without any stops. If the Committee approves the charter flight requests, the members flights would be limited to a total of four flights ((1) D.C. to Tel Aviv; (2) Tel Aviv to Kigali; (3) Kigali to Tel Aviv; and (4) Tel Aviv to D.C.). However, if the group were required to fly commercial airlines, there will be at least seven different flights, including five between Tel Aviv and Kigali and back given the various layovers.

These various layovers would create additional travel time, in excess of 14 hours from takeoff to landing from Tel Aviv to Kigali and Kigali to Tel Aviv. Furthermore, if the members were required to travel from Kigali back to Washington, D.C., the shortest commercial itinerary would be 23 hours and 25 minutes on Brussel Airlines, departing 8:05 pm from Kigali on September 9 and arriving 1:30 p.m. in Washington, D.C. on September 10. Thus, the flight time would "begin before midnight and land after 5 a.m. the following day."

Given the totality of circumstances, we respectfully request that the Committee grant AIEF's request to charter a flight for the members of the CBC from Tel Aviv to Kigali and from Kigali back to Tel Aviv. Chartered flights for this leg of the trip would remain within the same range of estimated costs of commercial airline flights, reduce security concerns related to multiple layovers on various flights and reduce overall travel time.

AIEF is currently in the process of negotiating with a chartered flight company to reserve a private plane in the event this Committee approves its request. Given the demand for chartered flights, the charter company will only hold our request for a limited period before the plane is forfeited to another potential customer. Therefore, we respectfully request that this Committee respond to, and hopefully approve, our request within one (1) week of the date of this later so that AIEF may reserve a chartered plane for this trip.

The Old City of Jerusalem is home to the holiest shrines of the three monotheistic religions, including the Temple Mount, the Church of the Holy Sepulchre, and the Al-Aqsa Mosque. The Holy Basin is the historic location of Jerusalem and refers to the land surrounding the Old City, including the Mount of Olives, believed to be the departure point for Jesus' final entry into Jerusalem and the cemetery where Jews have been burying their dead for 2,500 years. The Holy Basin also includes the Western Wall, Judaism's holiest site, and the Temple Mount (Haram al-Sharif), sacred ground for Jews, Muslims, and Christians. Control over these sensitive areas remains among the largest disputes in the Middle East. The professionally guided survey will walk through all of these sites and others, educating trip participants on their historical impact and their role in today's political discussions.

Jerusalem's City of David, more than any other site, represents the complexity of the Arab-Israeli conflict. The City of David is the site most archeologists agree to be the ancient city of Jerusalem that later became the capital of the united Israelite tribes under King David. This area is one of the most intensively excavated sides in the wider region. To Jewish Israelis, the site represents the beginning of their physical and emotional attachment to Jerusalem that has continued for over three thousand years. At the same time, much of the site is located in the predominantly Arab neighborhood of Silwan. The residents of Silwan, and the Palestinian Authority leadership are opposed to the archeological efforts being carried out in the City of David. In several instances, homes in Silwan were purchased and then destroyed to open up more areas for excavations. Palestinian leadership has denied the existence of any Jewish connection to Jerusalem.

Dinner with Jonathan Kamin, Mission Director, USAID in Rwanda

Jonathan Kamin will share the history of the USAID Mission in Rwanda, the tremendous progress made in the country, and challenges and opportunities for Rwanda today. The mission was established in 1964, a few years after the establishment of USAID in 1961 and Rwanda's establishment as an independent republic in the same year. The early decades of U.S. assistance focused on health, sanitation and rural development — with agriculture and nutrition programs at its core. As Rwanda's largest bilateral donor, the United States has helped support the agriculture-led poverty reduction the country has seen over the past 15 years- from around 60% to around 40%. Rwanda has achieved remarkable declines in maternal and under-five mortality over the past decade, demonstrating the highest average annual rates of reduction among the 75 countries where more than 95 percent of maternal and child death occur. Rwanda has achieved remarkable success in increasing access to education, with primary school net enrollment standing at 97 percent. USAID/Rwanda's current programs seek to build on these successes, and do so in four key areas: health, economic growth, education, and democracy and governance.
