



Dear Colleague:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to United Arab Emirates,<sup>1</sup> scheduled for December 7 to 11, 2023, sponsored by the Climate Solutions Foundation.

You must complete a Member/Officer Post-Travel Disclosure Form and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. You must also report all travel expenses totaling more than \$480 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House Members may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$480] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

Visiting the Barakah Nuclear Energy Plant will provide Members of Congress with a first-hand look at the UAE's energy transition and is tied directly to United States nuclear technology. The construction and use of this plant will contribute greatly to the UAE's diversification of energy sources and is a step toward meeting their international commitments for emissions reductions under the Paris Agreement on climate change.

The Barakah Nuclear Energy Plant is located in the Al Dhafra of the Emirate of Abu Dhabi on the Arabian Gulf. The Plant's four APR1400 design nuclear reactors will supply up to 25% of the UAE's electricity needs once fully operational and are expected to prevent up to 22 million tons of carbon emissions every year. In 2015, with the start of construction of Unit 4, the Barakah Nuclear Energy Plant became the world's largest nuclear energy construction site with four identical reactors being safely constructed on one site.

The reactors at the Barakah plant are adaptations of Westinghouse Designs, based in the United States, that are licensed to South Korea. Through the UAE's competitive procurement process, South Korea won the contract to build the reactor in Abu Dhabi. This is one of the first examples of the United States losing control of its own nuclear technology.

The United States's bid did not win in a nuclear procurement process that the UAE created based on the United States's licensing program. The UAE completed construction of the reactors at a lower cost and faster than reactors can be built in the United States. The goal of this site visit would be to learn about the UAE's regulations, construction techniques, and global competition for reactor technologies. Our Bipartisan delegation will be brought in to tour the facility and learn

The Climate Solutions Foundation's (CSF) mission is to bring together elected officials, scientists and academics, and corporate and trade executives to move action on climate change forward. We do not support any specific climate legislation. With this in mind, we have found that bringing Members to the local of global climate dialogues is an invaluable experience, which is why we seek to bring a bipartisan group of Members of Congress to Dubai, UAE for the United Nations Climate Change Conference (COP28) for the third year in a row. Like our programming in Sharm El-Sheikh, Egypt for COP27 and Glasgow, Scotland for COP26, our programming will consist of discussions and events focusing bipartisan climate solutions and the global green energy transition.

The United Nations selects a location for its annual climate change conference (UNFCCC, otherwise known as COP28). They selected Dubai, UAE to hold this year's event. The Climate Solutions Foundation (CSF) has brought two groups of bipartisan Members of Congress to the past two UNFCCC COPs located in Glasgow, Scotland in 2021 and Sharm El-Sheikh, Egypt in 2022. CSF has found the conversations with global leaders in a place dedicated to solely talking about and advancing a climate agenda to be invaluable. Additional events, such as the tour of the Jebel Ali L Power Station and dinner with a bipartisan group of global elected leaders, provide additional opportunities to compare how the United States' green energy transition and environmental laws compare to other countries. CSF found the experience at both COP26 and COP27 to be extremely valuable to the organization and it provided a great learning experience for the Members that attended.

COP28 will feature the first ever “Trade Day” intended to highlight the role trade policy can play in accelerating global decarbonization efforts. This comes during a moment of profound transformation for the global trading system. The EU CBAM, the world’s first carbon import fee on internationally traded goods, is now in its inaugural phase. Policymakers around the world are simultaneously exploring similar policies to bolster domestic industries and workers while lowering global emissions.

Meanwhile, the United States is making remarkable strides in emissions reduction. Our innovative free-market system, bolstered by record investments in new low-carbon technologies, has further elevated America's carbon efficiency advantage over most of the world. The case for leveraging this advantage to reward cleaner businesses and compel other countries to follow our lead has never been stronger.

The Climate Leadership Council (CLC) is an international research and advocacy organization whose mission is to convene global opinion leaders around new climate solutions based on a carbon tax and dividends. CLC is focused on exploring the transformative intersection of climate and trade and the opportunities it presents for U.S. climate, economic, and geopolitical objectives. This discussion will focus on America's carbon efficiency advantage over key trading partners and the opportunities to hasten global decarbonization using trade policy.

Agricultural methane emissions are primarily the result of livestock, farming practices, and rice production. Countries will not be able to meet ambitious goals to reduce global methane emissions without engaging the agricultural community and the bioeconomy. The U.S. Chamber of Commerce is co-hosting this conversation with the Biotechnology Innovation Organization (BIO) and the U.S. Department of Agriculture (USDA), convening companies with government officials to discuss the potential to reduce methane emissions from food and agriculture. Objectives of this conversation include bringing together companies to engage about research efforts around fermentation, feed additives, and/or wearables, building consensus around funding and policies to incentivize research and public-private partnerships to promote the innovation needed to reduce methane emissions, and exploring the possible FDA regulatory process and barriers.

The global stocktake, which is set to conclude at COP28, offers a chance for nations to reflect on progress made (or not made) toward Paris Agreement pledges. It also provides an updated assessment on the world's chances of limiting warming to well below 2°C.

Since the United States is a major emitter and plays a large role in the world economy, the nation's progress toward its own climate commitments will have major repercussions for the international community. With an

election year looming, how could the findings of the global stocktake, along with other emerging international actions, affect future US climate policy? And how might US climate policy in turn affect future international actions?

**Background:** In September this year, during the period of the UN General Assembly, the UAE released a discussion paper describing its concern over the growing challenge of water scarcity. In this publication, the UAE demonstrated that although water scarcity is a peer threat to other transnational threats such as climate change and global pandemic, it receives far less attention and far fewer resources are dedicated to its mitigation. The UAE is launching an effort to rally global support to raise awareness and channel greater resources to combatting this problem. A working level team from the Executive Affairs Authority (EAA) and the UAE Ministry of Foreign Affairs would like to meet and identify possible opportunities for cooperation.
