The imperative to reduce emissions has grown in urgency. Yet expectations of a simple linear global transition have been shaken as climate goals compete with concerns over how to deliver economic growth while ensuring energy security, energy access, and affordability. The multidimensional energy transition reflects different realities and timelines by region, technology, industry strategies, the variety of social and political approaches and divergent national priorities in an increasingly multipolar world. Opening plenaries will offer diverse perspectives from global government and energy leaders on the energy transition and what that means for climate change.

CSF’s mission is to bring together ideologically diverse Members of Congress and their staff, global leaders, and corporate and trade executives to discuss climate science, economics, and policy. By bringing Members of Congress to CERAWeek, CSF is working towards its mission of being a trusted space for dialogue that advances the agenda on climate.

Members will be joined by renewable energy executives to discuss how different types of hydrogen are being used in the multidimensional energy transition. Clean hydrogen produced with renewable or nuclear energy, or fossil fuels using carbon capture, can help to decarbonize a range of sectors, including long-haul transport, chemicals, and iron and steel, where it has proven difficult to reduce emissions. The purpose of this meeting is to discuss advancements in hydrogen technology and the feasibility of increasing production on a broader scale.
