The Members will learn how the Casa Alitas program is sustained by an inter-denominational network of faith collaborators and interorganizational partnerships with federal, state, and municipal government agencies; universities and colleges; and other non-governmental organizations. The humanitarian aid project is committed to helping legally processed asylum-seekers in Tucson, Arizona. Migrant families arrive at the shelter after recent release from ICE and Border Patrol detention. Volunteers offer hospitality; housing, food, clothing, toiletries, advocacy, and travel assistance. Casa Alitas provides comfort and safety while guests await their journey, and prepare to reunite with loved ones across the country.
