

Dear Colleague:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your and your spouse's proposed trip to Australia,¹ scheduled for May 25 to June 1, 2024, sponsored by Aspen Institute, Inc., Breakthrough Energy Foundation, and Climate Imperative Foundation.

You must complete a Member/Officer Post-Travel Disclosure Form and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. You must also report all travel expenses totaling more than \$480 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House Members may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$480] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

¹ Please be aware that the Committee's review of the proposed trip does not extend to either the security situation in the destination country or security related to foreign travel in general. We recommend you contact the Office of House Security (OHS) for a safety and security briefing prior to your departure. OHS may be reached at (202) 226-2044 or ohsstaff@mail.house.gov. House travelers should also register for the U.S. State Department's Smart Traveler Enrollment Program at <https://step.state.gov>.

Question 15-B-1: Detail the cost per day of meals (approximate cost may be provided.):

The daily cost of meals is \$85. This amount reflects the cost of the daily dinner. The accommodation costs include breakfast. The daily meeting fee includes lunch and snacks. The dinner costs are \$40 over the dinner per diem of \$45 for Sydney and \$43 over the dinner per diem of \$42 in Canberra. Food costs increases are the reason behind these expenses, but it is a cost that is reasonable and necessary.

Question 18: Total Lodging Expenses per Participant

The nightly room rate in Sydney is \$319. Participants land in Sydney beginning at 6:05 am on May 27 through 8:10 am. Check in is not available until 3 pm. An early check-in fee was paid to guarantee participants could check-in upon arrival, prepare for meetings on May 27, and for security purposes. On June 1, for the participants departing on the late evening flights, a late check out fee was paid to allow them to have access to their rooms for purposes of security until they depart for the airport to return to the U.S.

On May 30, participants travel in mid-afternoon from Sydney to Canberra, the capitol of Australia, to meet with Australian senior government officials and U.S. Embassy officials. The group overnights in Canberra, returning to Sydney the following afternoon. This 24-hour visit required maintaining the room block space in Sydney, and at the same time, providing a hotel room for one night, May 30, in Canberra for participants. These costs are reflected in the total hotel costs for participants.
