



Response to Question 12

The Center for Economic and Policy Research (CEPR) was established in 1999 to promote democratic debate on the most important economic and social issues that affect people's lives. In order for citizens to effectively exercise their voices in a democracy, they should be informed about the problems and choices that they face. CEPR is committed to presenting economic and foreign policy issues in an accurate and understandable manner, so that the public is better prepared to choose among the various policy options. Toward this end, CEPR conducts both professional research and public education.

The Congressional trip to Bogota, to participate in the Pan American Parliamentary Congress, fulfills this mission by providing members of the US Congress with an overview of, and a variety of perspectives on, the challenges that Latin American countries face in the areas of democracy and human rights, peace and climate. CEPR is the trip's sole organizer and sponsor.

Response to Question 15 b. (2)

CEPR determined that the Pan American Congress should be held outside of the United States given the goal for US Members to listen and learn from their parliamentary counterparts. Bogotá was selected as the concluding site of CEPR's August 2023 delegation and a convenient location for participants traveling from across the Americas. Subsequently, CEPR engaged with a range of local stakeholders and found there to be interest in participation in the Congress.

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Colombia,¹ scheduled for August 2 to 6, 2024, sponsored by Center for Economic and Policy Research. We note that this trip includes one day at your personal expense.

You must complete a Member/Officer Post-Travel Disclosure Form and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. You must also report all travel expenses totaling more than \$480 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House Members may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$480] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

¹ Please be aware that the Committee's review of the proposed trip does not extend to either the security situation in the destination country or security related to foreign travel in general.
