



Dear Colleague:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your and your spouse's proposed trip to Isle of Palms, South Carolina, scheduled for March 28 to 30, 2025, sponsored by International Conservation Caucus Foundation.

Committee travel regulations require that you submit your complete pre-trip approval request to the Committee at least 30 days before the commencement of the trip or it will not be granted. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

March 28-30, 2025

Isle of Palms, SC

Friday, March 28th

13:00 - 17:00 Participants depart from Washington, DC and arrive throughout the afternoon at Charleston International Airport

18:00 - 20:00 **Welcome Reception: Circularity in International Business**

ICCF will host local international business leaders for a welcome reception highlighting circularity and sustainability in supply chains. Conference participants will have the opportunity to meet business leaders and learn about their sustainability initiatives and will hear from experts in corporate sustainability policy about circular economy and the obstacles companies face to achieve their circularity goals.

These discussions will inform participating members' work through the International Conservation Caucus on sustainability in supply chains.

09:00 - 09:30 **Breakfast Briefing with John Gantt, CEO of the ICCF Group and President of ICCF**

John Gantt will present on the work of ICCF and the International Conservation and Oceans Caucuses since the organization's founding. He will also brief participants on the expansion of the caucus model, through the ICCF Group, around the world, including in the UK, Africa, Asia, and Latin America. With parliamentary conservation caucuses in 20+ countries, the ICCF Group is at the forefront of building political will to improve conservation governance by educating U.S. and international policymakers, facilitating public-private conservation partnerships, and providing on-the-ground conservation solutions.



Through this discussion, participants will review past successes to build upon and identify potential areas for collaboration with international lawmakers through ICCF Group-supported caucuses.

09:30 - 11:30

Briefing and Strategy Session – The U.S. Foundation for International Conservation and the Future of International Conservation

ICCF staff will provide an update on implementation of the U.S. Foundation for International Conservation Act, signed into law at the end of the 118th Congress, and the status of foreign assistance for international conservation.

Under the USFICA, the Secretary of State is tasked with establishing the new, nonprofit U.S. Foundation for International Conservation within 180 days of enactment. The USFIC will provide federal grants to match private and nonfederal investments in public-private partnerships on a 1:2-basis (public:private), supporting “responsible management of designated priority primarily protected and conserved areas in eligible countries that have a high degree of biodiversity or species and ecosystems of significant ecological value.” Once established, the USFIC must develop a plan of action within six months.

Mismanaged protected areas, especially in Africa, Latin America, and Southeast Asia, can be a haven for not only poaching and habitat destruction, but also gangs, drug cartels, and terrorist networks that foster regional violence and instability. By funding effective management of protected and conserved areas over the next decade, driving good governance and inclusive development, the USFIC will serve as a vital tool for the United States to repel the influence of malign actors in the developing world.

International Conservation Caucus co-chairs will then lead a discussion to identify strategic objectives for work in the 119th Congress to ensure foreign assistance for international conservation makes the United States more secure, stable, and prosperous.

Reconvene and transfer to Center for Birds of Prey



14:00 - 16:00

Site Visit: Center for Birds of Prey and Avian Medical Clinic

Participants will have the opportunity to learn more about key avian species as they follow natural paths accentuated with subtle interpretive signage and aviaries housing nearly 50 species of eagles, falcons, hawks, owls, kites, vultures and other birds of prey from all parts of the world.

The Avian Medical Clinic operates 365 days a year and currently admits between 800-1000 patients each year, representing a variety of birds of prey and shorebird species with injuries ranging from minor to critical.

Constructed with a grant from U.S. Fish & Wildlife Service and South Carolina Department of Natural Resources, the Center's combined use Avian Medical Center / SC Oiled Bird Treatment Facility was completed in October 2007 and is the only permanent avian treatment center of its kind on the Eastern seaboard.

Throughout the visit, participants will learn about the importance of avian species and the ecosystems they live in, as well as threats to these species and their environments, which will inform their work as members of the International Conservation Caucus.

Keynote Discussion and Dinner: Conservation and National Security

Monica Medina, former Assistant Secretary of State for Oceans and International Environmental and Scientific Affairs and U.S. Special Envoy for Biodiversity and Water Resources at the U.S. State Department, and Mark Green, former Administrator of the U.S. Agency for International Development, will lead a discussion of the role of good natural resource management and efforts to combat environmental crime in fostering peace and security.

Communities across the globe depend on nature for vital ecosystem services: clean air and clean water, food, energy, medicine, and resilience against extreme weather and disease. The loss of and resulting



competition for scarce natural resources often impact vulnerable populations the hardest, producing desperate circumstances that can lead to and exacerbate conflict and insurgency. Competition over critical natural resources has been a constant driver of conflict throughout history. Over the past 60 years, 40 percent of civil wars can be associated with natural resources. Since 2010, violent civil conflict has tripled, and forced emigration has reached a record high. In a vicious cycle, conflict also often drives mass displacement, puts added pressure on neighboring regions, and can catalyze international mass migration.

Breakfast Briefing and Strategy Session – Promoting International Food Security and Combating Deforestation to Advance U.S. Security Interests

ICCF staff will lead a discussion of the links between conservation, agriculture and forestry, food security, and security. Land degradation includes soil erosion, salinization, pollution, nutrient depletion, and loss of soil fertility, and is often driven by agricultural expansion, deforestation and biodiversity loss, increasing human and livestock populations, and unsustainable use. Up to 50 million people are on the brink of famine, and over 13 million children suffer from severe malnutrition. These dire conditions can lead to mass migration, conflict, and insurgency, requiring international intervention. In a cyclical scenario, war also impacts global food systems. Improved food systems and agricultural practices can help countries become more food independent and less reliant on global food supply chains.

The illegal extraction of resources, including forest products, is not only an environmental issue but often goes hand-in-hand with other illegal activities, including money laundering, human and drug trafficking, labor abuse, and terrorism. Proceeds from this illicit trade can help finance transnational criminal organizations and militant groups, often with ties to U.S. adversaries. Illegally extracted resources also undercut legal markets, competing with companies that abide by widely accepted regulatory frameworks and laws.

International Conservation Caucus co-chairs will then lead a discussion to identify strategic objectives for work in the 119th Congress and the role that



the caucus can play in addressing these natural resource management issues.

Dear Representative Cuellar,

We are pleased to invite you and an accompanying family member to attend the International Conservation Leadership Conference in Isle of Palms, South Carolina from March 28-30, 2025.

As a co-chair of the International Conservation Caucus, you're invited to hear from leading international conservation experts, identify and debate priorities, and work to build bipartisan consensus around issues of international conservation as you strategize a path forward for the 119th Congress. Participants will also have the opportunity to see conservation at work, and the two-day conference will cover a range of topics from innovations in conservation finance to national parks and protected areas, forest conservation, sustainable agriculture and food security, and sustainability and circular economy.

We will share a more detailed agenda in due course, as well as provide required private sponsor travel forms. Trip expenses, including transportation, lodging, meals, and associated fees will be covered by ICCF.
