

Dear Colleague:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to the United Kingdom,¹ scheduled for May 8 to 11, 2025, sponsored by Reaction Digital Media Ltd.

You must complete a Member/Officer Post-Travel Disclosure Form and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. You must also report all travel expenses totaling more than \$480 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House Members may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$480] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

¹ Please be aware that the Committee's review of the proposed trip does not extend to either the security situation in the destination country or security related to foreign travel in general. We recommend you contact the Office of House Security (OHS) for a safety and security briefing prior to your departure. OHS may be reached at (202) 226-2044 or ohsstaff@mail.house.gov. House travelers should also register for the U.S. State Department's Smart Traveler Enrollment Program at <https://step.state.gov>.

THE UNITED STATES, THE WEST, AND ALLIANCES

Since the end of World War II, America's alliances have proved central to promoting U.S. and Western interests around the world. They helped the United States avoid direct military confrontation with the Soviet Union; they continue to boost regional stability in Europe, Asia, Latin America, and elsewhere; and they enable the West to promote and defend democratic values.

America's alliances date back to the American Revolution (when the colonies signed [treaties with France](#)) but – until the end of World War II – its alliances were generally temporary. For 150 years, the nation largely followed the advice of George Washington, in his Farewell Address of 1796, to “steer clear of permanent alliances.” The United States worked with other nations when necessary, but it had no permanent military establishment or permanent military commitment to any other country. Even after leading the Allies to victory in World War I, the United States did not join the League of Nations and instead returned to its traditional global posture.

After World War II, however, the United States and its Western allies found themselves facing a new global threat from an aggressive and expansionist Soviet Union. At that time, Great Britain, France, and the other traditional European powers were exhausted by war – with their economies barely functioning, their infrastructure in ruins, and their people suffering from hunger and homelessness. Only the United States had the means to prevent the Soviets from expanding across Europe and elsewhere. In response to the challenge, and in bipartisan fashion, America's leaders helped create a series of multilateral alliances in Europe, Asia, and Latin America to promote Western interests.

[NATO](#) was America's “first peacetime military alliance outside the Western Hemisphere.” The product of the North Atlantic Treaty of 1949, NATO arose in the aftermath of events that raised U.S.-Soviet tensions and prompted concerns about European security: the Soviets had helped engineer a communist coup in Czechoslovakia, and it then threatened Finland and blockaded West Berlin. In response to these and other developments, NATO was formed as a mutual defence agreement among the United States, Canada, and 10 European nations– with, under Article 5, a commitment by each ally to consider an attack on any one of them to be an attack on all. Over time, and especially after the Cold War, NATO expanded and now numbers [32 nations](#).

America's other major post-war alliances, however, stretch far beyond Europe. They [include](#) the RIO Treaty (crafted in 1947), the Organization of American States (OAS, 1948), the Australia, New Zealand, and United States Security Treaty (ANZUS, 1951), the Southeast Asia Treaty Organization (SEATO, 1954), and the North American Aerospace Defence Command (NORAD, 1958). The United States also has fashioned scores of military, diplomatic, commercial, and other alliances with individual nations or regional bodies like the European Union.

America's alliances have proven not just durable but extremely valuable:

- They are a “force multiplier,” enabling the United States and the West to increase the military force they can bring to the battlefield.
- They spur military, diplomatic, and economic cooperation across the West, which helps nourish regional stability and boost global economic growth.
- They encourage information sharing on military, intelligence, and other matters, better enabling the United States and the West to meet emerging threats.

THE UNITED STATES, THE WEST, AND ALLIANCES (cont.)

The United States and its NATO allies, for instance, conducted military strikes in the 1990s that brought peace to the Balkans, preventing a wider war in Europe. For the only time in its history, NATO invoked Article 5 after the terrorist attacks of September 11th. NATO allies then served side by side with their U.S. brothers-in-arms in Afghanistan, and the United Kingdom lost 457 soldiers while honoring its commitment to NATO and the United States. NATO also conducted military operations against Muammar Gaddafi's regime in 2011 to protect the Libyan people.

America's fiercest adversaries certainly understand the value of alliances, which explains why they are coming together to challenge U.S. supremacy. China, Russia, Iran, and North Korea have formed an alliance – which Western officials and experts have nicknamed **CRINK**, an “Axis of Upheaval,” and a “common market of autocracies” – that revolves around opposition to the U.S.-led West. Increasingly, these nations:

- Send troops to fight one another's battles,
- Share military weaponry,
- Conduct joint military drills,
- Build economic ties,
- Work together to evade Western sanctions, and
- Launch disinformation campaigns to shape the politics of Western nations.

These nations are increasingly working together through their own alliance, and they pose a serious threat to U.S. interests.

With its theme of “Alliances,” the London Defence Conference comes at a crucial moment in global affairs. The U.S.-led network of alliances is facing internal strains and even threats to its continued existence.

Calvin Bailey (Labour) serves as the Member of Parliament for Leyton & Wanstead, being first elected in 2024. Bailey served for 26 years in the Royal Air Force from 1999 to 2024, eventually earning the rank of Wing Commander. He served as a commander of Air Mobility forces during Operation Pitting, the United Kingdom’s efforts to evacuate British nationals and eligible Afghan allies from Kabul in 2021.

Bailey serves as the Chair of the All Party Group on the Armed Forces Community.

Alistair Carns (Labour) serves as the Parliamentary Under-Secretary of State for Veterans and People in the Labour Government, serving since July 2024. He serves in the Ministry of Defence. He is the Labour MP for Birmingham Selly Oak, first elected in July 2024.

Carns joined the Royal Marines at the age of 19 in 1999 and eventually rose to the Rank of Colonel. He served as a military adviser to three Secretaries of Defence. He resigned his commission to stand for election and then subsequently re-enlisted in the Reserves.

Fred Thomas (Labour) serves as the Member of Parliament for Plymouth Moor View, first elected in 2024. After graduation from University, Thomas joined the Royal Marines, where he trained in arctic warfare and worked in nuclear security. He left active duty in 2023 at the rank of Captain, and continues to serve in the Reserves.

In Parliament, he serves on the Defence Select Committee and is the co-chair of the All Party Parliamentary Group on Defence Technology, particularly focusing on defence technology modernization.

Dan Jarvis (Labour) was appointed Minister of State for Security at the Home Office on 6 July 2024. A Member of Parliament since 2011, Jarvis graduated from Aberystwyth University with a degree in International Politics and Strategic Studies before attending the Royal Military Academy Sandhurst. From Sandhurst, he was commissioned into the Parachute Regiment and subsequently deployed to Kosovo, Northern Ireland, Iraq and Afghanistan. His service included: Platoon Commander with 1 Para, Aide-de-Camp to General Sir Mike Jackson, and Adjutant 3 Para. On promotion to major, he worked as a staff planner in the Permanent Joint Headquarters and then at the Army’s Headquarters. He also served as a company commander in the Special Forces Support Group. Jarvis served in various shadow front bench roles between 2011 and 2015 before serving on the Joint Committee on the National Security Strategy between 2017 and 2019.



LORD CHRISTOPHER GEIDT

Christopher Geidt, Baron Geidt is a non-partisan member of the House of Lords. Lord Geidt served as Private Secretary to the Sovereign for Queen Elizabeth II from 2007 to 2017. As private secretary, he was the principal channel of communication between Queen Elizabeth II and the governments of the commonwealth over which she presided, and was one of the most senior members within the Royal Household. Lord Geidt served in the Intelligence Corps of the British Army, serving from 1987-1994. From 1994 until his recruitment to serve in the Royal Household in 2002, he served in multiple diplomatic posts in the Foreign Office.

Admiral Alan West, Baron West of Spithead has served as a Labour member of the House of Lords since 2007. He joined the Royal Navy in 1965 and spent the majority of his career at sea, serving in fourteen different ships, and commanding three.

He was promoted to Admiral in November 2000 when he became Commander-in-Chief Fleet, NATO Commander-in-Chief East Atlantic and NATO Commander Allied Naval Forces North. He led the United Kingdom's maritime response to 9/11 including the invasion of Afghanistan. In 2002, he was appointed as the First Sea Lord and Commander in Chief of the Royal Navy, a post he held until his retirement in 2006. He was also a member of the Defence Council and Admiralty Board as well as First and Principal Naval Aide-de-Camp to Her Majesty the Queen. From 2007 until 2010, Lord West served as Parliamentary Under-Secretary of State and Government Spokesperson at the Home Office with responsibility for Security, Counterterrorism and Police.

From 1979 to 1987, he represented South Dorset in the House of Commons, and in the 1990s, he was Leader of the House of Lords under his courtesy title of Viscount Cranborne. Lord Salisbury lives in one of England's largest historic houses, the 17th-century Hatfield House in Hertfordshire, and currently serves as Chancellor of the University of Hertfordshire.

Ellwood was in the Royal Green Jackets from 1991 to 1996, and served in Northern Ireland, Cyprus, Kuwait, Germany, Gibraltar and Bosnia. He is a current Army Reservist at the rank of Lieutenant Colonel. Tobias was a senior business development manager with the London Stock Exchange for two years, and then with Allen and Overy in a senior role.

He was appointed Minister for Business and Enterprise in September 2012 and Minister of State for Energy in March 2013. In 2014 he also became Minister for Portsmouth. He was appointed Defence Secretary on 15 July 2014 and served until 2017. He did not run for re-election in the 2019 election.



DR. KARIN VON HIPPEL

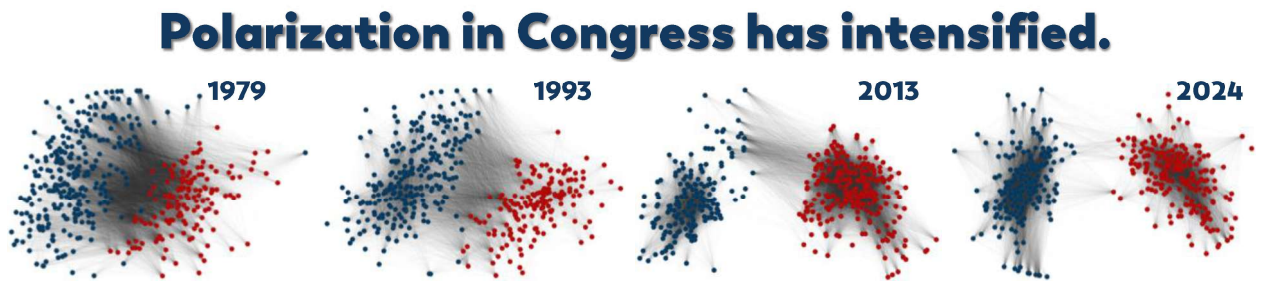
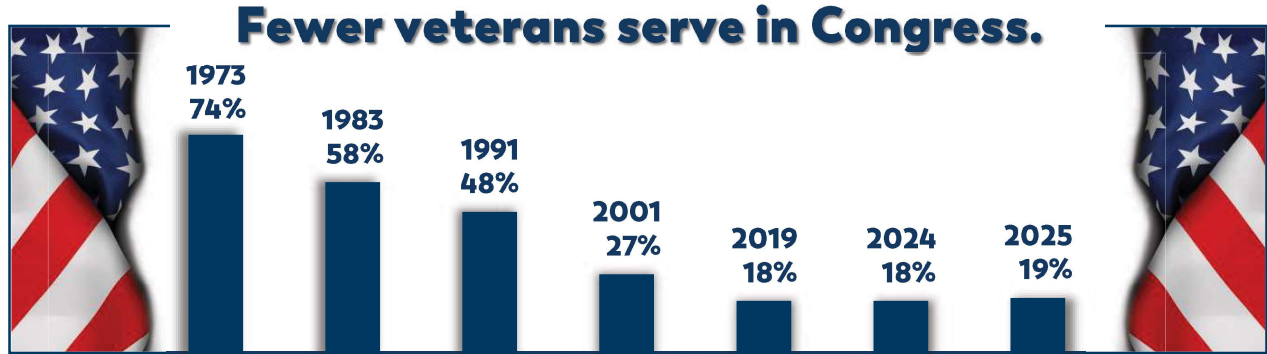
