



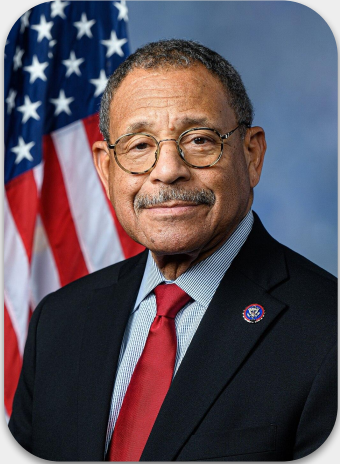

He has represented the Second Congressional District of Georgia in the U.S. House of Representatives since 1993.

Dr Homer Lee Wilkes is an American conservationist and former government official from Mississippi. He served as the first African American USDA Under Secretary for Natural Resources and Environment. Former Mississippi State Director for USDA Rural Development



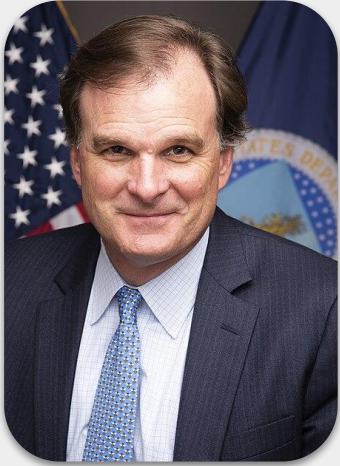

Robert Bonnie

Former Under Secretary for Agriculture for Farm Production and Conservation



During the Biden and Obama Administrations, Robert was Under Secretary for Natural Resources and Environment at USDA. Prior to joining USDA, Robert was vice president for land conservation at Environmental Defense Fund where he focused on developing incentives to reward stewardship on private lands. Robert lives with his wife, Julie, and daughter, Lilly, in Loudoun County, Virginia.

Basil Gooden

Former Under Secretary of Agriculture for Rural Development



Basil Ivanhoe Gooden is an American governmental executive whose career has advanced equitable food systems, agriculture policy, public health, and community economic development in rural America. Gooden served as the 3rd Virginia Secretary of Agriculture and Forestry for the Commonwealth of Virginia. He became the first Black American to serve in this position and during his tenure from September 2016 until January 2018, he was the only Black American Secretary of Agriculture in any state in the United States. In his capacity as Secretary, he provided strategic vision and leadership to two of Virginia's largest private industries, Agriculture and Forestry, with an annual economic impact of \$91 billion in Virginia.

Thaddeus Fairley

Former Mississippi State Director for USDA Farm Service Agency



Thaddeus Fairley, Sr. was appointed by the Biden Administration to serve as the State Executive Director of the USDA Farm Service Agency (FSA) in Mississippi in November 2021. Fairley is a certified nonprofit professional and native of Sunflower, Mississippi. Previously, he served as a Field Representative for Congressman Bennie G. Thompson. During his time with the Congressman, Fairley served as an expert on broadband initiatives and constituent services, including working on resolving issues for farmers. Prior to joining the Congressman's office, Fairley worked in the banking industry for over seven years.

Almost 7 months into the Trump Administration and nearly 50 percent of Project 2025 has been implemented. The changes have been swift and have required a response from the public sector at the local and state level as well as the private sector.

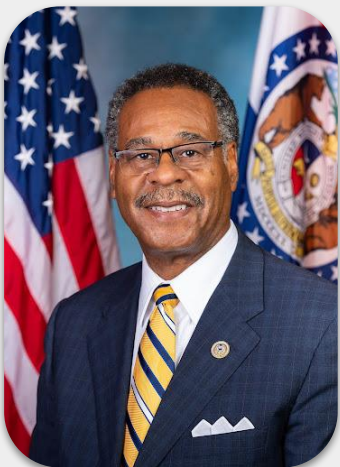

Opening Remarks by Attorney Scott Colom

On October 14, 2022, President Joe Biden nominated Scott Colom to serve as a United States District Judge for the Northern District of Mississippi to the seat vacated by Judge Michael Mills. A native of Mississippi, Mr. Colom has dedicated his life to justice in his home state with roles at the Mississippi Center for Justice, as a justice court judge in Lowndes County and the City of Aberdeen, as a private plaintiff-side attorney, and as the District Attorney of Mississippi's 16th District. He is serving as both the first Black justice court judge of Lowndes County and the first Black city prosecutor of his hometown of Columbus.
