

*Two historian-guided visits to globally significant parts of Old Town Geneva*

In a visit led by a historian from the ICRC and a Canton of Geneva official, the Members of Congress will be shown historic Hôtel de ville de Genève – Geneva’s City Hall – where the first Geneva Convention was signed in 1864. This signing occurred in the Alabama Room, named after a U.S. Civil War-related arbitration between the 6 States and Great Britain, which represents Geneva’s emergence as the world’s neutral meeting ground.

Another historian will guide the group through the Cathédrale Saint-Pierre, the spiritual center of Reformation leader John Calvin’s Geneva. From its pulpit, Calvin delivered thousands of sermons that transformed Western religious thought and governance, and bestowed Geneva with the nickname “the Protestant Rome.”





Dear Colleague:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your and your spouse's proposed trip to Switzerland,<sup>1</sup> scheduled for August 1 to 9, 2025, sponsored by the Ripon Society and the Franklin Center for Global Policy Exchange. We note that this trip includes three days at your personal expense.

You must complete a Member/Officer Post-Travel Disclosure Form and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. You must also report all travel expenses totaling more than \$480 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House Members may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$480] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.
