

Dear Colleague:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your and your spouse's proposed trip to Israel,<sup>1</sup> scheduled for February 16 to 23, 2026, sponsored by 12 Tribe Films Foundation.

You must complete a Member/Officer Post-Travel Disclosure Form and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. 
Because the trip may involve meetings with foreign government representatives, we note that House Members may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$525] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.



## **Itinerary, Congressional Educational Mission to Israel**

February 16-22, 2026

### **Day 1 February 16 Travel Day**

Depart NYC on El AL

1:30 pm Nonstop flight from JFK to TLV

### **Day 2 February 17 Beginnings**

5:35 am Arrive Tel Aviv - Transfer to Jerusalem

8:00 am Arrive and check in to the Orient hotel

11:00 - 11:30 am Meet hosts, 12 Tribe Films Foundation

Topic: Welcome briefing, review the trip's itinerary and introduction to Israel today.

Short overview of issues that will be discussed, from geopolitics to technologies to the IDF - .5 hour.

12:30 Depart for Prime Minister's office - business attire

1:30 - 2:45 pm Briefing with PM Benjamin Netanyahu

Topic: Iran, Gaza and more from the Middle East. Important meeting for the mission, for our guests, with the Prime Minister of Israel. 1.5 hours.

3:00 - 4:00 pm Depart and travel south - IDF Spokesman is the guide and host for this time.

Topic en route, while viewing the areas outlying - south of Jerusalem, approaching the Negev and southern flank of Israel towards Gaza: US policy in the Middle East, border issues.

A close view of the surrounding political neighborhood, as a prelude to work investigating American policy vis-a-vis the current ongoing war with Gaza and further questions of diplomacy with Israel's neighbors. One hour of briefing throughout the travel.

4:00 pm Arrive for visit to Southern Israel Sites - After October 7

A note for this southern visit: We believe that any visitor, particularly congressional leaders, must receive first hand witness to the beginnings of the war currently ongoing between Israel and Hamas.

4:00 - 5:00 pm Visit site of Nova, with IDF Spokesman

Topic: First line of defense on October 7, early hours of surprise breach of the border and resulting losses and responses. 1 hour.

5:00 - 6:00 pm Kibbutz Kfar Aza overlook to the nearby Gaza border

Topic: Detailed examination of the border with Gaza and its breach that began the current war. Critical analysis of the breach from Gaza that gives the basis for further congressional work regarding the questions of border and control. Survivors and families; civilian, military and police defenders; emergency responders. 1 hour.

6:00 -7:30 pm Shuva soldiers center

Topic: The civilian front of the war - How Israel met the needs of residents and soldiers. Volunteers and locals supporting the IDF soldiers in the field. Includes dinner. 1.5 hrs.

7:30 - 8:30 pm Return to Jerusalem - via the central Negev hills

Topic: Understand the main Israeli towns under fire and still largely evacuated, its inhabitants removed from their homes because of ongoing threat from Gaza. Return with hosts. 1 hour.

### **Day 3 Wednesday February 18**

8:45 am Depart for Government offices

9:30 - 10:30 am Briefing with Cabinet Minister Nir Barkat, Ministry of Economy and Infrastructure

Topic: The economics of the US-Israel relationship; future of US foreign aid versus bilateral cooperation. Explore possible new coordinated efforts to replace the current aid package. This hot topic is very relevant as a congressional issue, discussed now by both US and Israeli governments. 1 hour.

11:00 am Entrance to Knesset

11:30 am - 12:00 pm Visit special 1967 war room

Topic: Decision making under fire - audio visual presentation - .5 hour.

12:00 - 1:00 pm Meeting with Speaker of the Knesset Amir Ohana

Topic: Relationships between allies and parliaments, a special opportunity to forge cooperative efforts. Relevant elected officials with an opportunity to share the challenges of their parliamentary work. One hour.

1:00 - 2:00 pm Lunch in the Knesset with hosts

Topic: Israel and the PA - After Gaza: Challenges and opportunities for Stage 2.  
Presented by hosts, in light of voting schedule on Knesset floor. One hour.

2:15 - 4:15 pm Meeting with Members of the Knesset Amit Halevy - Security & Defense Committee; MK Ohad Tal - Public Affairs Committee; and Simcha Rothman - Chairman, Judiciary Committee.

Topic: The significance of international law on legislative initiatives.  
Participants include NGO representatives in these fields. Meeting is taking place as part of an ongoing series in the Knesset on international affairs, and Congressmen are invited to attend. There is no fee for attendance. 2 hours.

4:30 - 6:00 pm Geopolitical tour of Jerusalem

Topic: From 1948 to 1967 to today. A historical reader that presents the facts as Israel evolves from its beginnings to a modern metropolitan capital. This includes international pressures and decisions such as US recognition of Jerusalem as Israel's capital. Developing conversations on Jerusalem's place in any future resolutions in the region - 1.5 hours.

6:30 pm Dinner on own at First Station, Jerusalem

#### **Day 4 Thursday February 19 Borders and neighbors**

9:00 - 10:30 am Depart hotel for Jordan Valley region, Drive along Route 90

Topic: Regarding Israel's borders - Defensive strategies & challenges. A maps-open review with hosts of surrounding Middle East countries - in light of the Abraham Accords. Include President Trump's plans, Saudia Arabia & Qatar issues. With hosts. Very relevant to congressional work analyzing the situation on the ground in the region. 1.5 hours.
