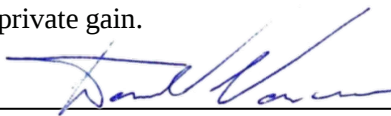

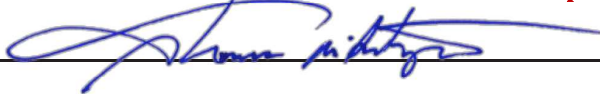

Several Members also have established relationships with members of the UK Delegation that will participate in the program, which the program is designed to help strengthen and expand upon.

15.b.2. Provide the reason for selecting the location of the event or trip

Oxford: Oxford was selected as the opening location for the delegation because it provides a focused, retreat-like environment conducive to substantive discussion and relationship building among participants. The city's academic setting allows for meaningful engagement with leading experts and scholars contributing to the program, many of whom are based at the University of Oxford and related institutions. Oxford is also home to a significant number of current Marshall Scholars studying in the United Kingdom, creating valuable opportunities for interaction between the delegation and scholars participating in the program.

London: London was selected as the second program location because it serves as the center of the United Kingdom's national government and diplomatic activity. Holding the London portion of the exchange there allows the delegation to participate in meetings with Ministers, Members of Parliament, government officials, and other institutional partners at Parliament and across Whitehall. The location also provides access to leading policy, cultural, and research institutions that support the program's broader focus on transatlantic cooperation and public policy engagement.

QUESTION #16 - Explanation of Cost of Oxford Hotel

While hotel rates in Oxford during the month of June are notably high due to limited hotel inventory and significant seasonal demand, the rate secured at the Old Bank Hotel represents a discounted group rate that is substantially lower than prevailing market pricing during the program period. Comparable centrally located hotels capable of

accommodating a delegation of this size were either unavailable or offered at similar or higher rates.

The Old Bank Hotel was selected because of its central location and operational suitability for the program. Its proximity to Oxford University colleges, meeting venues, dining locations, and transportation logistics significantly reduces the need for additional ground transportation and allows the delegation to move efficiently between scheduled engagements.

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your and your spouse's proposed trip to United Kingdom,¹ scheduled for June 11 to 15, 2026, sponsored by Association of Marshall Scholars.

Committee travel regulations require that you submit your complete pre-trip approval request to the Committee at least 30 days before the commencement of the trip or it will not be granted. Despite your failure to do so in this instance, we are approving your current request. However, any future requests should adhere to the 30-day requirement.

You must complete a Member/Officer Post-Travel Disclosure Form and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. You must also report all travel expenses totaling more than \$525 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House Members may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$525] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign
