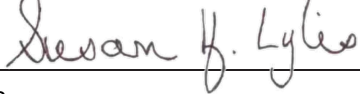

Dear Colleague:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Ecuador,¹ scheduled for August 7 to 14, 2026, sponsored by International Conservation Caucus Foundation and Gordon and Betty Moore Foundation.

You must complete a Member/Officer Post-Travel Disclosure Form and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. You must also report all travel expenses totaling more than \$525 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House Members may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$525] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

¹ Please be aware that the Committee's review of the proposed trip does not extend to either the security situation in the destination country or security related to foreign travel in general. Rafael will lead a tour of the island, renowned for its abundant seabird colonies, iconic yellow land iguanas, and Galápagos sea lions. The island represents a major conservation success through the reintroduction of land iguanas, led by the Galápagos National Park Directorate. Karl lives in the Galápagos Islands and has spent the vast majority of his career implementing island rewilding projects, primarily in Latin America. His interests include transforming human-wildlife conflicts through co-design of holistic solutions with communities, identifying, developing and deploying innovative solutions to reduce the costs and increase feasibility of projects, implementing financing mechanisms and taking projects to scale. He is now working with local partners on a ridge-to-reef rewilding initiative spanning the Pacific coast of Latin America, from Mexico to Chile. He will discuss importance of conservation finance and the world's largest debt for nature swap, which includes financing from the U.S.'s Development Finance Corporation.

12:20 - 13:20 Guided hike and briefing by Dr. Campbell and Naturalist Rafael

Floreana Island is home to 54 threatened species. The Floreana



Mockingbird, extinct on the main island, survives only on two small predator-free offshore islets. Re:wild is working with partners to remove invasive predators from Floreana and create conditions for the reintroduction of the Floreana Tortoise, the Floreana Mockingbird, and the recovery of other species including the Galápagos Petrel.

Dr. Campbell will highlight the important role of debt conversions to the biodiversity work in the Galapagos and the role of the Development Finance Corporation and other conservation finance mechanisms.

Lunch briefing with Dr. Campbell on the Floreana Restoration Project at Claudio Cruz's farm

Floreana Restoration Project is a proof of concept for the broader One Galápagos model: an island-wide approach that combines community priorities, sustainable livelihoods, invasive species management, and the recovery of native wildlife as part of a single, long-term restoration strategy. On Floreana, the project has worked closely with the local community to strengthen agricultural production and invest in durable infrastructure and improved management for cattle, pigs, and chickens—supporting local livelihoods and food production while resolving long-standing conflicts between farming and native wildlife. This work has helped establish the community, technical, and operational conditions needed to advance the eradication of invasive rodents and feral cats and, in turn, enable the reintroduction of 11 additional species that have disappeared from the island. Earlier this year, giant tortoises were returned to Floreana, marking the first major reintroduction in this new phase of recovery.

These efforts build on the earlier successful eradication of feral goats, donkeys, and pigs, after which the island's vegetation has continued to recover. Together, the results show that improving livelihoods and restoring ecosystems are not competing objectives: when designed together, they can reinforce one another and create the conditions for durable, island-wide recovery.

Claudio will brief the group on his experience and participation in the Restoration Project and how it has improved his business but also the quality and sustainability of his farm. Claudio will give a tour of the farm and show the different approaches incorporated into his farm to keep rodents and pests away from crops and improve livestock management.

Karl will brief the group on the details and stakeholders involved in the Galapagos' recent debt for nature swap, the world's largest to date. In 2023, with support from the Inter-American Development Bank (IDB) and the U.S. Development Finance Corporation (DFC), Ecuador completed a debt conversion that will allow the country to allocate resources for long-term marine conservation in the Galápagos Islands to promote greater sustainability and improve the quality of life of Ecuadorians.

To date, this is the largest debt-for-nature conversion completed in the world. The operation consists of an \$85 million IDB guarantee and a \$656 million DFC political-risk insurance to Ecuador to purchase existing public debt at better terms. This debt purchase with cheaper financing will generate lifetime savings of more than \$1.126 billion.

- 8:00 - 09:30 Breakfast briefing by Gustavo Jimenez, Principal Investigator of the Marine Bird Conservation Program at Charles Darwin Foundation

Gustavo has been part of the Charles Darwin Foundation since 2001. His work has focused on the health and welfare of the Galapagos endemic species. Understanding the dynamic population of Galapagos penguins, flightless cormorants, waved albatross, and flamingos, against their threats (pathogens, pollutants, introduced species, human interactions) is the main objective for the conservation of seabirds.

In addition, Gustavo is an advisor to the Galapagos National Park Directorate and the Galapagos Biosecurity Agency. Currently, he leads the monitoring of avian influenza in the Galapagos in collaboration with the ABG and DPNG.

- 09:45 - 11:45 Brief and tour of Española Island by Gustavo Jimenez

Española is the southernmost island of the Galápagos and is home to the Waved Albatross, one of many seabird species that faces threats including its restricted breeding range, incidental capture in longline fisheries, disease, and environmental change. These threats highlight the importance of coordinated conservation efforts such as the Agreement on the



Conservation of Albatrosses and Petrels (ACAP), a treaty that has been considered by the U.S. Senate Foreign Relations Committee but has not been ratified by the United States.

The visit to Española Island will highlight the importance of long-term monitoring of seabird populations and their health. Through sustained monitoring, researchers can detect changes in population status and emerging threats, allowing conservation actions to be adapted before declines become irreversible.

Karl will brief the group on the foreign fishing pressures that are often illegal, pollute local waters, and use unsustainable, indiscriminate fishing gear that harms birds and other marine life.

Massive, mostly Chinese-flagged fishing fleets have routinely swarmed the edge of the Galápagos Marine Reserve in international waters. Numbering up to 300+ vessels, the armada targets squid—a vital food source for endangered hammerhead sharks and fur seals. These vessels frequently disable tracking devices and oftentimes are engaged in other illegal activity such as labor abuses, shark finning, dumping and sometimes human, drug and arms trafficking.

SOUTHCOM has traditionally had partnerships with Ecuador to support maritime domain awareness initiatives primarily to deter drug trafficking which is oftentimes connected to other environmental crimes.

David will brief the delegation on the important role the legislative branch plays in creating sound natural resource management policies, such as the U.S. Foundation for Natural Security and Counterterrorism, that conserve the environment and ensure economic, food, and national security. He will also highlight global initiatives such as the G7's Nature and People's Finance Alliance that strengthen financing for nature protection, conservation and restoration by leveraging increased voluntary private sector engagement.

The mission of the Charles Darwin Foundation and its Research Station is to tackle the greatest threats and challenges to Galapagos through scientific research and conservation action, in order to safeguard one of the world's most important natural treasures.

Ambre will discuss the important history and impact of the Charles Darwin Research Station while highlighting current research and initiatives that are driving conservation efforts across the region.

*The delegation will visit the *Philornis downsi* laboratory to learn about one of the greatest threats facing Galápagos landbirds. The visit will highlight ongoing research on rearing the invasive fly for studies of its life cycle, ecology, and behavior, including experiments evaluating a host-specific biological control agent.*

The delegation will meet with Miguel Pinto, Head curator of the Galápagos Natural History Collections – the largest collection of Galapagos in Ecuador – who will discuss the historical importance of the scientific collections and showcase specimens representing endemic, native, and invasive species, highlighting the threats invasive species pose to the Galápagos and their implications. Current and relevant Charles Darwin Foundation research and conservation projects will also be presented in connection with the collections.

After tourism, the artisanal fishing sector is the second most important driver of the Galapagos Islands' local economy. More than 500 families depend on this activity, which supplies restaurants, cruise ships, and hotels, and feeds local people across the four inhabited islands. Artisanal fishing can generate \$10.5 million in gross revenue every year, and was the activity that revitalized the local economy following the COVID-19 pandemic.

The CDRS partners with fishermen to improve fishing practices, traceability, and management to help them gain access to alternate markets and charge more for their seafood products, advancing the



Galapagos blue economy. Representatives from the EmprendeMar Program will join the delegation for lunch and bring some of their product. This program was previously funded by USAID.

14:45 - 15:45 Brief by the Galapagos National Park Director, Lorena Sanchez

Lorena will brief the group on the role of the Park Service in Ecuador's maritime domain awareness. The delegation will see the command center where the Park Service can see all the boat activity in the Park and how they go about enforcing regulations and addressing IUUF.

Iniciativa Galápagos (known as the Giant Tortoise Restoration Initiative) is a collaborative effort led by Galápagos Conservancy and the Galápagos National Park Directorate (GNPD). The long-term goal of the initiative is to restore tortoise populations to their historical distribution and numbers across Galápagos, including on islands where tortoises went extinct. The program has many partnerships with U.S. zoos on species conservation and efforts around combatting the illegal pet and wildlife trade.
