### ***Tongass National Forest 2026 Fact-Finding Trip Itinerary August 15 - 21st, 2026***

**Mission Goals:** A fact-finding trip to visit Southeast Alaska and view the Tongass National Forest, learn about forest and land management planning, old-growth forests, regional economic drivers, and Alaska Native communities. Participants will have the opportunity to visit remote areas of the Tongass National Forest to gain firsthand knowledge on forest management regimes, salmon habitats, watershed health, and rural economies, and to meet with local stakeholders to learn more about local and regional policy issues.

**Relevance to Official Duties:** Congress and the Administration play a significant role in Alaska's land and natural resources policy due to more than 60 percent of its total land area being federally managed. As Members of Congress, Rep. Laura Friedman and Rep. Sarah Elfreth have legislative and oversight responsibilities concerning the Tongass National Forest and Southeast Alaska. This fact-finding trip will educate the Members on the economic, tribal, and natural resource management issues related to the Tongass National Forest and Southeast Alaska. They will gain firsthand knowledge to inform their decisions on legislation, appropriations, amendments, and other congressional actions.

**Location:** The purpose of travel to Juneau, Alaska is to gain hands-on experience in the Tongass National Forest to educate Members on the landscape's history, ecology, management, and the many local and Tribal communities that depend on it. The American Lands Project will also take Members to several locations outside of Juneau to meet with local and Tribal communities and visit various locations in the Tongass National Forest to learn about the diverse landscapes of the forest. Locations will include an Inventoried Roadless Area, salmon spawning streams and watersheds, and wildlife habitats that can only be accessed via boat or float plane.

**Introduction to Southeast Alaska**

Members will take a tour of downtown Juneau and the Juneau harbor led by SE Alaska guide Tim Bristol to learn about and observe the active tourism and cruise industry as well as the commercial fishing infrastructure in Juneau. The tour will demonstrate SE Alaska's complex economy, introduce the diversity of roles that the Tongass National Forest plays in the local economy, and inform participants on Juneau's role as a population center and marine hub in SE Alaska, in addition to serving as the Alaska State Capitol.

This tour will provide the Members with foundational information on the economic value of public lands in SE Alaska that is important for the rest of the trip. As Members of Congress, it is their responsibility, along with the administration, Tribes, and local communities, to oversee and steward federal public lands.

Participants will meet with the Hoonah Indian Association (HIA). HIA staff will present on forestry issues impacting their community and local economy as well as the history of forestry in Hoonah and its importance to the local community. HIA staff will lead participants on a tour of their current restoration projects in previously harvested areas of the forest surrounding Hoonah.

Alaska Native communities rely on and are stewards of the public lands and waters in SE Alaska, including the Tongass National Forest. In doing so, they partner with the U.S. Forest Service, Congress, and other government agencies. By hearing directly from Alaska Native leaders about issues of importance to them, Members of Congress are able to more fully understand these issues when they work on relevant legislation and other congressional actions.

The ALP Trip Leader and SE Alaska expert will give an introductory presentation on SE Alaska, the Tongass National Forest, and the geographies that the Members will observe during the remainder of the trip. The Tongass National Forest is the largest national forest in the country, totalling 16.7 million acres of land in Southeast Alaska, and is the traditional homeland of three distinct Alaska Native tribes: Tlingit, Haida, and Tsimshian. With much of the Forest consisting of remote islands and undeveloped areas, visiting by boat or air is the only way to view much of the Forest.

Congress often acts on legislation related to federal land management in Alaska and Alaska Native communities. An overview of the SE Alaska public lands, the Tongass National Forest, and the Alaska Native Tribes who live in SE Alaska offers the Members a baseline for understanding the region, the people, and the landscape.

Recreation and tourism on national forests generate billions of dollars in economic activity for local communities and support more than 150,000 jobs. Nearly 50,000 Alaskans depend on tourism for their livelihoods. The Members will hear directly from business owners in the small boat tourism sector of the tourism industry. Firsthand stories from small business owners will help inform decisions as Congress addresses legislation related to outdoor recreation and tourism businesses dependent on our public lands.

Participants will take an onshore hike to gain firsthand insights into salmon spawning habitat and salmon streams. During the hike, Members will learn about the economic value of healthy watersheds to salmon fisheries and harvests. Rivers, lakes, and streams in the Tongass National Forest produce 75% of the commercial

salmon harvested annually from SE Alaska. This harvest of about 40 million salmon is valued at \$68 million annually.

Observing an active salmon spawning stream gives the Members direct, firsthand knowledge of watershed health in the Tongass and its impact on salmon populations — evidence that briefings and written testimony alone cannot provide. Wild Alaskan salmon is a key economic driver for the region - providing jobs and resources for the Tribes and local communities - and are consumed across the United States and the world. When Congress considers legislation regarding fishing, wildlife and habitat, it is important that the Members understand the value of salmon and the rivers and streams on which they rely.

During lunch, House attendees will participate in a discussion on public lands in the State of Alaska. Topics will cover:

- Land management directives for resource development
- Recreation, conservation, and subsistence uses on tribal, state, and federal lands in the State of Alaska.

Distinguishing land-management authorities and permitted uses across tribal, state, and federal lands is essential background for Members evaluating any Alaska-specific public lands legislation.

Members will take an onshore hike to view Alaska's iconic wildlife. On the hike, the leaders will educate participants on how natural systems function in this landscape and the importance of the Tongass National Forest to salmon, grizzly bears, marine mammals, and other regional wildlife. Participants will observe the interactions between wild salmon and other Alaskan wildlife, and the guides will lead a discussion on the economic impacts of tourism and wildlife viewing in Alaska.

Wildlife is at the heart of SE Alaska's way of life. It is relevant to understand the wildlife species and how they relate to the region's outdoor recreation and tourism economy. Congress addresses a host of bills related to wildlife management and the

industries that depend on healthy populations of various species. Learning about, and observing firsthand, this interdependence provides the Members with valuable insight for when they make decisions on legislation and other congressional actions.

While underway, Members will listen to and participate in a short presentation by Ellen Wang, Tim Bristol, and Christine Smith, followed by a discussion on SE Alaska communities, the expansion of tourism into more remote parts of the Tongass National Forest, the role the Forest plays in the regional economy, and the economic challenges of seasonal employment in communities throughout the region.

There are many aspects of the tourism economy that should be considered when making policy decisions. It is important to understand the benefits as well as the challenges of the tourism industry. As Congress considers legislation that could impact the tourism sector, understanding both the opportunities and the challenges facing these communities can help to inform that work.

Regional economies shift over the years. In areas such as SE Alaska, it is imperative that the federal government engages with local communities and Tribes to identify land management directives and uses that benefit those who live in the region and beyond. This discussion will teach Members about the partnerships between the federal government, tribal communities, and local residents to help Members understand how federal lands can be managed in ways that are responsive to the unique needs of local communities.

While underway, Ellen Wang and Tim Bristol will educate participants on the current Tongass Land Management Plan (Forest Plan) and the U.S. Forest Service's efforts to update the Forest Plan. The current Forest Plan was developed in 1997, and a revision process for the Tongass Forest Plan, announced in 2023, is currently in progress. This conversation will include a discussion on the Forest Plan and the revision process currently in progress.

Bills related to land and resource management planning are regularly discussed and debated in Committees and on the House Floor. By gaining firsthand knowledge of the landscapes and land management directives in the Tongass National Forest, Members can make more informed decisions on related legislation or oversight actions.

Presentation and discussion led by Ellen Wang and Tim Bristol regarding the history and legislation that have shaped federal land ownership and land management practices in Alaska, focusing on the Alaska National Interest Lands Conservation Act of 1980 (ANILCA). Review the history and landscape-shaping impacts of ANILCA, which designated many of the National Park Service units in Alaska as well as wilderness areas, national wildlife refuges, and wild and scenic rivers across the state. ANILCA also established a priority for subsistence uses of fish and wildlife resources for rural residents of Alaska during times of scarcity. ANILCA is the foundation of federal land management in Alaska and is essential to understanding current discussions regarding resource management and utilization.

Federal public lands in Alaska are managed under a unique legislative framework based on ANILCA. Current Alaska-specific public lands bills are often related to ANILCA and its history. To help Members make informed decisions on these bills, they must understand this foundational legislation.

Presentation and discussion led by Ellen Wang and Tim Bristol on the Alaska Native Claims Settlement Act of 1971 (ANCSA). Presenters will review the history and key elements of ANCSA, which extinguished aboriginal land title in Alaska, divided the state into 12 regions based on the common heritage and shared interests of the Alaska Native people within each geographic area, and mandated the creation of for-profit entities - which Congress termed “Alaska Native Corporations” (ANCs) - tasked with promoting the social, cultural, and economic advancement of Alaska Native people and communities. This discussion will familiarize guests with the Alaska Native Corporations active in Southeast Alaska and the nuances of ANCSA.

ANCSA is another piece of unique Alaska legislation. Alaska Native Corporations are different from cultural structures found in the Lower 48. Since the passage of ANCSA, Congress has considered many legislative proposals that focus on amending ANCSA, making it important for the Members to understand the history of the legislation and the formulation and purposes of ANCs when making decisions about relevant policies.

Onshore hike led by Christine Smith and Tim Bristol. Participants will visit a designated Inventoried Roadless Area in the Tongass National Forest. This area has no road access and can only be reached via boat or float plane. On the hike, Members will observe old-growth stands and intact forest ecosystems without roads or other manmade infrastructure. This hike will educate House attendees on how the forest is managed at the watershed level and the history of the Roadless Rule in Southeast Alaska. In June 2025, the administration announced its intention to rescind Roadless Rule protections nationwide, including in the Tongass National Forest.
