Dear Mr. Meltzer:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Cleveland, Ohio, scheduled for August 27 to 29, 2017, sponsored by the Aspen Institute, with financial support from the Bill and Melinda Gates Foundation.

Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.
