Addendum – Primary Trip Sponsor Form

Item 4: *Representative Lisa Blunt Rochester.*

Congresswoman Lisa Blunt Rochester is a member of the House Committee on Energy and Commerce, and its subcommittees on Consumer Protection and Commerce; Energy; Environment and Climate Change; and Health. Agriculture is also a very important sector in Delaware and it is the state's single largest land use. Both Reps. Davis and Blunt Rochester have districts that are rich in agricultural resources including corn, soybeans, dairy products, and poultry.

The visit will provide Rep. Blunt Rochester and Rep. Rodney Davis the chance to meet directly with a group of farm owners and employees and learn their views on trade, regulatory reform, immigration, tax reform, and rural infrastructure. Representative Rodney Davis sits on the Transportation & Infrastructure Subcommittees on Highways and Transit, and Railroads, Pipelines and Hazardous Materials – both of which deal with how farmers can move their products, supplies, and equipment. Similarly, Rep. Blunt Rochester has many farms in her district that are interested in these issues.

The trip will also include visits that coincide with Rep. Blunt Rochester's service on the Energy & Commerce Energy Subcommittee, which includes jurisdiction over synthetic and alternative fuels and national energy policy. Conversations will include subjects of trade policy, national energy policy, and environmental issues.

An additional stop will dovetail with Rep. Blunt Rochester's service on the Energy & Commerce Health Subcommittee which often considers public health issues, public health insurance (Medicare, Medicaid), and drug abuse concerns. Both members have numerous Federally Qualified Health Centers (FQHC) in their respective districts and both are interested in innovative ways to tackle the challenges of the opioid crisis. This visit provides an opportunity to look at how rural health clinics are providing critical health services and utilizing health care technology.

Jacqueline Sanchez (Chief of Staff to Rep. Lisa Blunt Rochester): Jacqueline is Chief of Staff to Rep. Lisa Blunt Rochester. As such, she is responsible for the operation of the office and involved in all policy decisions, development of legislation and legislative strategy, and approaches to issues important to the Congresswoman and her district.

Regional agriculture supply company ranked as the 4th largest agriculture cooperative in the United States with over \$7 billion in revenue. They have 362 employees locally. The two members will discuss several issues critical to ag. cooperatives including transportation infrastructure, water quality, energy policy, and the regulatory review process. GROWMARK provides products and services to the agricultural sector in agronomy, energy, facility planning, and logistics, as well as grain marketing and risk management.

Both Reps. Davis and Blunt Rochester have districts that are rich in agriculture resources including corn, soybeans, dairy products, and poultry.

11:30-12:30 Drive to Champaign.

12:30-3:00 University of Illinois at Urbana-Champaign (UIUC). Internationally renowned engineering and agriculture research takes place here, ranked 5th in the United States for Biological/Agricultural Engineering. Includes working lunch.

The two members will first meet with the University's leadership including: Robert Jones, Chancellor; Andreas Cangellaris, Vice Chancellor for Academic Affairs and Provost; and Susan Martinis, Vice Chancellor for Research.

Next, the visit moves to the College of Agriculture, Consumer, and Environmental Sciences (ACES). Of special interest is the Agricultural & Biological Engineering program which has ongoing projects and research in soil and water (drainage, hydrology, and water quality), food and bioprocess (addressing the challenges of ethanol and alternative biofuel production), animal welfare and livestock production engineering, and off-road equipment which includes autonomous systems, precision agriculture, as well as safety and health.

Rep. Davis' service on the Agriculture Subcommittee on Biotechnology, Horticulture, and Research, and Rep. Davis' state of Delaware which hosts companies like DuPont and Syngenta (agrochemicals and seeds) sets the context for this portion of the visit.

Finally, the two members will tour the Grainger College of Engineering and discuss with faculty and students some of the current research initiatives in areas such as the Center for Electric Aircraft Research and Technology, Detection of the Illicit Movement of Nuclear Materials with Big Data, Civil Infrastructure Systems Big Data Innovation Hub, and the Interdisciplinary Study of Sound for film, music, bioacoustics, and hearing research.

All of these projects are funded with support of the National Science Foundation and/or other Federal departments such as Energy, Defense, and Homeland Security.

3:00-3:30 Drive to Piatt County Farm

3:30-4:30 Meet with representatives of the IL and Piatt County Farm Bureau including: T.J. Shambaugh, IV, Jared Gregg, Fred Perry, Jacob Lieb, and Tucker Muse.

This region of Illinois is a fertile center for soybean and corn crops. Illinois is the leading soybean producing state and second largest producer of corn in the U.S. This stop will provide the chance for the two members to meet directly with a group of farm owners and employees and learn their views on trade, regulatory reform, immigration, tax reform, and rural infrastructure.

Rep. Davis sits on the Transportation & Infrastructure Subcommittees on Highways and Transit, and Railroads, Pipelines and Hazardous Materials – both of which deal with how farmers can move their products, supplies, and equipment. Similarly, Rep. Blunt Rochester has many farms in her district whom are interested in these issues.

4:30-5:00 Drive to Decatur.

5:00-6:15 Tate & Lyle HQ (food processing); tour and meeting at 2200 E. Eldorado St.

Tate & Lyle is a U.K.-based global provider of solutions and ingredients for food, beverage, and industrial markets. It specializes in using innovative technology to turn raw materials like corn, tapioca and oats into ingredients that add taste, texture, nutrients and increased functionality to food and beverages.

The Decatur works was the result of an acquisition in 1988 of the A.E. Staley Manufacturing Co., and produces a range of starch products including high fructose corn syrup and other agro-industrial products.

The meeting with Tate & Lyle's Decatur leadership will take place in the historic and restored former headquarters building of A.E. Staley Mfg. Co., designed in an Art Deco style.

For Rep. Blunt Rochester, this discussion fits with her state of Delaware, where agriculture is the state's single largest land use.
