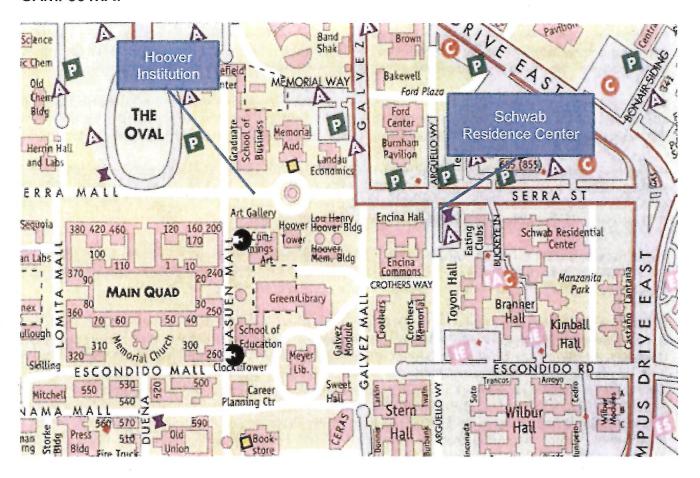
Checked Bags: Hoover does not cover the cost of checked bags.

SPEAKERS

ERIC WAKIN is the author of Anthropology Goes to War: Professional Ethics and Counterinsurgency in Thailand. His current research interest is guns and gun control in the nineteenth-century United States and he is revising a manuscript titled "From Flintlock to 'Tramps' Terror': Guns and Gun Control in Nineteenth-Century New York City." He has also coauthored a number of walking-tour books and travel guides.

Before coming to Hoover, Wakin was the Herbert H. Lehman Curator for American History and the Curator of Manuscripts at the Rare Book & Manuscript Library at Columbia University, where he also taught courses in the History Department on public history, memory and narrative, archives and knowledge, and theory.

He has also worked in business development, competitive intelligence, strategic communications, and digital strategy at Ernst & Young, IBM Custom Publishing, Kroll, PaulHastings, and Technology Investor. He continues to advise corporate and nonprofit entities on history and archive-related issues and consults on leadership and operational effectiveness in libraries and special collections.

Wakin received a BA in English literature from Columbia University; an MA in Southeast Asian studies and an MA in political science from the University of Michigan, where he was a FLAS Fellow; and a PhD in history from Columbia, where he was a Richard Hofstadter Fellow and a President's Fellow.

MICHAEL A. MCFAUL is the Peter and Helen Bing Senior Fellow at the Hoover Institution as well as a professor of political science, director and senior fellow at the Freeman Spogli Institute for International Studies at Stanford University. He also currently works as a news analyst for NBC and writes monthly column for the Washington Post. His areas of expertise include international relations, Russian politics, comparative democratization, and American foreign policy. From January 2012 to February 2014, he served as the US ambassador to the Russian Federation. Before becoming ambassador, he served for three years as a special assistant to the president and senior director for Russian and Eurasian Affairs at the National Security Council. He has authored and edited several books including most recently the New York Times best seller, From Cold War to Hot Peace: An American Ambassador in Putín' Russia (May 2018).

JOHN COGAN is the Leonard and Shirley Ely Senior Fellow at the Hoover Institution and a faculty member in the Public Policy Program at Stanford University.

John Cogan's research is focused on U.S. budget and fiscal policy, federal entitlement programs, and health care. He has published widely in professional journals in both economics and political science. His latest book, The High Cost of Good Intentions (2017) is the recipient of the 2018 Hayek Prize. The book traces the history of U.S. federal entitlement programs from the Revolutionary War to modern times. His previous books include Healthy, Wealthy, and Wise: Five Steps to a Better Health Care System, coauthored with Glenn Hubbard and Daniel Kessler, and The Budget Puzzle, (with Timothy Muris and Allen Schick).

Cogan has devoted a considerable part of his career to public service. He served under President Ronald Reagan as assistant secretary for policy in the U.S. Department of Labor from 1981 to 1983, as associate director in the U.S. Office of Management and Budget (OMB) from 1983 to 1985, and as Deputy (OMB) Director in 1988-89. His responsibilities included developing and reviewing Reagan Administration policies in the greas of health care, Social Security, disability, welfare, and employment training.

Cogan has served on numerous congressional, presidential, and California state advisory commissions. At the federal level, he has served on President George W. Bush's Commission to Strengthen Social Security, the U.S. Bipartisan Commission on Health Care (the Pepper Commission), the Social Security Notch Commission, and the National Academy of Sciences' Panel on Poverty and Family Assistance. He has also served on the California State Commission on the 21st Century Economy and the California Public Employee Post-Employment Benefits Commission.

SPEAKER BIOS

Cogan received his A.B. in 1969 and his Ph.D. in 1976 from the University of California at Los Angeles, both in economics. He received his M.A. in Economics from California State University at Long Beach in 1970. He was an associate economist at the RAND Corporation from 1975 to 1980. In 1979, Cogan was appointed a national fellow at the Hoover Institution; in 1980 he was appointed a senior research fellow; and in 1984 he became a senior fellow.

LARRY DIAMOND is senior fellow at the Hoover Institution and the Freeman Spogli Institute for International Studies, at Stanford University. He is also a professor by courtesy of political science and sociology at Stanford and a past director of its Center on Democracy, Development, and the Rule of Law, where he now leads its Program on Arab Reform and Democracy and its Global Digital Policy Incubator. He is the author of *The Spirit of Democracy: The Struggle to Build Free Societies Through the World* and editor or co-editor of 50 books on democracy. He is the founding co-editor of the *Journal of Democracy*.

FRANK DIKOTTER is the author of Mao's Great Famine: The History of China's Most Devastating Catastrophe published by Bloomsbury and Walker Books. The book was selected as one of the Books of the Year in 2010 by The Economist, The Independent, the Sunday Times, the London Evening Standard (selected twice), The Telegraph, the New Statesman and the BBC History Magazine, and won the 2011 Samuel Johnson Prize for Non-Fiction, Britain's most prestigious book award for non-fiction. He has been Chair Professor of Humanities at the University of Hong Kong since 2006. Before coming to Hong Kong he was Professor of the Modern History of China at the School of Oriental and African Studies, University of London.

KATE BUNDORF is an Associate Professor of Health Research and Policy at the Stanford University School of Medicine, an Associate Professor, by Courtesy, at the Stanford Graduate School of Business, and a Stanford Health Policy Fellow. She is also a Faculty Research Fellow at the National Bureau of Economic Research. She received her M.B.A. and M.P.H. degrees from The University of California at Berkeley and her Ph.D. from The Wharton School. She was a Fulbright Lecturer and Visiting Professor at Fudan School of Public Health in Shanghai, China in 2009 and 2010.

Her research, which focuses on health insurance markets, has been published in leading economics and health policy journals and has received funding from the U.S. National Institutes of Health, the Agency for Health Care Research and Quality and the Robert Wood Johnson Foundation. She received the 13th Annual Health Care Research Award from The National Institute for Health Care Management in 2007.

GEORGE SHULTZ has had a distinguished career in government, in academia, and in the world of business. He is one of two individuals who have held four different federal cabinet posts; he has taught at three of this country's great universities; and for eight years he was president of a major engineering and construction company.

Shultz attended Princeton University, graduating in 1942 with a BA in economics. Shortly after graduation, he enlisted in the US Marine Corps and served through 1945. He then resumed his studies, this time at the Massachusetts Institute of Technology (MIT), where he earned a PhD in industrial economics in 1949. From 1948 to 1957 he taught at MIT, taking a leave of absence in 1955 to serve as a senior staff economist on President Eisenhower's Council of Economic Advisers. In 1957, Shultz joined the faculty of the University of Chicago's Graduate School of Business as a professor of industrial relations. He was named dean five years later.

Shultz returned to government when he was appointed secretary of labor by President Nixon in 1969. In June 1970, he became the first director of the newly formed Office of Management and Budget. In May 1972, he was named secretary of the Treasury, a post he held for two years. Shultz left government service in 1974 to become president and director of the Bechtel Group, where he remained until 1982. While at Bechtel, he maintained close fies with the academic world by joining the faculty of Stanford University.

Shultz held two key positions in the Reagan administration: chairman of the President's Economic Policy Advisory Board (1981–82) and secretary of state (1982–89). As secretary of state, he played a key role in implementing a foreign policy that led to the successful conclusion of the Cold War and the development of strong relationships between the United States and the countries of the Asia-Pacific region including China, Japan, and the Association of Southeast Asian Nations.

After leaving office, Shultz rejoined the Bechtel Group as director and senior counselor. He also rejoined Stanford as professor of international economics at the Graduate School of Business and as a distinguished fellow at the Hoover Institution. In 2001, Shultz was named the Thomas W. and Susan B. Ford Distinguished Fellow at the Hoover Institution.

In January 1989, Shultz was awarded the Medal of Freedom, the nation's highest civilian honor. He is also a recipient of the Seoul Peace Prize (1992), the West Point Sylvanus Thayer Award (1992), the Eisenhower Medal for Leadership and Service (2001), the Reagan Distinguished American Award (2002), and the Association for Diplomatic Studies and Training's Ralph Bunche Award for Diplomatic Excellence (2002). In 2011, he received the Congressional Medal of Honor Society's Distinguished Citizen Award and the first Economic Club of New York Award for Leadership Excellence. In 2012, he was presented with a Democracy Service Medal by the National Endowment for Democracy and received the Henry A. Kissinger Prize at the American Academy in Berlin. The Ronald Reagan Presidential Foundation dedicated the Global Issues and Reagan-Gorbachev Summits Galleries in his honor in June 2012.

WILLIAM PERRY is an American mathematician, engineer, and businessman who was the United States Secretary of Defense from February 3, 1994, to January 23, 1997, under President Bill Clinton. He also served as Deputy Secretary of Defense (1993–1994) and Under Secretary of Defense for Research and Engineering (1977–1981).

Perry is the Michael and Barbara Berberian Professor (emeritus) at Stanford University, with a joint appointment at the Freeman Spogli Institute for International Studies and the School of Engineering. He is also a senior fellow at Stanford University's Hoover Institution. He serves as director of the Preventive Defense Project. He is an expert in U.S. foreign policy, national security and arms control. In 2013 he founded the William J. Perry Project, a non-profit effort to educate the public on the current dangers of nuclear weapons.

Perry also has extensive business experience and serves on the boards of several high-tech companies. He is a member of the National Academy of Engineering and a fellow of the American Academy of Arts and Sciences. Among Perry's numerous awards are the Presidential Medal of Freedom (1997), Knight Commander of the Order of the British Empire (1998) and the Grand Cordon of the Order of the Rising Sun (2002), awarded by the Emperor of Japan.

JOSH RAUH is a senior fellow and Director of Research at the Hoover Institution and the Ormond Family Professor of Finance at Stanford's Graduate School of Business. He formerly taught at the University of Chicago's Booth School of Business (2004–9) and the Kellogg School of Management (2009–12).

Rauh has published numerous journal articles and was awarded the 2006 Brattle Prize for the outstanding research paper on corporate finance published in the Journal of Finance for his paper "Investment and Financing Constraints: Evidence from the Funding of Corporate Pension Plans." In 2011 he won the Smith Breeden Prize for the outstanding research paper on capital markets, published in the Journal of Finance, for his paper "Public Pension Promises: How Big Are They and What Are they Worth?" coauthored with Robert Novy-Marx.

His other writings include "Pension Assumptions and Managerial Investment Decisions," coauthored with Daniel Bergstresser and Mihir Desai, which won the Barclays Global Investor Best Symposium Paper from the European Finance Association and appeared in the Quarterly Journal of Economics. Other work has

appeared in the Review of Financial Studies, the Journal of Financial Economics, and the Journal of Political Economy. Rauh's research on state and local pension systems in the United States has received national media coverage in outlets such as the Wall Street Journal, the New York Times, the Financial Times, and The Economist.

Rauh received a BA degree in economics, magna cum laude with distinction, from Yale University and a PhD in economics from the Massachusetts Institute of Technology.

ABBAS MILANI is the Hamid & Christina Moghadam Director of Iranian Studies and Adjunct Professor at the Center on Democracy, Development and Rule of Law at the Freeman Spogli Institute at Stanford University. He has been one of the founding co-directors of the Iran Democracy Project and a research fellow at the Hoover Institution. His expertise is U.S.-Iran relations as well as Iranian cultural, political, and security issues. Until 1986, he taught at Tehran University's Faculty of Law and Political Science, where he was also a member of the Board of Directors of the university's Center for International Relations. After moving to the United States, he was for fourteen years the Chair of the Political Science Department at the Notre Dame de Namur University. For eight years, he was a visiting Research Fellow in University of California, Berkeley's Middle East Center.

BJORN LOMBORG is president of the Copenhagen Consensus Center and visiting professor at Copenhagen Business School. He has been named one of TIME magazine's 100 most influential people in the world, multiple times "top 100 Global Thinker" by Foreign Policy, "one of the 50 people who could save the planet" by the UK Guardian and "one of the world's 75 most influential people of the 21st century" by Esquire Magazine.

He has written for New York Times, Wall Street Journal, USA Today, The Economist, The Atlantic, Forbes Magazine, Globe & Mail, The Guardian, The Daily and Sunday Telegraph, The Times, The Australian, the LA Times, Boston Globe, New Scientist, Prospect, Der Spiegel, Stern, Focus, Frankfurter Allgemeine, Süddeutsche Zeitung, Handelsblatt, Die Welt, Le Monde, Le Figaro II Sole 24 Ore (Italy), El Mundo (Spain), Times of India, Hindustan Times, China Daily, Shanghai Daily, Jakarta Post, Philippine Daily Inquirer, Prothom Alo (Bangladesh), VEJA (Brazil), Milenio (Mexico), El Tiempo (Colombia), Clarin (Argentina), El Universal (Venezuela), La Tercera (Chile), El Comercio (Peru), East African (Nigeria, Tanzania, Uganda and Rwanda), Mail & Guardian (South Africa), New Telegraph (Nigeria) and many others. Lomborg's monthly column is printed in about 40 newspapers in 19 languages, with more than 30 million readers. He is a television commentator on CNN, Fox, MSNBC and the BBC, among others, on shows such as "Newsnight", "20/20", "60 Minutes", David Letterman, Larry King and Stephen Colbert. He was featured in the movie "Cool it", by Sundance Award-winning director Ondi Timoner. His numerous books include "The Skeptical Environmentalist", "Cool It", "How to Spend \$75 Billion to Make the World a Better Place" and "The Nobel Laureates' Guide to the Smartest Targets for the World 2016-2030."

The Copenhagen Consensus Center is an award-winning think-tank that researches the smartest ways to do good, working with 300+ of the world's top economists and 7 Nobel Laureates.

JAMES MATTIS is the Davies Family Distinguished Fellow, after having served with distinction as the nation's 26th Secretary of Defense in the administration. In December of 2016, President Donald J. Trump nominated Mattis for Secretary of Defense and he was confirmed a month later. Mattis left Hoover to apply his extraordinary knowledge and experience to help the President shape his national defense policy.

General Mattis commanded at multiple levels in his forty-three-year career as an infantry Marine. As a lieutenant in the western Pacific, he served as a rifle and weapons platoon commander in the Third Marine Division. As a captain in the Pacific and Indian Ocean, he commanded a rifle company and a weapons company in the First Marine Brigade. As a major he was the battalion officer at the Naval Academy Prep School and commanded Marine recruiters in the Pacific Northwest and Hawaii. As a lieutenant colonel he commanded an assault battalion breaching the Iraqi minefields in Operation Desert Storm.

As a colonel he commanded 7th Marine Regiment and, on Pentagon duty, he served as the Department of Defense Executive Secretary. As a brigadier general he was the Senior Military Assistant to the Deputy Secretary of Defense.

Following 9-11 he commanded the First Marine Expeditionary Brigade and Naval Task Force 58 in operations against the Taliban in southern Afghanistan. As a major general, he commanded the First Marine Division during the initial attack and subsequent stability operations in Iraq. In his first tour as a lieutenant general, he was in charge of Marine Corps Combat Development at Quantico and subsequently served as Commander, I Marine Expeditionary Force/Commander, U.S. Marine Forces in the Middle East. As a general he served concurrently as the Commander of U.S. Joint Forces Command and as NATO's Supreme Allied Commander for Transformation.

Before retiring in 2013 he was the Commander of U.S. Central Command, directing military operations of over 200,000 soldiers, sailors, airmen, Coast Guardsmen, Marines and allied forces across the Middle East. He is coeditor of the book, Warriors & Citizens: American Views of Our Military.

EDWARD LAZEAR is the Morris A. and Nona Jean Cox Senior Fellow at the Hoover Institution since 1985, is also the Davies Family Professor of Economics at Stanford University's Graduate School of Business, where he has taught since 1992. Professor Lazear taught previously at the University of Chicago's Economics Department and Graduate School of Business, where he was the Brown Professor of Urban and Labor Economics.

Lazear was Chairman of the President's Council of Economic Advisers and served at the White House, on leave from Stanford, from 2006 to 2009. In his position as the chief economic advisor to the President, he advised on a broad range of matters that involve both the macroeconomy and microeconomic issues. Founding Editor of the Journal of Labor Economics, Lazear is a Fellow of the American Academy of Arts and Sciences, the American Association for the Advancement of Sciences, the Econometric Society, and the Society of Labor Economists of which he was president. Lazear is a Visiting Distinguished Fellow of the Becker Friedman Institute at the University of Chicago and is heads the economics initiative at the George W. Bush Institute. He is also a Research Associate of the National Bureau of Economic Research, where he co-chairs the program in personnel economics.

Professor Lazear's book Personnel Economics (MIT Press, 1995) expands on his 1993 Wicksell Lectures. In 1998, he received the Melamed Prize, which cited this book as the best research by a business school professor anywhere in the world during the previous two years. He received the Distinguished Teaching Award from Stanford University's Graduate School of Business, the PhD Faculty Distinguished Service Award, and the Davis Prize for Lifetime Achievement.

Lazear won the IZA Prize in Labor Economics, which is given to the person viewed to have made the most significant contributions to labor economics in the world. This was primarily for his work in personnel economics. In June 2006, Lazear was awarded the Jacob Mincer Prize given by the Society of Labor Economics for lifetime contributions to the field. He holds four honorary doctorates.

In addition to his former duties in Washington, Professor Lazear has been an advisor to the governments of Czechoslovakia, Romania, Russia, Ukraine, and Georgia.

Born in 1948, Professor Lazear grew up in Los Altos, California. He received his AB and AM degrees from the University of California at Los Angeles, and his PhD from Harvard University in economics.

Rachel Brandenburg is Senior Policy Advisor for Congresswoman Elissa Slotkin (MI-08). Just prior, Rachel worked at the Atlantic Council as director of the Scowcroft Center Middle East Security Initiative. From late 2014 to early 2018, Rachel served in the U.S. Department of Defense Office of the Secretary of Defense for Middle East Policy where she initially focused on Iraq and the counter-ISIS campaign as Iraq Director, and then Israel, Jordan, Egypt, and Lebanon as Levant Director. Rachel had previously worked on the Middle East and North Africa at the U.S. Institute of Peace, and served at the U.S. State Department in the Office of Middle East Transitions as the Tunisia Assistance Coordinator, and in the Middle East Partnership Initiative office. Prior to joining the U.S. government, Rachel worked with Search for Common Ground, the Saban Center for Middle East Policy, and the Transatlantic Institute in Brussels. Rachel was the recipient of a Fulbright Scholarship in Israel and a Critical Language Scholarship in Jordan. Rachel completed an MS in foreign service at Georgetown University and a BA in international relations and Middle Eastern studies at Tufts University.

Legislative Director, Representative Jody Hice (GA)

Nicholas (Nick) Brown hails from Atlanta, Georgia. He has worked in policy and politics for over 15 years—with a focus on high tech and family values policy. In addition to having served 27 years in the U.S. Marine Corps (both active and reserve), Bill—a 1986 graduate of the University of Texas at Austin—also served as Assistant Vice Chancellor for Federal Relations for the University of Texas System. He graduated from the Naval War College in 1995.

Allison Feikes is a Legislative Assistant for Senator Mike Braun of Indiana, covering issues including education, social security, tax, and foreign affairs. She previously worked in a similar capacity for Congresswoman Barbara Comstock of Virginia. She also completed a Fulbright Scholarship in Canakkale, Turkey and worked at the U.S. Mission to the European Union in Brussels, Belgium. She is a member of CISV International, a UNESCO nonprofit peace organization that aims to educate and inspire action for a more just and peaceful world.
