GHC advocates with the broader community in U.S. and multilateral forums for sound, strong global health policies and resources. GHC seeks to inform Congressional staff on CDC's role in gathering and sharing public health data and evidence and in protecting the health of Americans and others around the world, as well as the level of expertise it brings to the global health sphere. GHC is working in partnership with the other cosponsors on trip logistics, the agenda and other materials, and the Congressional travel forms.
