**Dr.** Jan Kasofsky has been the Executive Director of the Capital Area Human Services for the past 23 years. She has led this CARF accredited, \$26-\$30M, seven parish agency through implementation of innovative approaches for individuals with behavioral health and developmental disabilities challenges. Some of her most innovative programmatic work includes crisis services, integrated care, pre-natal substance use screening and brief intervention, school and prison in-reach, law enforcement training and reentry services. She established the Behavioral Health Collaborative 15 years ago, and through it

recently completed a region-wide opioid response plan.



Dr. Tim Murphy's professional career spans over 40 years in Healthcare, government service, the military, education and media. He is the only mental health professional in the United States with that unique background. Earning his degrees in psychology from the University of Pittsburgh (PhD), Cleveland State University (MA) and Wheeling Jesuit University (BA), he worked at hospitals in the Pittsburgh region including Children's Hospital, Magee Womens, Mercy, and West Penn and owned a multi-disciplinary private practice. At the University of Pittsburgh, he served as Assistant Professor in the School of Medicine as well as Associate Professor in the School of Public Health.

In 1996, he was elected to the Pennsylvania State Senate and reelected in 2000. He then was elected to eight terms in the United States Congress representing Southwestern Pennsylvania. His multiyear investigation into federal problems with mental health policy culminated in the comprehensive bill "Helping Families in Mental Health Crisis Act"; it was later amended into the 21st Century Cures Act and signed into law by President Obama in December 2016.

Murphy served on the Energy and Commerce committee and several subcommittees including Health, Energy and Power, Environment and the Economy. In addition, he chaired the Subcommittee on Oversight and Investigation where he led several congressional investigations. He chaired the Mental Health Caucus, Steel Caucus, and founded the GOP Doctors Caucus and Natural Gas Caucus.

While serving in Congress, Dr. Murphy volunteered and was commissioned an officer in the United State Navy Reserve in 2009. He served for 8 years in the Medical Service Corps as a psychologist on an inpatient Traumatic Brain Injury/PTSD Unit at Walter Reed National Military Medical Center at Bethesda. Additional active duty time was aboard the aircraft carriers (USS Carl Vinson, USS Theodore Roosevelt and USS Ronald Reagan), and with Navy Special Warfare in Coronado CA, and Dam Neck VA. He achieved the

rank of Commander. His Navy research for the Defense Veterans Brain Injury Center was on behavioral and psychological outcomes of TBI.

Murphy now works as a consultant in public policy with health care, energy, manufacturing, and as a public speaker. He still practices as a consulting psychologist treating PTSD, Traumatic Brain Injury, addiction disorders and volunteers with the care of homeless veterans and with the American Red Cross.

Paul W. Rainwater most recently held the title as Governor Jindal's Chief of Staff. He resigned in February of 2014 to pursue a career in the private sector and shortly thereafter joined Cornerstone Government Affairs.

Prior to his latest position, Paul held the title of Commissioner of Administration. Before that, he served as Governor Jindal's deputy chief of staff. Prior to that, he served as executive director of the Louisiana Recovery Authority (LRA). Previously, Paul served as legislative director and chief of operations for U.S. Senator Mary Landrieu. From June 2006 to January 2007, he served as director of hazard mitigation and intergovernmental affairs at the LRA, where he managed program policies,

served as team leader and coordinated with state and federal agencies to set mitigation priorities. From July 2000 to June 2006, Paul served as the chief administrative officer for the City of Lake Charles.

Paul also formerly served as manager of governmental affairs for Conoco, Inc., Gulf Coast Business Unit in Baton Rouge from 1998 to July 2000; as manager of public affairs for ARCO Chemical in Lake Charles from 1995 to May 1998; and as administrative aide to the Calcasieu Parish Police Jury in Lake Charles from 1988 to 1996.

In addition to his public service duties, Paul also serves as a colonel with the Louisiana Army National Guard in the Joint Director of Military Support for Disaster Response Unit. He previously served as a lieutenant colonel in the Congressional Liaison Office of the Louisiana Army National Guard and as a lieutenant colonel in the United States Army Reserves' 336th Finance Command. For his military service, Paul has been awarded the Bronze Star Medal, the Army Commendation Medal and the Combat Action Badge.

Paul earned a bachelor's degree in government from McNeese State University in Lake Charles, a master's degree in international relations from Salve Regina University in Rhode Island, and is certified as a local government manager by Louisiana State University.



John E. Long joined FEMA's Federal Coordinating Officer (FCO) cadre in 2010, is a certified Type II FCO, and accredited by the International Association of Emergency Managers as a Certified Emergency Manager.

John has participated in more than 25 President declared disasters, recently serving as Deputy FCO during Hurricane Harvey in Texas. During Hurricane Sandy, he served as Operational Branch Director coordinating response and recovery operations in the five boroughs of New York City before assuming

duties as Deputy FCO in New York State. He also served as Deputy FCO during Hurricane Irene and Tropical Storm Lee in New York, and he served as FCO for disasters in New York, Iowa, Oklahoma, Arkansas, and Louisiana. Additionally, he served as the acting Region 6 Recovery Division Director for seven months.

Before joining FEMA, John spent 30 years on active duty as a U.S. Coast Guard officer. His last assignment was Chief of Staff, Eleventh Coast Guard District, which encompasses the states of California, Arizona, Nevada and Utah – including 3.3 million square miles of coastal and offshore waters extending to Ecuador.

In his previous assignment as Chief Operating Officer, Coast Guard Pacific Area, he directed Coast Guard operations throughout the Pacific theater while managing 28 major operating units. Primary missions included maritime homeland security, maritime homeland defense, search and rescue, protection of natural resources, counter-drug enforcement and alien migrant interdiction operations.

An aviator for 25 years, John commanded Coast Guard Air Station Houston, Texas and Coast Guard Sector San Diego, California where his duties included Captain of the Port, Federal Maritime Security Coordinator, Federal On-Scene Coordinator for oil and hazardous chemical spills, and Search and Rescue Mission Coordinator.

John is a graduate of the U.S. Coast Guard Academy with a Bachelor's Degree in Marine Science; and the Air War College, where he earned a master's degree in strategic studies.

#### The Ninth Ward:

The Ninth Ward or 9th Ward is a distinctive region of New Orleans, which is located in the easternmost downriver portion of the city. It is geographically the largest of the 17 Wards of New Orleans. On the south, the Ninth Ward is bounded by the Mississippi River. On the western or "upriver" side, it is bounded by Franklin Avenue going from the River north to Lake Pontchartrain); The Lake forms the north and northeastern end of the ward. The 9th Ward neighborhood was thrust into the nation's spotlight in the aftermath of 2005's Hurricane Katrina. Much of the area on both sides of the Industrial Canal experienced

catastrophic flooding. The majority of the damage was caused by storm surge. There were multiple severe levee breaks along both the MRGO and the Industrial Canal. The Lower Ninth Ward flooded most catastrophically, with storm surge coming through two large breaches in the Industrial Canal flood protection system, creating violent currents that not only flooded buildings, but smashed them and displaced them from their foundations. Floodwaters propelled the barge ING 4727 into the neighborhood on the other side of the levee from the Industrial Canal. Since Katrina, the 9th Ward has witnessed an uneven resurgence, with the Vietnamese community in New Orleans East establishing themselves as a dining destination and commercial hub, even as Vietnamese and other fishermen further down the Parish are suffering from the Deepwater Horizon oil spill of April 20, 2010 and despite the projected shuttering of NASA's Michaud facility with the retirement of the current space shuttle fleet.

\*lowernine.org is a 501(c)(3) nonprofit organization dedicated to the long-term recovery of the lower ninth ward of new orleans, louisiana in the wake of hurricanes katrina and rita, and the levee breaches of 2005.



Laura Paul, lowernine.org's Executive Director, volunteered in 2006 to help with initial disaster recovery. She was a founding board member for lowernine.org and has a deep institutional knowledge of the work of lowernine.org since its inception in 2007. As a resident in the Lower Ninth Ward, she has first-hand knowledge of the issues facing the neighborhood. Laura has been the Executive Director of lowernine.org since 2011. She was a founding board member, acting as board Vice-Chair from 2005-2007, then joined the staff as Development Director in 2007. Laura eventually became the Executive Director in 2009. In her role as Executive Director, Laura oversees the project manager, general organizational development, and ensures all rebuilds follow best practices and

meet established financial and time estimates.



Cotie San, lowernine.org's Outreach Coordinator and Volunteer House Manager, is a proud native of Chattanooga, TN and graduated from Sewanee: The University of the South in 2018. She originally volunteered with lowernine.org in March 2017 with the Sewanee Civic Engagement Office, and loved it so much that she returned to work full time as the Volunteer House Manager and Outreach Coordinator in October 2018. As the House Manager, she ensures safety and comfort of in-house volunteers. As Outreach Coordinator, she manages lowernine.org social media and assists the Executive Director with fundraising. She appreciates the culture and history of New Orleans, and the work that lowernine.org is doing to restore that in the Lower Ninth

Ward. Cotie supports racial and economic justice, as well as public health initiatives, so lowernine.org is a great fit and she hopes to continue learning about New Orleans' complicated history with race and class.
