



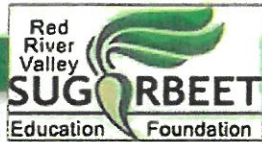

- 9:30 – 9:45 Depart / Travel to Chuck Johnson farm. – Sugarbeet Grower.
- 9:45 – 11:45 Arrive at Chuck Johnson field - Chuck will be harvesting near piling site a few miles. Observe sugarbeet harvest operations. Ride along in a defoliator, a harvester, and a beet truck. Riding along in equipment shows participant each step of the sugarbeet harvesting process. It is vital to understand modern production practices and the challenges farmers face.
