

Whereas, by November 17, 2019, the unrest had reached the capital of Tehran, with citizens marching for an end to the Islamic Republic and the downfall of its leaders, burning pictures of Supreme Leader Ayatollah Ali Khamenei, and calling for the return of Reza Pahlavi, the exiled son of the toppled Shah of Iran;
