To allow for robust discussion, invitations are being extended only to senior Congressional staff who work on a variety of energy-related policy areas.

We are able to reimburse the cost of travel and hotel accommodations and are carefully following House and Senate Ethics Committee requirements. The necessary forms will be provided to you should you apply to attend.

As you will see in the attached agenda, the seminar will include sessions with a range of MIT faculty with expertise on potential technological and policy approaches to climate. The seminar will also include tours of The Engine, a technology incubator and venture fund spun off from MIT, and of our fusion energy laboratory.

On the morning of April 21, the seminar will include attendance at a broader MIT event at which the flagship research projects from our Climate Grand Challenges competition will describe their plans.
