The Farm Foundation Congressional Fellows Program

Farm Foundation is excited to provide congressional staffers with the opportunity to gain hands-on experience and a broader perspective on the U.S. food and agriculture sector. Twenty congressional staffers will be selected to participate in the program. As Fellows and within their official duties, staff will participate in a two-day visit of a selected agricultural region in the United States. The experience will offer exposure to diverse perspectives, as well as a variety of agricultural production, processing, and marketing systems.

The program will include special speakers and facility tours. Emphasis will be on the opportunity for Fellows to have one-on-one interactions with farmers, researchers, processors, and other industry leaders to discuss timely issues and challenges facing food and agriculture in that region. Discussions could range over varied topics, such as water quality, sustainability, technology, and global trade. Fellows will see first-hand public policies' impact on day-to-day activities across the food and agriculture value chain, gain diverse perspectives on the impacts policies may have at all levels of the value chain, and build a network of experts on a variety of issues to call on in the future. All transportation, housing, and meals will be covered by Farm Foundation.

The Fellows Program has been designed to be in complete compliance with the Ethics Rules of the United States House and Senate. Importantly, we will work to ensure that each participating office will receive an approval letter from their respective ethics offices. We will ensure that participating in the Fellows programs will not constitute a "gift" under Congressional rules and that there will be no involvement by lobbyists in the planning of program events. Farm Foundation does not retain lobbyists. If a corporate sponsor of the Fellowship does have their own lobbyists, their participation will be appropriately limited.

The Fellows Program will be administered in the complete discretion of Farm Foundation. No sponsor will be able to finance, direct, or control the selection or participation of any particular staffer who may participate in the program.
