Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Israel, scheduled for August 12 to 21, 2022, sponsored by Jewish Institute for National Security of America.

You must complete an Employee Post-Travel Disclosure Form (which your employing Member must also sign) and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. If you are required to file an annual Financial Disclosure Statement, you must also report all travel expenses totaling more than \$415 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

On behalf of the Jewish Institute for National Security of America (JINSA), it is my pleasure to invite you to participate in our Congressional National Security Program to Israel, to be held **August 12-20**, **2022**.

JINSA is a not-for-profit 501(c)3 organization dedicated to working with congressional, military, and civilian decisionmakers to ensure American strategic interests, primarily in the Middle East, are defended. JINSA believes the cornerstone of this defense is a robust U.S.-Israeli security cooperation relationship. One of the ways JINSA executes its educational mission is through unique programs that promote dialogue between prominent U.S. military leaders and government officials and their Mideast counterparts. For example, for four decades JINSA has brought prominent retired military leaders to Israel to visit key security and historical sites and meet with senior Israeli generals and security officials; last year, that annual delegation included General Joseph F. The program curriculum will feature visits to strategically important sites, such as Israel's borders with Gaza, Lebanon, Syria, and Egypt, where participants will be briefed by IDF commanders to better understand the security challenges Israel faces on each respective border, including its lack of strategic depth. Delegation participants will also visit key religious and historical sites throughout the country and will meet with senior Israeli security, military, and foreign affairs officials.

The program will include briefings on topics such as:

- Middle East security challenges confronting the United States and Israel;
- U.S.-Israeli strategic cooperation with Abraham Accords countries;
- Linkages between Israel's "Silicon Wadi," IDF weapons technology, and the U.S. defense establishment; and
- Cyber threats and challenges for military intelligence.
