

**Goals:**

1. Educate congressional staff on the Cooperative Management System (CMS), the unique public-private partnership by which the National Park Service, ATC, 31 volunteer-led Trail Clubs, and local land managers (other federal agencies, states, municipalities, and private landowners) co-manage America's most famous national trail. The CMS sets the ANST and National Trails System as a whole apart from other types of federal land, and understanding the way that this collaboration plays out on the ground is critical context for Congress' consideration of a host of issues affecting the ANST and other national trails.
2. Spread the message that the Appalachian Trail Corridor is one of the most important open spaces in the Eastern United States! (This umbrella statement encompasses recreation, protection of natural resources, preservation of cultural resources, scenic value, etc.)
