

Dear Ms. Healy:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to France,<sup>1</sup> scheduled for April 1 to 7, 2023, sponsored by Global Women's Innovation Network. We note that this trip includes one day at your personal expense.

You must complete an Employee Post-Travel Disclosure Form (which your employing Member must also sign) and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. If you are required to file an annual Financial Disclosure Statement, you must also report all travel expenses totaling more than \$480 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House employees may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$480] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

Thaima is one of the founders, and President, of the European Network for Women in Leadership. She also sits on the boards of Women Equity for Growth and the Chamber of Commerce and Industry.

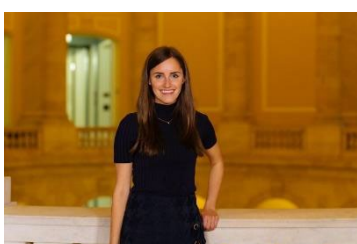

**Ambassador Denise Bauer, United States Ambassador to France**

Ambassador Denise Campbell Bauer, of California, was sworn in as U.S. Ambassador to the French Republic and the Principality of Monaco on December 23, 2021. Denise Campbell Bauer is an experienced diplomat, non-profit leader, and advocate for women's voices in politics and policy. She served as the United States Ambassador to the Kingdom of Belgium from August 2013 until January 2017, where she led one of the largest embassies in Europe and earned a reputation for her collaborative leadership style, high ethics standards, and crisis management skills. In that role, she focused on building transatlantic security partnerships and expanding international trade. Bauer began her career in Los Angeles, where she worked as a journalist for two internationally respected television networks. She went on to serve in leadership roles for a number of non-profits. In 2019, Bauer became the Executive Director of Women for Biden, a nationwide network of women that organized and mobilized to elect President Biden. In 2012, she served in a similar role for the Obama-Biden presidential campaign, while also chairing the Women's Leadership Forum for the Democratic National Committee. Upon returning from Brussels in 2017, she re-engaged in politics, focusing on supporting women running for office for the first time. Bauer received a B.A. in Political Science from Occidental College. She speaks French.

**Ambassador Jack Markell, U.S. Mission to the Organization for Economic Cooperation**

Jack Markell became the U.S. Representative to the Organization for Economic Cooperation and Development (OECD), with rank of Ambassador, on January 14, 2022. Markell previously served as the White House Coordinator for Operation Allies Welcome where he worked to ensure vulnerable Afghans who passed screening and vetting reviews were safely and effectively resettled in the United States. Governor Markell served on the boards of a number of publicly-traded and privately held corporations as well as on a number of non-profit organizations including Upstream USA, Delaware State University, Annie E. Casey Foundation, and Jobs for America's Graduates. He is a Henry Crown Fellow and a Rodel Fellow at the Aspen Institute. Governor Markell was born in 1960 in Newark, Delaware. He earned an undergraduate degree from Brown University and an MBA from the University of Chicago. He and his wife Carla have two children, Molly and Michael, who are in their 20s.

**Le Sénat Français ft. Sénateur Antoine Lefèvre and Sénatrice Catherine Dumas**

### **Catherine Dumas (The Republican - Conservatives), Senator of Paris, member of the Committee of Foreign Affairs, Defence and Armed Forces**

Catherine Dumas, 66, has been a key figure of the Paris for nearly 40 years. Throughout her career, she has proven being a fine connoisseur of culture-related topics and a strong advocate of the Parisian heritage. She was decorated Knight of the National Order of Merit in 2006 and Knight of the Legion of Honour in 2012. She regained her Senator seat in 2017 and was appointed Vice-Chair of the Culture, Communication and Education Committee. Catherine Dumas involved in cultural heritage-related issues, in particular the reconstruction of the Notre-Dame de Paris cathedral following a 2019 fire. She is now a member of the Senate’s Committee of Foreign Affairs, Defence and Armed Forces. Catherine Dumas is a member of the Board of Directors of the Georges Pompidou National Centre for Art and Culture, and of the High Council of French Museums. She has been involved in women empowerment organizations, she is the Founding President of the Association of Political Women, Vice-Chair of the French Association of Women, National Delegate for Women of the Association of Friends of former President Jacques Chirac.

### **Sénateur Antoine Lefèvre, (The Republicans - Conservatives), Chair of the Senate's France-United States Friendship Group, Member of the Senate’s Finance Committee**

Senator Antoine Lefèvre, 57, has held elected offices at local government and national level for more than 25 years. A former mayor of the city of Laon, Antoine Lefèvre was elected Senator (upper chamber of the French Parliament) for the first time in 2008, where he worked on a wide range of policies, including budgetary, health and local government matters. As a Senator, he has focused on public budget and healthcare affairs, electoral processes, as well as local government issues. Today, he sits in the Senate’s Finance Committee and serves as the Chair of the France-United States Friendship Group. In 2018, Antoine Lefèvre proposed a nonbinding resolution aimed at expressing the Senate’s gratitude and recognition to the American armed forces who participated in the landing of June 6<sup>th</sup>, 1944, in Normandy..

**Meeting with Laurence Rossignol, Vice-President of the Senate and a Former Minister for Women's Rights and for Social Affairs**

### **Sénatrice Laurence Rossignol (Socialist Party), Vice President of the Senate**

Jurist by training in Social Law, Laurence Rossignol has been from the beginning of her career a strong advocate for women and social rights. She is an influential figure of the Socialist Party, she has held many political positions within the party, dealing with women issues, environment, sustainable development. Laurence Rossignol joined the Socialist Party (PS) in 1981 and began her professional career as a legal journalist at *La Vie Ouvrière*, a newspaper affiliated with the French trade union CGT. In 1983, she was appointed as a collaborator in charge of monitoring social legislation in the office of Pierre Joxe, then president of the Socialist group at the National Assembly (lower chamber of the French Parliament). In 1988, following the legislative elections provoked by François Mitterrand after his re-election as President, Laurent Fabius became President of the National Assembly and chose Laurence Rossignol as one of the officers of his cabinet. In 1991, she used her parliamentary experience to join the cabinet of Frédérique Bredin, Minister of Youth and Sports, as a technical advisor in charge of children and relations with Parliament. She began a political career by being elected as a Regional Advisor for the Picardy Region in 1998 and as a Municipal Advisor of Compiègne (a city of 40 000 inhabitants in the north-east of France) in 2001. Invested in the party's bodies, she held between 2005 and 2014 the successive positions of National Secretary of the PS in charge of women (2005-2008), environment (2008-2012) and sustainable development (2012-2014). In 2004, she also became head of the National Council of Socialist Women. In September 2011, she was elected Senator for the department of Oise and joined the Committee on Sustainable Development, Infrastructure, Equipment and Regional Planning, of which she became Vice President in early 2012. She was particularly active in the preparation of the COP21, and the delegation for women's rights and equal opportunities between men and women. In April 2014, Manuel Valls became Prime Minister and Laurence Rossignol was appointed Junior Minister in his first government, in charge of the Elderly, the Family and Autonomy, a portfolio expanded to include Children as of summer 2015. Following a new ministerial reshuffle, she was appointed Minister for Families, Children and Women's Rights in 2016. She returns to the ranks of the Senate in 2017 following the termination of office of member of the Government and is re-elected three months later as Senator. She is now Vice-President of the Senate, member of the Social Affairs Committee and the Delegation for Women's Rights and Equal Opportunities between Men and Women. She is Vice-Chair of the committee of inquiry on the use of the social network TikTok rapporteure on the bill to strengthen the right to abortion (2021).

**American Chamber of Commerce (EACC) ft. MP Christopher Weissberg**

**MP Christopher Weissberg (Presidential Majority), Chair of the National Assembly's France-US Friendship Group**

Aged 37, Christopher Weissberg has been an early supporter of the Macron movement and a strong advocate for the party in Montréal. He is part of Roland Lescure's (the current Deputy Minister of Industry) inner circle as a member of his campaign team for the legislative elections and as an advisor once elected in 2017. He is now a Member of the Parliament (MP) at the National Assembly (lower chamber of the Parliament), as a suppletive to Roland Lescure following his appointment at the Government. He studied and had a few political experiences in the US and Canada. Christopher Weissberg holds a bachelor's degree in arts, Political Sciences from the University of Montreal (2011), a master's degree in political science from the College of Europe (2012) and a master's degree in International Energy, Environment Law, and Natural Resources from political sciences elitist school Sciences Po Paris (2013). He began his career in 2012 as Head of Office of the Vice-President of the Regional Council for Paris' Region, in charge of public procurement and administration, and became two years later a parliamentary assistant of MP Christophe Premat (Socialist) at the National Assembly. In 2015, he shortly joined Amsterdam Group, a Washington-based social media and public relations consultancy company, as a campaign manager. He then became in 2016 the Communications and Press Relations Advisor of Quebec's International Youth Offices. In parallel to this position, he was the referent of Emmanuel Macron's political party (centrist En Marche!, recently renamed Renaissance) in Montreal. During the 2017 presidential elections, he led Roland Lescure's campaign team (the current Deputy Minister of Industry). Following Lescure's election as Member of the Parliament and his appointment as President of the National Assembly's Economic Affairs Committee, he became his Political Advisor. In 2020, he joined the Ministry for Europe and Foreign Affairs as Parliament and elected representatives of French nationals living abroad Advisor to the office of the Junior Minister in charge of Tourism, French nationals living abroad and the Francophonie (Jean-Baptiste Lemoyne). In August 2022 and following the appointment of Roland Lescure as Deputy Minister of Industry, he became a Member of the Parliament for the presidential majority (Renaissance, centrist), representing the 1st constituency for French residents overseas (North America) as his suppletive. At the National Assembly, his priorities are to develop the Flam network (a fund supporting associations providing activities in French to children based abroad), to increase his presence within his consistency and pursue de modernization of consular services. He is committed to a few friendship groups with American countries, namely as the Chair of the France-United States friendship group, a member of France-Argentina, France-Quebec, French-Canada and France-Mexico friendship groups. He is also a member of the Foreign Affairs Committee and co-rapporteur of the fact-finding mission on international sanctions policy. In addition, he is a member of a few study groups e.g., Luxury industries, Discrimination and LGBTQI-phobias, Tourism and heritage, Participative democracy and e-democracy, wine and oenology. Finally, he is a member of the French Section of the Parliamentary Francophonie Assembly (APF), an association gathering French-speaking countries' MPs. For the record, he is also the owner of the Left Bank Café, a French restaurant located in New-York since 2010.

**Meeting with the office of the Deputy Minister for Digital Affairs, Jean-Noël Barrot**

**Renaud Vedel, Head of Office of Jean-Noël Barrot**

Renaud Vedel is a senior civil servant who graduated from Ecole nationale d'administration (ENA), a French elite institution training politicians and senior civil servants and allows one to occupy the highest positions in the French administration. He has mainly served in national security positions and was particularly affected by the 2015 attacks as he was then advisor for home affairs to the Prime Minister. He then ensured for the Prime Minister the proper implementation of the 2015 law on intelligence. Before being appointed in his current role, he coordinated the French national strategy for artificial intelligence (AI). Renaud Vedel graduated from Sciences Po Paris (1993), the University of Manchester (Masters in Economics in 1994), and Ecole Nationale d'Administration (1999). In 2001, he joined the office of the Director General of the National Police (Ministry of Interior) as Head of office. In 2007, he became Deputy Head of office of Paris' Prefect of Police, then moved to the role of Deputy Head of the Minister of Interior's office in 2012. In 2014, Renaud Vedel became Advisor, then Head of the Home Affairs Department at the Prime Minister's office until 2016. In 2018, he was appointed coordinator of France's National Strategy for AI. Following a parliamentary report on AI, Renaud Vedel was in charge of coordinating public and private initiatives aimed at positioning France as one of the world leaders in this set of key information processing technologies. In July 2022, Renaud Vedel appointed Head of Jean-Noël Barrot's office, Deputy Minister for the Digital Transition and Electronic Communications.

**Mélanie Przyrowski, Telecommunications Advisor to Jean-Noël Barrot, Deputy Minister for Digital Transition and Electronic Communications**

After practicing in the private sector, Mélanie Przyrowski joined the French Ministry of Economy where where she has worked on the French and European Union regulatory landscape for the digital and telecoms sectors for 6 years, before advising Minister Jean-Noel Barrot. Mélanie Przyrowski holds a master's degree in political science from the People's Friendship University of Russia (2015) and a master's degree in international relations from Sciences Po Paris (2015). For the three years following her graduation, she volunteered in the Young Europeans, a transpartisan association promoting the European construction and European federalism, where she was successively Secretary General and Treasurer. She began her career in 2014, in Moscow, as a Junior Business Developer for Bridor (a bakery product manufacturing company). A year later, she returned to Paris, and after a short experience at the strategy and risk management consultancy firm, CEIS, she was hired by Orange as a Junior Institutional and Regulatory Relations Officer. In 2016, she entered the Directorate General for Enterprises at the French Ministry of Economy, where she was Digital Sector Officer, then Parliamentary Advisor and Chief of



Staff at the Director General's office. In July 2022, she was appointed Telecommunications Advisor to Deputy Minister for Digital Transition and Electronic Communications, Jean-Noël Barrot. Mélanie Przyrowski is involved in the association Culture & Cie since 2013. As a volunteer, she supports the association for the organization and supervision of the street arts festival Fest'arts in Libourne and with the mediation between the public and the artist.

#### **Michaël Reffay, Advisor on Regulation and Digital Sovereignty to Jean-Noël Barrot**

Michaël Reffay is a young civil servant specializing in European affairs, who became an expert in digital economy regulation. Before joining the cabinet of Jean-Noël Barrot, he was Deputy Advisor for Digital Affairs at the French Permanent Representation to the European Union. Michael Reffay holds a Master's degree in Behavioral Economics from Panthéon-Sorbonne University (2014), a Master's degree in Public Affairs from Paris Dauphine University (2015) as well as a Master's degree in Political and Administrative Studies obtained from the College of Europe (2016). Michael Reffay began his career in 2014 as a project manager in charge of European and digital affairs at ENGIE. Between 2018 and 2021, he taught as a "digital economy" lecturer at Paris Dauphine University. In 2016, he joined the Ministry of Economy and Finance, Action and Public Accounts as a project manager for the French Digital Agency. Then in 2018, he became project manager for the "Data Economy" before being appointed project manager for the "Data, Electronics and Software Industries". From September 2021 to July 2022, he was deputy advisor for digital, telecommunications and postal services at the French Permanent Representation to the European Union. He participated in the negotiations between the EU member states on the draft Artificial Intelligence Act regulation during the French Presidency of the Council of the EU (January - June 2022). On July 26, 2022, he joined Deputy Minister for Digital Transition and Telecommunications Jean-Noël Barrot's office as Advisor in charge of regulation and digital sovereignty. He is responsible for regulatory issues related to artificial intelligence, data, cloud and online platforms.

#### **Baltis Méjanès, Chief of Staff and Advisor on Online Child Protection to Jean-Noël Barrot**

After graduating from Sciences Po Paris and the London School of Economics and Political Science, Baltis participated to the electoral campaign for the mayorship of Paris of a former Conservative minister, Nathalie Kosciusko-Morizet, in 2014. She served as Chief of Staff of the Mayor of the city of Palaiseau, Grégoire de Lasteyrie (conservatives) from 2014 to 2017, when she became parliamentary assistant of MP Olivia Grégoire (incumbent French Deputy Minister for Small and Medium-Sized Enterprises, Trade, Craft and Tourism). In 2019, she was appointed Chief of Staff and Advisor for the Relations with the Parliament of the former Junior Minister for Children Rights, Adrien Taquet, and Deputy Chief of Staff of the former Minister of Solidarity and Health, Agnès Buzyn. Since July 2022, Baltis has been serving as Chief of Staff and Advisor on Online Children Protection of the Deputy Minister for Digital Transition and Electronic Communications, Jean-Noël Barrot.
