

Tim has 30 years’ experience in fleet management, including with Philadelphia, Atlanta, the District of Columbia, and Harris County, Texas. A DC DPW B100 vehicle will be on display.

1:35 – 1:55 pm Low Carbon Fuel Demand, *Richard Hilmer*, Division Chief, Prince George’s County Fleet Management, will discuss the region’s need for low-carbon fuels in existing vehicles and infrastructure to meet budget and environmental goals.
