9:00 AM — 10:30 AM | Panel 1: How U.S. capital markets are fueling China's rise

This policy panel will cover key policy areas that fall under the portfolios of the staff of the U.S. House of Representatives that are in attendance. Specifically, we will have policy experts present on policy reforms to address how the Chinese Communist Party currently exploits U.S. capital markets to fund companies that pose a direct threat to U.S. economic and national security.
