

Dear Mr. Haley:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Israel,¹ scheduled for June 29 to July 7, 2024, sponsored by American Israel Education Foundation.

You must complete an Employee Post-Travel Disclosure Form (which your employing Member must also sign) and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. If you are required to file an annual Financial Disclosure Statement, you must also report all travel expenses totaling more than \$480 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House employees may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$480] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

¹ Please be aware that the Committee's review of the proposed trip does not extend to either the security situation in the destination country or security related to foreign travel in general. We recommend you contact the Office of House Security (OHS) for a safety and security briefing prior to your departure. OHS may be reached at (202) 226-2044 or ohsstaff@mail.house.gov. House travelers should also register for the U.S. State Department's Smart Traveler Enrollment Program at <https://step.state.gov>.

6. June 30, 2024 – Our group met with Ze'ev Orenstein, who led us on a tour of the City of David.

July 1, 2024 – Our group received several briefings. We met with Efrat Rosenberg Shapira, Media Figure, Content Director, Beit Avi Chai Foundation. We then received an overview briefing on October 7, 2023. We then received a briefing from LTC. Jonathan Conricus, former International Spokesperson of the Israel Defense Forces (IDF). We then received two separate briefings on October 7, 2023. We finished that evening with a meeting with two Israel military reservists.

July 2, 2024 – Our group visited the Old City. While in the Old City we received a briefing on the Strategic Survey of Jerusalem. We then had a discussion of the current state of Israeli politics. We then met with two members of the Israeli Knesset. We finished that day with a dinner and discussion on the state of Israeli politics.

July 3, 2024 -We visited the Yad Vashem Holocaust Museum and Mount Herzi Military Cemetery. We then met with Samer Sinijlawi, Fatah Activist & Founding Chairman of the Jerusalem Development Fund. We then discussed the Oslo Peace Accords with Dr. Shany Mor and a briefing on Israeli resiliency with Danielle Abraham, CEO of Regrow Israel and Miriam Ballin, Founder of Psychtrauma and Crisis Response Unit, United Hatzala.

July 4, 2024 – We first had a regional strategic overview briefing from Brig. Gen. Nitzan Nuriel, former Director, Counter-Terrorism Bureau at the Prime Minister's Office. We then received humanitarian aid with Hadassah Schwarz, Coordination of Government Activities in the Territories (COGAT). We then received a briefing and visited Alfei Menashe, Israel. We then were briefed on Hezbollah and visited an Israeli Air Force base. We finished that day by visiting displaced residents from a Kibbutz that was attacked during October 7, 2023.

July 5, 2024 – We started this day by a briefing of the historical significance of the Sea of Galilee. We then had a briefing on a shared society during crisis by Mohammed Darawshe, Director of Planning, Equality, and Shared Living, Givat Haviva Educational Institute. We then visited Hostage Square in Tel Aviv and then enjoyed Sabbath dinner hosted by a Tel Aviv family.

July 6, 2024 – We started this day with a briefing on understanding the roots of Israeli ethos. We then attended a viewing of the Processing Trauma Through Art: A Conversation with Local Artists at the University of Tel Aviv. We then finished our day with a briefing on Gaza after Hamas.

Jerusalem's City of David, more than any other site, represents the complexity of the Arab-Israeli conflict. The City of David is the site most archeologists agree to be the ancient city of Jerusalem that later became the capital of the united Israelite tribes under King David. This area is one of the most intensively excavated sites in the wider region. To Jewish Israelis, the site represents the beginning of their physical and emotional attachment to Jerusalem that has continued for over three thousand years. At the same time, much of the site is located in the predominantly Arab neighborhood of Silwan. The residents of Silwan, and the Palestinian Authority leadership are opposed to the archeological efforts being carried out in the City of David. In several instances, homes in Silwan were purchased and then destroyed to open up more areas for excavations. Palestinian leadership has denied the existence of any Jewish connection to Jerusalem.

The area is also home to Israel's "silicon valley", as well as Ben Gurion international airport. The discussion at Alfei Menashe will allow participants to see firsthand the proximity of Jewish and Arab neighborhoods in both Israel and the West Bank; as well as the strategic threats faced by the Israeli population living in Israel's narrow waistline.

Our guide will address how threats in the region impact Jordan internally, as well as relations and further potential for strategic partnership between Jordan, the United States, and Israel.

Tel Aviv is the first Hebrew city and reflects the diverse origins of the original Zionists who founded the city. A survey of the early neighborhoods, and visits to the major historical, cultural and political institutions will help participants understand modern Israel's ethos and approach to local and global issues. It will also be an opportunity to see the vibrant, diverse secular society in contrast to the experience of a Shabbat dinner the night before with a religious family.

Guided Survey of Jaffa

The ancient city of Jaffa, now part of the modern Tel Aviv-Jaffa Municipality has a rich history reflecting the different communities that have used it as a port city. Today, a diverse community of Jews, Christians and Muslims call it home. This visit will cover the ancient and modern city, allowing participants to have a deep understanding of different Israeli populations as well as the challenges and opportunities of a shared society.

12:00 – 1:30 PM **The IDF in Israel Life**
Lunch with Reservists
-at Blue Rooster

In Israel, military service is mandatory for everyone over the age of 18, with several exceptions. Most Israelis join the army right after high school and serve for three years. As such, the Israel Defense Force (IDF) is an integral part of the fabric of Israeli society. During this lunch, participants will have the chance to meet with several reservists and hear about their experiences in the army. They will discuss the values of the Israel Defense Forces – known as Ruach Tzahal (The Spirit of the IDF). This overarching ethical code, and the guidelines and operation resulting from it, shape the mode of action applied by all IDF soldiers and units, both in peace and at war. During basic training, every IDF soldier studies and analyzes the code of ethics together with their commanders.

2:00 – 3:00 PM **Understanding Oct 7 and its Impact on Israeli Society**
Visit to ANU Museum of the Jewish People

"October Seventh" examines how Israeli culture reacts to the war. The exhibition curates works by 25 artists whose creative activity reflects the atrocious times Israeli society is facing since October 7th. Some of them are living artists, some deceased – either murdered on October 7th or died during the ongoing war, while others are residents (or former residents) of the southern areas, who suffered the loss of their loved ones, their homes, or whose families were affected by the horrors of the massacre. The new exhibition wishes to frame a current situation and to record the unique creative burst that is well felt among Israelis since the war began.

We will process the range of topics explored, including the U.S.-Israel strategic partnership, prospects for Arab-Israeli peace, the experience of minorities in Israel, as well as greater existential threats throughout the region. Participants will also have the opportunity to share their takeaways and ask any lingering questions that weren't covered during the week.
