Dear Ms. Wallach:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Israel,<sup>1</sup> scheduled for October 26 to November 3, 2024, sponsored by the Jewish Institute for National Security of America (JINSA).

You must complete an Employee Post-Travel Disclosure Form (which your employing Member must also sign) and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. If you are required to file an annual Financial Disclosure Statement, you must also report all travel expenses totaling more than \$480 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House employees may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$480] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

On behalf of the Jewish Institute for National Security of America (JINSA), it is my pleasure to invite you to participate in this year's [Congressional National Security Program to Israel](#), to be held **Saturday, October 26-Sunday, November 3, 2024**.

JINSA is a not-for-profit 501(c)3 organization dedicated to working with military and civilian decisionmakers to ensure American strategic interests in the Middle East are defended. JINSA believes the cornerstone of this defense is a robust U.S.-Israeli security cooperation relationship.

One of the ways JINSA executes its educational mission is through [unique programs](#) that promote dialogue between prominent U.S. government officials and military leaders and their Mideast counterparts. The Congressional National Security Program provides insight and understanding into Israel's security challenges, the shared threats facing Israel and the United States, the benefits of U.S.-Israel security cooperation and ways to deepen that cooperation, and insight into how collaboration between U.S. and Israeli defense industries contribute to the defense of both nations. JINSA will cover your lodging, tours, food costs, and round-trip international travel between the United States and Israel.

The program curriculum will feature visits to strategically important sites, such as Israel's borders with Gaza, Lebanon, Syria, and Egypt, where participants will be briefed by IDF commanders to better understand the security challenges Israel faces on each respective border, including its lack of strategic depth. Delegation participants will also visit the Knesset, to understand the role it plays in developing and executing Israeli national security policy, and key religious and historical sites to gain a deeper appreciation for the importance of the land to three of the world's great faiths and how this directly impacts the security environment in the Middle East.

The program will include briefings on topics such as:

- The impact of the Israel's war with Hamas in the aftermath of the October 7, 2023 terrorist attacks;


- Middle East regional security challenges confronting the United States and Israel;
- Prospects for U.S.-Israeli strategic cooperation with Abraham Accords countries;
- Perspective on how the Arab world understands and perceives Israel; and
- Linkages between Israel's "Silicon Wadi," IDF weapons technology, and the U.S. defense establishment.

Background: By 1945, the Nazi's Third Reich had killed the majority of Europe's Jewish population, destroying a civilization that had flourished for centuries. Yad Vashem encapsulates and memorializes this tragic history. The visit will provide participants with an unparalleled opportunity to learn about the Holocaust, how it is perceived and understood through the eyes of Israelis, and how it significantly impacts Israel's national defense posture and diplomatic relationships today.
- 11:00-11:30 Depart for the City of David, Jerusalem
- 11:30-14:00 Visit and guided tour through the **City of David, Jerusalem**  
Background: The United States Embassy in Jerusalem, together with the United States Commission for the Preservation of America's Heritage Abroad, have recognized the City of David as a testament to America's Judeo-Christian heritage and founding principles. The archeological discoveries at the City of David bring Biblical Jerusalem back to life and reaffirm the prophetic messages of freedom, justice and peace that inspired America's founders. The City of David is an archaeological excavation of the city of ancient Jerusalem, prior to the Jewish-Roman wars and the destruction and the Second Temple in 70 CE. Participants will learn how Israelis, from diverse ethnic and religious backgrounds, perceive their history and connection to the land of Israel. A key focus will be how this history and the interpretation of it strongly manifests itself in the political and religious challenges that Israeli experiences today in the modern world and how this impacts Israel's national defense posture.

Topic: Briefing en route by Ibgly Eliyahu on the history of Masada and its role in the Great Jewish Revolt.

Topic: A UNESCO World Heritage site, the Masada fortress and palace complex built by King Herod the Great sits perched atop a Judean Desert plateau. The fortress was famously the location of the Jewish Sicarii rebels suicidal last stand against Rome's X Legion in 73 CE. during the Great Jewish Revolt (or First Jewish-Roman War) of 66-74 CE. The destruction of Masada marked the end of the last independent remnant of the Kingdom of Judah at the end of the Second Temple period. As such, Masada remains a potent symbol to the modern state of Israel, and for many years inductees to the IDF swore that "Masada shall not fall again" at the end of their training on location.

Topic: Briefing en route by Ibgly Eliyahu providing background to the geology and topography of the Dead Sea, and the extent to which the water level has dropped over the past century.
