



Visit to archeological excavation site  
-at the City of David, Jerusalem

Jerusalem's City of David, more than any other site, represents the complexity of the Arab-Israeli conflict. The City of David is the site most archeologists agree to be the ancient city of Jerusalem that later became the capital of the united Israelite tribes under King David. This area is one of the most intensively excavated sites in the wider region. To Jewish Israelis, the site represents the beginning of their physical and emotional attachment to Jerusalem that has continued for over three thousand years. At the same time, much of the site is located in the predominantly Arab neighborhood of Silwan. The residents of Silwan, and the Palestinian Authority leadership are opposed to the archeological efforts being carried out in the City of David. In several instances, homes in Silwan were purchased and then destroyed to open up more areas for excavations. Palestinian leadership has denied the existence of any Jewish connection to Jerusalem.

Efrat Shapira Rosenberg is the current content director at Beit Avi Chai, where she creates and hosts popular podcasts about Israeli politics, current affairs and Jewish thought. Previously, Efrat was a program officer at the Avi Chai foundation, a major player in the field of Jewish renewal and education in Israel. Over the last decade she has been writing newspaper columns and hosts Radio programs on Reshet Bet and Galei Tzahal; television programs on Reshet (Channel 2) and Kan (Channel 1); and a popular podcast about Israeli

politics. She is a member of the board of directors of The Sam Spiegel Film School in Jerusalem, and Chair of the "Kolech" Movement for Religious Feminism in Israel. As Israel continues to fight the war against Hamas in Gaza, as well as deal with escalating Iranian threats, Ms. Rosenberg will provide staff with a synthesis of domestic political trends, current international affairs, and the general state of mind of Israeli voters.

Guided visit through the Old City of Jerusalem

The Old City of Jerusalem is home to the holiest shrines of the three monotheistic religions, including the Temple Mount, the Church of the Holy Sepulchre, and the Al-Aqsa Mosque. The Holy Basin is the historic location of Jerusalem and refers to the land surrounding the Old City, including the Mount of Olives, believed to be the departure point for Jesus' final entry into Jerusalem and the cemetery where Jews have been burying their dead for 2,500 years. The Holy Basin also includes the Western Wall, Judaism's holiest site, and the Temple Mount (Haram al-Sharif), sacred ground for Jews, Muslims, and Christians. Control over these sensitive areas remains among the largest disputes in the Middle East. The professionally guided survey will walk through all of these sites and others, educating trip participants on their historical impact and their role in today's political discussions.

Guided visit to the Yad Vashem: The World Holocaust Remembrance Center

One cannot understand Israel's worldview without understanding the trauma of the Holocaust. Israelis view threats to its destruction in light of the events of the 1930s and 1940s, when the German government's threats to exterminate the Jewish people were not taken seriously by the international community. This museum provides an important reference point as to how Israelis interpret the threat of an Iranian nuclear program and Iranian leaders committed to Israel's destruction. Yad Vashem has become a symbol of the Jewish people and its transformation from total helplessness to self-reliance and strength. Thus, a visit to Yad Vashem provides a historical context for the Jewish state. The museum's professional docent will guide the delegation through the main exhibit hall and the children's memorial.

The sliver of Israeli land west of the West Bank is often referred to as the Hadera-Gadera rectangle, with the city of Hadera denoting the northern point, and the city of Gadera the southern point. The Hadera-Gadera rectangle is home to over 50 percent of Israel's population, as well as civilian infrastructure. The area is also home to Israel's "silicon valley", as well as Ben Gurion international airport. The discussion at the Alfei Menashe overlook will allow participants to see firsthand the proximity of Jewish and Arab neighborhoods in both Israel and the West Bank; as well as the strategic threats faced by the Israeli population living in Israel's narrow waistline.

Our tour guide will spend the drive providing a briefing on the Jezreel Valley and the Upper Galilee and the challenges facing these regions of the country. For thousands of years, the Jezreel Valley served as a land bridge linking Africa, Asia and Europe; as a thoroughfare for ancient caravans and; more frequently, armies. The Jezreel Valley is also home to historical and biblical sites including Tel Megiddo and Nazareth. Today it is an important symbol of Israel's complex and diverse political reality. The Jezreel Valley, together with the areas of the Lower and Upper Galilee, is home to the majority of Israel's Arab citizens. A survey of this area provides an opportunity to discuss and learn about Israel's Arab citizens – over 20 percent of the population – each of which has full democratic, social and welfare rights, the right to vote and serve in the Knesset, and the opportunity to serve on Israel's Supreme Court. The Upper Galilee is home to the largest variety of ethnic communities in Israel including Druze, Circassian, Arab Muslim and Arab Christian villages. The Galilee is also home to ancient Jewish and Christian holy sites that provide additional historical and political context to regional tensions.

Citizens in the line of Fire, The Northern displaced communities  
Briefing with Lt. Col (Res.) Sarit Zehavi  
-at Kibbutz Malkia

This briefing at the IDF's Northern Command Base will give participants an insider's understanding of the threat Israel currently faces from Hezbollah in Lebanon and the work the IDF is doing to secure Israel's northern border. Lt. Col. (Res.) Sarit Zehavi served 15 years in the IDF in Military Intelligence –first in the Research and Analysis Branch, and later in the Northern Command. During her military service she briefed hundreds of delegations, ranging from U.S. Senators, Congressmen and politicians to global military commanders, senior journalists and visiting VIP delegations. She is the founder/director of Alma, an educational research center focusing on the security issues of Israel's northern border. Zehavi has authored many position papers focusing on Lebanon, Syria and Israel's national security challenges, and continues to brief delegations on these topics. She holds an MA in Middle East Studies from Ben Gurion University and is a resident of the northern Galilee region. Lt. Col. Zehavi will brief the delegation on security threats coming from the Lebanese border, and the role Iran plays in supporting Hezbollah terrorism against Israel. As a lifelong resident of the North, she will also share her experiences living on the border with Lebanon.

Our guide will also lead discussions through Capernaum and St. Peter's Church.

They will describe life in Tel Aviv since October 7, including the impact on civilian life in Tel Aviv, where the population lives just hours from a war zone.

During our drive to and from the Dead Sea area, as well as during our visit to the Dead Sea, our tour guide will discuss a variety of issues integral to understanding this desert region, and relations with both the Palestinians and Jordanians. For decades, Israel has been developing the agricultural potential of the desert. While the Middle East is suffering from water shortages, Israel, through modern technology and water conservation policies, including the recycling of over 80 percent of water used for domestic purposes and transferring it to agriculture, has literally “made the desert bloom.” The key regional players also face serious environmental issues in the Dead Sea region. One of the major environmental concerns is the receding of the Dead Sea and the appearance of sinkholes, which cause the earth above to collapse. Roads, fields and buildings have collapsed due to this phenomenon, and experts are concerned the tourist infrastructure along the Jordanian and Israeli shores of the Dead Sea are in danger. This issue has led to unprecedented cooperation between Israelis, Jordanians and Palestinians and serves as a model for regional cooperation.

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Israel,<sup>1</sup> scheduled for May 24 to June 1, 2025, sponsored by American Israel Education Foundation.

You must complete an Employee Post-Travel Disclosure Form (which your employing Member must also sign) and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. If you are required to file an annual Financial Disclosure Statement, you must also report all travel expenses totaling more than \$480 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House employees may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$480] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.
