

Dear Ms. Harbeck:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Israel and Jordan,¹ scheduled for May 23 to June 2, 2025, sponsored by Rebuilding Alliance.

You must complete an Employee Post-Travel Disclosure Form (which your employing Member must also sign) and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. If you are required to file an annual Financial Disclosure Statement, you must also report all travel expenses totaling more than \$480 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House employees may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$480] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

¹ Please be aware that the Committee's review of the proposed trip does not extend to either the security situation in the destination country or security related to foreign travel in general. We recommend you contact the Office of House Security (OHS) for a safety and security briefing prior to your departure. OHS may be reached at (202) 226-2044 or ohsstaff@mail.house.gov. Leadership Learning Mission 12.0 to Israel, the West Bank, and Amman
May 23-June 2nd, 2025

With financial sponsorship by Rebuilding Alliance, an American 501(c)3 nonprofit organization

MISSION GOALS: The overall goal of this Leadership Learning Mission was to explore how the peaceful aspirations of all can be furthered when Palestinians and Israelis both enjoy the benefits of equal rights and how U.S. policy and aid can support those aspirations, especially exploring how to assure the health and safety of children and families, and consider the implications of American policies in the region. This delegation focused on the region-wide public health consequences of a delay in polio vaccinations in Gaza and the West Bank.

RELEVANCE TO OFFICIAL DUTIES: While always prioritizing safety, the Leadership Learning Mission offered Congressional staff the opportunity to learn the implications of American policies in the region, to better support constituents, and to address the urgent public health crises that threaten communities not only in the region, but in the U.S. and globally.

This fact-finding trip:

- Provided participants with an understanding of the history of Jerusalem and Israel, the West Bank, Gaza, and Jordan
- Developed their understanding of the challenges faced by all in this time of crisis through meetings with community leaders, human rights experts, U.S. embassy officials, and Israeli officials and decision maker, as well as front-line personnel at aid agencies including doctors to understand the challenges of assuring vaccines and emergency relief, especially in Gaza and the West Bank
- Visited Palestinians and Israelis who are providing emergency response and who work for peace and justice to understand the challenges they are facing now, learn about their efforts to address those challenges, consider what Congress is uniquely able to do to support such efforts, and how this makes a difference
- Showed how U.S. aid and intervention can benefit the health and safety of children and families in the region.

The village's entire area, 18 km², is beyond the Green Line, but one third of its land on the northern side was annexed to Israel along with the rest of East Jerusalem and included in Jerusalem's municipal boundaries. As opposed to the rest of the Palestinian neighborhoods and villages that were annexed, Israel did not recognize the residents of Walajeh -- not even those who lived in the annexed part -- as residents of Jerusalem, and therefore almost all of the 2,500 residents of the village carry the orange identity cards of West Bank residents. The village also is an example of the impact of vast settlement blocs on Palestinian villages in the area. Because the village is located between Jerusalem and the Gush Etzion Settlement bloc, large swaths of the village are facing demolition orders. During our visit, we were introduced to a single mother whose home was demolished just a few days earlier.</p> <p>Entire neighborhoods of the village of Al Walajeh received demolition orders from the Government of Israel. The Abu Khyara family's home was demolished several years ago. Our partner in the planning of this delegation, the Holy Land Trust, funded and assisted in the rebuilding of the family's home.</p> <p>Why: This presentation is relevant to the mission of the trip and the Congressional staff's official duties because it addresses many of the issues that are seen to impact peace in the region: Jerusalem and settlement takeover of Palestinian village lands, home demolitions, and discriminatory planning policies.
