## **The Heritage Foundation's Gettysburg Battlefield Tour 2025**

**Friday, August 8, 2025**

### Agenda:

7:00 AM - Pickup at Heritage Foundation building in Washington, D.C.

Breakfast en route to the battlefield

9:15 AM - Arrival at Gettysburg Battlefield

9:15-10:00 AM - Tour the Gettysburg Battlefield Museum

This museum will provide the staff with an overview of the Battlefield and will lay out the importance of what they will be experiencing throughout the day.

10:00-10:30 AM - Cyclorama Viewing

The Gettysburg Cyclorama is a painting by the French artist Paul Philippoteaux depicting Pickett's Charge. The massive painting was finished in 1883 and is remarkably historically accurate, in large part because the artist interviewed veterans of the actual battle.

10:30-10:40 AM - Drive to Leister Farm (Meade's HQ)

10:40-11:40 AM - Battlefield Drive, stops at statues and key locations from battle

This will be an immersive tour drive with stops along the way to discuss key components of the battles that took place. Staff will learn how key decisions in individual battles led to either success or defeat.

11:40-11:50 AM - Drive to Little Roundtop

11:50AM-12:50 PM - Little Roundtop and surrounding sites

Little Roundtop is the scene of one of the most famous engagements during the Battle of Gettysburg, in which Colonel Joshua Chamberlain of the 20<sup>th</sup> Maine Volunteer Infantry Regiment fought off a sustained Confederate assault.

12:50-1:00 PM – Drive to Lunch

1:00-2:00 PM – Lunch at the Borough BBQ

During lunch the staff will be discussing the lessons learned from the tours, with a focus on how battlefield decisions made by individual commanders affected the outcome of the battle and ultimately the entire war.

2:00-3:00 PM – Tour of Gettysburg Old Town

As much a site of historical interest as the battlefield. This aspect of the tour will include stop to places like the Gettysburg Lincoln Railroad Station, where President Lincoln arrived in the town to deliver his famous Gettysburg Address.

3:00PM - Return to DC (2.5 hours with light traffic).
