

The Foundation for Rural Service (FRS) is a 501c3 non-profit dedicated to enhancing quality of life in America by promoting a better understanding of rural issues. The vision of FRS is to harness the power of the rural communications industry to enrich lives in America.

The purpose of this trip is to educate Capitol Hill staff on the geographic and financial challenges of providing robust broadband service to remote rural areas, as well as to highlight the role rural telecom companies play in providing these essential services that support education, commercial activity, agriculture, health, and public safety. Attendees will meet with a range of small, rural telecommunications companies in New Mexico as well as companies that rely on broadband to provide essential services to their communities. The group will also visit rural community leaders and discuss ways in which the state has been enhanced by broadband applications. Drive times will provide an opportunity for educational sessions on the bus, as well as illustrate the difficulty of serving “last mile” areas in rural states.

No registered federal lobbyists will attend this trip. All expenses will be paid in full by the Foundation for Rural Service (FRS) and will be subject to the daily per diem allowances for Senate and House employees—all meals, lodging, and transportation for staffers will be covered by FRS within these allowance rates. There will be at least 6.5 hours of educational content each day.

Lunch, Broadband 101 briefing, and Tour of ENMR/Plateau, a telecommunications company founded more than 75 years ago and serving rural citizens living in West Texas and eastern New Mexico. Driven by the need for dependable, quality telephone service, interested area farmers, ranchers and other citizens came together to create Eastern New Mexico Rural Telephone Cooperative (now referred to as Plateau). The earliest periods of service came from an arrangement between Clovis-based Farmer's Electric Cooperative and what was then known as ENMR and made possible by sharing the same facilities. As services were upgraded, there became a significant need for more physical space, greater independence and improved business strategies. These changes also necessitated the hiring of the first full-time general manager; and operations were moved to the current location on the northern outskirts of the city of Clovis.

Increasing demands of a faster-paced society and the advent of rapid and even more reliable telecommunications systems caused the Board of Directors to accept the recommendations of management to invest in fiber-optic cabling, modern networking equipment and establish strategically located retail stores. The company-owned and shared fiber-optic cable network now exceeds 5,200 miles. Due to these investments, many business development opportunities have been and continue to be created; enhancing the economic stability of the region.

Also in the area, **Yucca Telecom** has proudly been a part of eastern New Mexico for over 70 years, providing universal access to high quality communications services since 1951. Yucca Telecom is one of the first companies in New Mexico to lay a platform for a Gigabit Network. Fiber powered state-of-the-art technology has been installed in Portales and in some of the surrounding communities. Yucca Telecom's service area covers over 3,400 square miles in Roosevelt, Curry, DeBaca, Chaves, and Lea Counties, much of it over a state-of-the-art fiber network.

TBTC established its subsidiary, Tularosa Communications, Inc. (TCI) in May of 2000 to bring internet to over 4,500 customers in the Basin area. TBTC/TCI continues to bring cutting edge technology to its rural customers by replacing traditional copper line infrastructure with fiber optic infrastructure.

Role of broadband in Artesia’s community services. Artesia General Hospital (AGH) is a community-based, nonprofit acute-care facility with 25 beds dedicated to delivering healthcare across Artesia, Carlsbad, Roswell and the surrounding regions of southeastern New Mexico. The hospital and its providers rely on robust internet connections for the daily operation of the facility as well as telehealth services.

The Artesia Public School District is comprised of 10 schools, serving students located in Artesia and the surrounding areas. Students in Artesia have access to online learning through IDEAL-NM, a state-wide eLearning program, as well as access to modern technology including Smartboards, computer labs, mobile computer labs, laptops, iPads, wireless networks, and digital learning.

The main event for Artesia’s economy is the production of oil and gas. Approximately 20% of Artesia’s workforce is employed directly by development and production of oil and gas. A variety of careers are in high demand, including scientists in engineering and geology, professional services such as land, legal and accounting, and field work such as lease operators, trucking/hauling, and a variety of specialty work. More than 100 million barrels of oil and 750 cubic feet of gas have been produced in the fields of Eddy County in just the first few years of this decade. The unemployment rate in the Artesia area is well below the national average, household incomes are among the highest in the state, and real estate values have held steady or even increased over the last seven year.
