- 10:00 – 10:45 AM **Introduction to ITIF and Trip Preview**
Welcome and briefing from the leadership of the Information Technology and Innovation Foundation (ITIF), the nation's leading think tank for science and technology policy. ITIF President Rob Atkinson and Chief Development Officer Jackie Whisman will provide an overview of ITIF's mission to advance innovation-driven economic growth and outline the objectives for the Boston-area site visits.
- 10:45 – 1:00 PM **Amazon Robotics** (50 Otis Street, Westborough MA)
This immersive visit to the company's flagship robotics innovation hub will give staff an up-close look at the cutting-edge technologies driving Amazon's fulfillment network and reshaping the future of logistics, automation, and American manufacturing. During the tour, staff will observe advanced robotics systems in action, including mobile drive units and robotic arms used in Amazon's fulfillment centers; Learn how Amazon Robotics is enhancing efficiency, safety, and sustainability across operations; Engage with engineers and operations leaders to discuss workforce development, tech-driven job creation, and Amazon's partnerships with local schools and community colleges; Explore Amazon's role in the Massachusetts innovation ecosystem, including investments in research, training, and public-private collaboration. Boxed lunch provided during discussion period.
- 2:00 – 3:15 PM **Boston Dynamics** (200 Smith Street, Waltham MA)
The group will visit Boston Dynamics for a tour of the world's leading robotics company. We will visit the company's Robot Museum featuring prototypes of the company's robots from its 32-year history, and then tour the active research labs where robots such as Spot and Atlas are designed and perfected. Finally, we will have a hands-on interactive experience with a Spot robot in the company's Demo Lab. The tour will cover the convergence of AI and robotics, industrial and public safety applications, and informal discussions about emerging federal policy issues in the robotics industry.

- 4:00 – 5:15 PM **Teradyne** (600 Riverpark Drive, North Reading MA)
Teradyne is a global leader in automated test equipment and industrial automation. Staff will have a firsthand look at the technology powering the semiconductor and advanced electronics sectors. Teradyne designs systems that test everything from smartphones to electric vehicles—ensuring reliability and performance in the devices Americans use every day. During the tour, staff will explore the development and testing of semiconductor devices, robotics, and autonomous systems; Learn how Teradyne supports U.S. chip manufacturing, national security, and supply chain resilience; Discover how Teradyne is innovating in collaborative robotics through its Universal Robots and Mobile Industrial Robots (MiR) brands.
- 6:00 – 7:30 PM **Roundtable Dinner Discussion with The Engine and MIT**
The Engine is a venture firm and incubator founded by MIT to support Tough Tech—transformational technologies that solve complex societal challenges and require long time horizons to commercialize. The Engine bridges the gap between scientific discovery and scalable impact by supporting startups in areas such as climate tech, advanced manufacturing, biotech, and quantum computing. Over dinner, staff will engage with founders, investors, and academic leaders who are advancing breakthrough innovations with the potential to reshape entire industries. Discussion will focus on the unique challenges Tough Tech ventures face—such as capital intensity, infrastructure needs, and regulatory complexity—and the role public policy can play in accelerating their path to market. Participants will also explore how The Engine fosters collaboration among universities, government, and the private sector to grow a thriving innovation ecosystem rooted in American research leadership and regional economic development.

Vertex Pharmaceuticals is a leading global biotechnology company headquartered in Boston’s Seaport Innovation District. Known for developing transformative medicines for people with serious diseases, Vertex has revolutionized treatment for cystic fibrosis and is advancing cutting-edge therapies in sickle cell disease, type 1 diabetes, and other areas. The tour will include a look inside state-of-the-art research and development labs focused on gene editing, regenerative medicine, and precision therapies. Staff will engage with scientists and policy leaders on the drug discovery pipeline, regulatory environment, and access to innovative treatments. Attendees will also learn about Vertex’s investments in STEM education and equity initiatives, including its award-winning Learning Lab and partnerships with local schools, and explore how the company is contributing to Massachusetts’ life sciences leadership and advancing biotech manufacturing in the U.S.

(250 Massachusetts Ave, Cambridge MA)
Staff will experience the heart of Novartis’ global research engine at the Novartis Institutes for BioMedical Research (NIBR) in Cambridge, where cutting-edge science drives breakthrough treatments for diseases affecting millions worldwide. The site anchors Novartis’ U.S. innovation footprint and plays a central role in its drug discovery strategy. The tour will feature visits to high-tech labs where scientists are exploring areas like oncology, neuroscience, and gene therapy. Staff will learn how Novartis leverages AI and advanced analytics to accelerate medical discovery and personalized treatment, and hear from researchers and leadership on U.S. R&D policy, regulatory pathways, and the challenges of developing first-in-class medicines. The visit will also explore Novartis’ commitment to health equity, clinical trial diversity, and expanding access to life-saving therapies. This tour provides an inside look at one of the world’s most research-intensive pharmaceutical companies and its role in the innovation economy.

This site is a hub for immunology, diabetes, oncology, and neuroscience research, and a key component of Lilly’s broader strategy to bring next-generation biologics and gene therapies to patients. Staff will walk through advanced research labs and collaborative workspaces designed to accelerate early-stage discovery, and learn about Lilly’s partnerships with academic institutions, startups, and health systems in the region. The visit will also include discussion of federal policy impacts on drug development, clinical trials, and patient access, as well as Lilly’s investments in U.S. manufacturing and affordability initiatives. Staff will
