Dear Mr. Reckling:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Midland, Texas, scheduled for February 17 to 19, 2026, sponsored by American Exploration and Production Council and Diamondback Energy.
