

Met with: U.S. Embassy, the Japan Science and Technology Agency, the Ministry of Foreign Affairs, the American Chamber of Commerce, the Ministry of Economy, Trade, and Industry, the Ministry of Defense, the National Diet staff, the Economic Security Intelligence Lab, the Central Japan Railway Company, Nakasone Peace Institute Scholars, Keidanren (Japanese Business Federation), the Japan External Trade Organization, the Japan Institute of International Affairs, the Institute of Geoeconomics, Tokyo Electron, and the Japan Institute for Cyberspace Studies. In addition, participated in a briefing, base tour, and carrier tour at Yokosuka Naval Base, with U.S. Naval Forces Japan. Also participated in a site visit to Kawasaki Heavy Industries Nagoya Works, to tour their factory that manufactures Boeing 777X and 787 components and discuss the company's manufacturing of major components for U.S.-owned airplanes. Also participated in a tour of the port of Nagoya, which included a meeting with Nagoya Port Authority Officials. Also toured the JAXA Tsukuba Space Center and met with officials on past, present, and future efforts of Japan in space – this included visiting the ISS Japanese Experiment Module Control Room. Also did a site visit to JERA Kawagoe Thermal Power Station, Japan's largest power producer. Conversations covered a range of topics, but focused heavily on economic security, particularly trade with the United States – including the recent trade agreement. Conversations also focused heavily on Japan's efforts to build up their infrastructure and national security resilience.

The purpose of this trip is to focus on the future of the U.S.-Japan alliance, in both the security and economic dimensions. In particular, the emphasis on the economic dimensions of our alliance with Japan is important to our office, and my role as Legislative Director within the office, given the Congresswoman's position on Ways and Means. This is more true than ever given the ongoing trade negotiations and international tax conversations (OECD). This trip is also important to deepen our understanding of Japan, a key U.S. ally whose economic and tax policies directly affect American workers, businesses, and supply chains. Engaging on the ground with Japanese government and industry leaders will help inform my policy recommendations on trade, taxation, and broader economic and security issues in the Indo-Pacific.



The Carnegie Corporation of New York (CCNY) funds the CSIS Congressional Foresight Initiative. The objective of this initiative is to enhance Congressional staff's understanding of long-range trends and key changes in the global environment affecting U.S. and international security. On the basis of this understanding, the series fosters new opportunities for bipartisan collaboration to address challenges to international peace and prosperity. The series also considers best practices in long-range strategic planning and its implementation in government drawn from around the globe. The Carnegie Corporation of New York plays no role in selecting the trip participants or determining the meetings that are a part of the itinerary.

Engaging Japanese counterparts provides unique insight into how a close ally perceives Indo-Pacific competition and the strategic choices the U.S. will face in the coming decades, making Japan an essential destination for congressional staff seeking to deepen their understanding of the alliances that will define American strategy in the region.

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Japan,¹ scheduled for April 4 to 11, 2026, sponsored by Center for Strategic and International Studies and Carnegie Corporation of New York.

You must complete an Employee Post-Travel Disclosure Form (which your employing Member must also sign) and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. If you are required to file an annual Financial Disclosure Statement, you must also report all travel expenses totaling more than \$525 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.
