Ingrid will welcome everyone on the bus, highlighting what makes this site unique is that it's Maryland's only nuclear plant—and it provides most of the state's clean electricity. It runs 24/7, producing carbon-free power for over a million homes, making it a critical piece of how we fight climate change today—not just in the future. She will provide the attendees with an overview of what they will see and what they will learn. She will then welcome questions and comments from the attendees.

Constellation's Calvert Cliffs Nuclear Facility is located on the western shore of the Chesapeake Bay in Calvert County and is Maryland's only nuclear energy facility. The station operates two pressurized water reactors with a combined generating capacity of approximately 1,775 megawatts—enough to supply roughly 30% of the electricity used by homes and businesses across Maryland.

Beyond energy production, the plant is a major economic contributor. It supports hundreds of high-paying jobs and generates significant local revenue, including about \$22.8 million annually in taxes that help fund schools, infrastructure, and other public services.

Site: Waterfront Intake Structure
This will be an opportunity for the group visiting the waterfront intake at the Calvert Cliffs Energy Center to see an example of the energy–water–climate nexus in action: a facility that produces low-carbon electricity while relying on enormous volumes of water from the Chesapeake Bay for cooling. They would recognize both the benefits and trade-offs—how nuclear power supports decarbonization yet introduces localized ecological pressures through fish entrainment and impingement and contributes to thermal stress when warmer water is discharged back into an already climate-sensitive estuary. At the same time, the expert would

be thinking about future risks, including rising water temperatures, sea-level rise, and storm surge, all of which could affect the plant's reliability and efficiency. Ultimately, the visit would reinforce a systems-level insight: even "clean" energy infrastructure is deeply intertwined with natural systems, and managing climate change requires balancing emissions reduction with ecosystem protection and long-term resilience.

Site: Turbine Deck

Nuclear power plants heat water to produce steam. The steam is used to spin large turbines that generate electricity. The group will understand how well maintained the turbines are and how electricity is produced.

Site: Radiation Protection

During your visit, you'll learn how Calvert Cliffs protects workers, the public, and the environment from radiation. Using the ALARA principle keeping exposure As Low As Reasonably Achievable workers are closely monitored, controlled areas are strictly managed, and federal oversight ensures safety. You'll see how nuclear power can provide reliable, carbon-free electricity while maintaining the highest standards of radiation protection.

The trip is organized by the Climate Solutions Foundation (CSF), a bipartisan nonprofit organization dedicated to fostering dialogue among Members of Congress, their staff, industry leaders, and global experts on climate science, economics, and policy.

CSF's interest in the subject matter of this trip is directly aligned with its mission to advance practical, bipartisan solutions to climate and energy challenges. By facilitating this staff trip, there is an opportunity to see the only nuclear plant in the state of Maryland. As of 2026, there are 54 commercially operating nuclear power plants in the United States, containing a total of 94 nuclear reactors across 28 states. These facilities provide approximately 20% of the nation's electricity.

Constellation's Calvert Cliffs Nuclear Facility is located on the western shore of the Chesapeake Bay in Calvert County and is Maryland's only nuclear energy facility. The station operates two pressurized water reactors with a combined generating capacity of approximately 1,775 megawatts—enough to supply roughly 30% of the electricity used by homes and businesses across Maryland. Beyond energy production, the plant is a major economic contributor. It supports hundreds of high-paying jobs and generates significant local revenue, including about \$22.8 million annually in taxes that help fund schools, infrastructure, and other public services.

11:30 AM– 12:45 PM **Plant Tour –They will be guided by a licensed Nuclear Reactor Operator, Mechanical and Electrical Engineers and a Project Manager. (These change routinely and they are unable to provide the names)**

11:30 AM – 12:00 PM **Site: Waterfront Intake Structure**

This will be an opportunity for the group visiting the waterfront intake at the Calvert Cliffs Energy Center to see an example of the energy–water–climate nexus in action: a facility that produces low-carbon electricity while relying on enormous volumes of water from the Chesapeake Bay for cooling. They would recognize both the benefits and trade-offs—how nuclear power supports decarbonization yet introduces localized ecological pressures through fish entrainment and impingement and contributes to thermal stress when warmer water is discharged back into an already climate-sensitive estuary. At the same time, the expert would be thinking about future risks, including rising water temperatures, sea-level rise, and storm surge, all of which could affect the plant's reliability and efficiency. Ultimately, the visit would reinforce a systems-level insight: even “clean” energy infrastructure is deeply intertwined with natural systems, and managing climate change requires balancing emissions reduction with ecosystem protection and long-term resilience.

Site: Turbine Deck

Nuclear power plants heat water to produce steam. The steam is used to spin large turbines that generate electricity. The group will understand how well maintained the turbines are and how electricity is produced.

Site: Radiation Protection

During your visit, you'll learn how Calvert Cliffs protects workers, the public, and the environment from radiation. Using the ALARA principle keeping exposure As Low As Reasonably Achievable workers are closely monitored, controlled areas are strictly managed, and federal oversight ensures safety. You'll see how nuclear power can provide reliable, carbon-free electricity while maintaining the highest standards of radiation protection.

Site: Spent Fuel Storage

Spent fuel storage facilities contain deep pools of water holding used fuel assemblies, sometimes showing a faint blue glow from Cherenkov radiation. After cooling, the fuel is moved into large, sealed concrete and steel casks stored outdoors. The site looks like a quiet, secure industrial area with fencing and monitoring systems.
