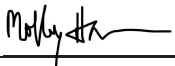

Megafire Institute engages scientists, experts, and practitioners working across all phases of the fire cycle to craft effective policy recommendations that allow ecosystems and communities to thrive with wildland fire. Megafire Institute took the lead role in organizing and conducting the trip.

Safewoods (Additional Sponsor) is a 501(c)(3) non-profit organization dedicated to the eradication of devastating wildfire in collaboration with the US Forest Service, congress, and members of the private sector. Safewoods organizes in-person educational events at their camp outside of Darby, MT to provide people with opportunities to gain firsthand experience with effective wildfire

mitigation solutions. Safewoods provided in-kind assistance including campsite facilities and coordination of the hands-on treatment activity.

Gordon and Betty Moore Foundation (Funding Sponsor) is a private grantmaking foundation that advances scientific discovery, environmental conservation, and the special character of the San Francisco Bay Area. The Moore Foundation's Wildfire Resilience Initiative, launched in 2019, is focused on enabling beneficial fire and reducing vulnerability to extreme wildfire to safeguard healthy fire-adapted ecosystems and resilient fire-prone communities. The Moore Foundation provided funds to support the trip through a grant awarded to Megafire Institute.

Day 2 – Wildfire Mitigation Experience (Thu, May 28)

Land managers will discuss the value of fuels management to reduce wildfire risk and to restore beneficial fire regimes in forested ecosystems. Topics covered will include the use of prescribed fire and selective thinning, what's needed for initial entry vs long term maintenance of the landscape, and how treatment strategies vary among different types of ecosystems. Attendees will participate in a hands-on fuels reduction activity where the group will work together to build a small waste-biomass pile to gain first-hand experience of the work involved with wildfire mitigation treatments. Led by David Fox, Bitterroot National Forest.

12:00 pm – 1:00 pm Lunch

1:00 pm – 2:00 pm Indigenous Wildfire Stewardship

Attendees will learn about how indigenous stewardship practices can help reduce the risk of destructive fires and provide co-benefits for local communities. Topics covered will include ongoing work by tribes to restore cultural fire practices and place-based land stewardship. Led by Jim Durglo, Intertribal Timber Council

2:00 pm – 3:00 pm Community Mitigation Briefing

Attendees will learn about the value of community-wide mitigations to prevent wildfires from spreading into the built environment and triggering a destructive urban conflagration. Topics covered will include defensible space, home hardening, and community-scale mitigations. Led by Neil Chapman, Flagstaff Fire Department

Attendees will learn about the unique challenges of wildfire management in the chaparral shrubland ecosystems common to southern California. 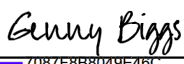

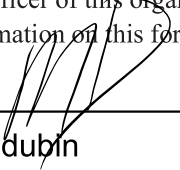
