Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Boulder, Colorado, scheduled for June 16 to 18, 2026, sponsored by NCTA - The Internet and Television Association. Attendance at the event will require travel across two time zones—between Washington, DC and Denver, CO—and involves a full day of programming, beginning at 7:45 am and ending at 6 pm (excluding the scheduled dinner). Given the lengthy travel time, an additional night of lodging is necessary to allow the invitees to participate in the full day of programming.

NCTA is the principal trade association for the cable television and broadband industry. The cable industry employs at least 300 individuals in each invitee's Congressional district. Attendance by Congressional staff on this trip provides the best opportunity to demonstrate the industry's significance to the U.S. economy, innovation and job growth. In addition, staffers will gain a greater understanding of the importance of radio spectrum to the video, broadband, and wireless services that NCTA members provide millions of Americans.

NCTA is the sole organizer and planner of this trip and all the events associated with the trip. NCTA worked with its member companies to arrange the tours of their facilities and to determine availability of the facilities and staff for tours, presentations, and other planned events.
