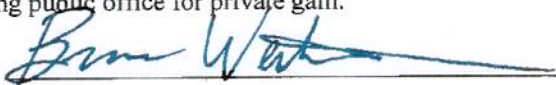

Dear Mr. Matheson-McNaught:

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Charlotte, North Carolina, scheduled for June 17 to 19, 2026, sponsored by Conservative Climate Foundation.
