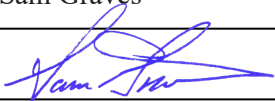

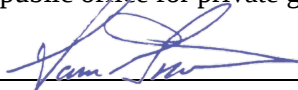

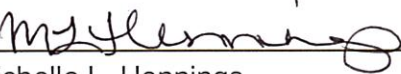

Lower Snake River Dam System Educational Tour

Lewiston, Idaho

*With financial support from Washington State Potato Commission, The McGregor Company
and Northwest RiverPartners*

August 17-19, 2026

Tour Objective/Goal: The Washington Association of Wheat Growers (WAWG) will demonstrate the importance of Marine Highway 84 for the region's navigation, irrigation, tourism and hydropower. Nearly 60 percent of the nation's wheat, corn and soybean are transported on the Lower Snake River-Columbia River system for export.

Relevance to Staffers' official duties: Congressional staffers were targeted by their topics of responsibility including agriculture, natural resources, energy, and/or transportation. Many staffers have never had the opportunity to see the Lower Snake River System. We want them to experience the river system first-hand and hear from those who utilize the river for navigation, irrigation, tourism and hydropower

Location: The purpose of travel to Lewiston, Idaho is for staffers to see and experience a hydro-power generating dam with fish ladders, visit the nation's furthest inland seaport in Lewiston as well as learn about the activities of the Port of Lewiston.

August 17 -- TRAVEL DAY

Geordy Bryant Greene, WA State Potato Commission will share importance of irrigation to region's farmers.

Arrive Boyer Park & Marina 1753 Granite Rd. Colton (Hwy 195 to Hwy 194)

Get on tour boat to go through the navigation locks to the Lower Granite Dam
Experience the navigational lock from inside as the boat goes through the locks, Corp of Engineer representative will be on the boat to explain the process as it happens. These are one of four of the navigational locks on the Lower Snake River System and are critical to shipping fuel, fertilizer and commodities (wheat, lumber, corn and soybeans) as well as for the cruise ships to go up and down the river. Bus will meet the boat on the other side of the dam and transport group to the visitor center for the start of the tour.

11:00 am-1:15 pm

Arrive at Lower Granite Dam

Clark Mather, Northwest RiverPartners Clark will share region's hydropower helps provide clean energy to his organization's members – community-owned electric utilities in OR, WA, ID, MT, US, NV, CA and WY.

Chuck Witherspoon, Corp of Engineers, Safety brief and Project Orientation presentation provides mission of dam (hydropower, fish passage and navigation)

Walking tour of Dam – Corp of Engineers

Information Center

Adult fish trap – watch various agencies conduct studies on adult salmonids

Adult fish ladders –bird's eye view of how a fish ladder works

Fish screens – how fish are diverted away from turbines

Removable Spillway Weir (RSW) – bypassing juvenile fish through spillways

The opportunity for House/Senate staffers to see first-hand the dam and its multiple purposes is a very critical element of this event. They will be hearing from Corp operation manager and fish biologist as to the power and fish saving activities that occur at the dam.

Leslie Druffel, The McGregor Company will share how this family-owned business provides fertilizer and crop protection to the region's farmers and uses Marine Hwy 84 to transport their product.

George Walker, AgriNorthwest the company's history dates to 1968 and is headquartered in Kennewick, WA, and includes several large farms in WA and OR and uses irrigation with their crops.

Port of Lewiston, 1626 N 6th Ave., Lewiston

Scott Corbitt, Manager of Port of Lewiston provides a tour of the port facilities and the new cruise line docking structure. This is the nation's further inland seaport and there are many businesses at the port. We will see the recently completed Confluence Riverfront docking system for American Cruise Lines (a large economic driver to area's tourism).

Xochitl Casteneda, MARAD, Director of Pacific Northwest & Alaska Gateway, for US Dept. of Transportation. The DOT agency responsible for America's waterborne transportation system, the Maritime Administration (MARAD) is busy. At their core, they support the technical aspects of America's maritime transportation infrastructure -- things like ships and shipping, port and

vessel operations, national security, environment, and safety. They promote the use of waterborne transportation, and ensure that its infrastructure integrates seamlessly with other methods of transportation.

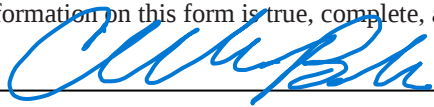

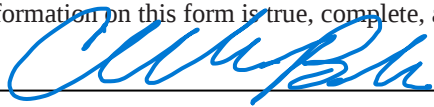
