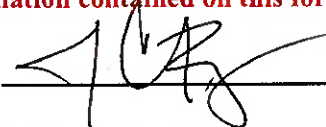

Just as strategic surveys in Jerusalem focused on Jewish, Muslim, and Christian history and claims to the land, the site visits to the Christian sites help provide context for the competing religious narratives for the land of Israel. For example, we will be visiting the Mount of Beatitudes, where Jesus delivered the Sermon on the Mount, the most studied and read speech of any religion in history. Our guide will also lead discussions through Capernaum.

Hezbollah has a global reach and has killed more Americans than any terrorist group other than al-Qaeda.

This briefing from Lt. Col (Res.) Sarit Zehavi will give participants an insider's understanding of the threat Israel currently faces from Hezbollah in Lebanon and the work the IDF is doing to secure Israel's northern border. Lt. Col. (Res.) Sarit Zehavi served 15 years in the IDF in Military Intelligence – first in the Research and Analysis Branch, and later in the Northern Command. During her military service she briefed hundreds of delegations, ranging from U.S. Senators, Congressmen and politicians to global military commanders, senior journalists and visiting VIP delegations. She is the founder/director of Alma, an educational research center focusing on the security issues of Israel's northern border. Lt. Col. Zehavi will brief the delegation on security threats coming from the Lebanese border, and the role Iran plays in supporting Hezbollah terrorism against Israel. As a lifelong resident of the North, she will also share her experiences living on the border with Lebanon.

Pursuant to House Rule 25, clause 5(d)(2), the Committee on Ethics hereby approves your proposed trip to Israel,¹ scheduled for August 8 to 16, 2026, sponsored by American Israel Education Foundation.

You must complete an Employee Post-Travel Disclosure Form (which your employing Member must also sign) and file it, together with a Sponsor Post-Travel Disclosure Form completed by the trip sponsor, with the Clerk of the House within 15 days after your return from travel. As part of that filing, you are also required to attach a copy of this letter and both the Traveler and Primary Trip Sponsor Forms (including attachments) you previously submitted to the Committee in seeking pre-approval for this trip. If you are required to file an annual Financial Disclosure Statement, you must also report all travel expenses totaling more than \$525 from a single source on the "Travel" schedule of your annual Financial Disclosure Statement covering this calendar year. Finally, Travel Regulation § 404(d) also requires you to keep a copy of all request forms and supporting information provided to the Committee for three subsequent Congresses from the date of travel.

Because the trip may involve meetings with foreign government representatives, we note that House employees may accept, under the Foreign Gifts and Decorations Act (FGDA), gifts "of minimal value [currently \$525] tendered as a souvenir or mark of courtesy" by a foreign government. Any tangible gifts valued in excess of minimal value received from a foreign government must, within 60 days of acceptance, be disclosed on a Form for Disclosing Gifts from Foreign Governments and either turned over to the Clerk of the House, or, with the written approval of the Committee, retained for official use.

¹ Please be aware that the Committee's review of the proposed trip does not extend to either the security situation in the destination country or security related to foreign travel in general.
